

RESOLUTION NO. 16-03

A RESOLUTION APPROVING THE 2016 – 2017 FISCAL YEAR BUDGET FOR THE CITY OF ANADARKO/ANADARKO PUBLIC WORKS AUTHORITY/ANADARKO ECONOMIC DEVELOPMENT AUTHORITY.

WHEREAS, The City of Anadarko, Oklahoma adopted the Municipal Budget Act (“Act”) of 1979, and;

WHEREAS, The City Manager has prepared budget(s) for fiscal year 2016 – 2017 (July 1, 2016 through June 30, 2017) that is consistent with that Act and presented such to the City Council/Anadarko Public Works Authority Board of Trustees/Anadarko Economic Development Authority Board of Trustees, and;

WHEREAS, A public hearing on the preliminary budget(s) was conducted on June 21, 2016 in compliance with Section 17-208 of the Act, and;

WHEREAS, The City Council and Boards of Trustees desire to vest the City Manager with the authority to amend the approved budget(s) by transferring budgeted amounts between departments or funds without increasing or decreasing the total budget.
