Dear Franchise Official:

I am writing to inform you that effective August 31, 2023, at 8pm ET, The Walt Disney Company removed its programming from Spectrum Mid-America, LLC ("Charter"). Charter had been in discussions to renew its carriage agreement when The Walt Disney Company took this action. As a result of The Walt Disney Company's unreasonable demands to increase prices and limit customer choice, negotiations failed to reach a deal and they chose to pull the programming from Charter customers, rather than extend the contract until negotiations conclude. The Walt Disney Company's decision to remove its programming is outside of Charter's control; we wanted to provide you notice of these changes as quickly as possible.

## US-10 road and sidewalk work begins Monday in Ludington

**LUDINGTON, Mich.** - The Michigan Department of Transportation (MDOT) is investing approximately \$700,000 to resurface [US-10 from Jackson Street to east of US-31 Business Route \(Pere Marquette Highway\)](#). Work also includes sidewalk ramp upgrades and drainage improvements.

**County:** Mason

**Highway:** US-10

**Closest city:** Ludington

**Start date:** Monday, Sept. 11, 2023

**Estimated end date:** Mid-November 2023

**Traffic restrictions:** Lane and shoulder closures will be in effect throughout the project.

**Jobs numbers:** Based on economic modeling, this investment is expected to directly and indirectly support about 10 jobs.

**Safety benefit:** This project will improve the ride and extend the service life of the roadway.

As to why PM Township pays the same as Hamlin, it was meant to be based on equity and potential, not based on a single years participants.
