Firstly, I apologize for this being presented at a special meeting instead of the normal second meeting of the month. Due to vacations and the recent resignation of the City Manager, I am still getting caught up.

This is the January month end report. Officers handled 104 complaints for the month and further made 12 arrests. I typically attempt to highlight some of the more concerning or notable arrests for you each report. There is one that notably stands out. A male subject was arrested for a "hard" narcotics possession. Upon arrival at the jail, it was discovered he was in possession of more narcotics hidden on his person. The arrestee removed additional narcotics from his "posterior" while being booked at the jail.

In regards to police department community projects, we are starting to gear up for our bicycle safety program. Over the course of the Spring, we will raise several thousand dollars thanks to community donations. These funds will allow us to provide bicycle helmets and prizes to K-4 students at Surline Elementary.
