Finances

The total budget (combined with carryover) for the Police Department for 2018 was \$7,030,203. Actual expenses for 2018 were \$6,635,013.

In 2018 Blue Ash was awarded \$57,949 seized from a drug courier during a traffic stop and two vehicles from forfeiture cases.

Notable Events

The Blue Ash Police Department received the AAA Platinum Traffic Safety Award for the ninth year in a row. Participation in campaigns such as "Click it or Ticket" and "Drive Sober or Get Pulled Over" show the strong dedication the department has to traffic safety.

ALICE training was conducted for many local businesses, including the members of the 123rd Ohio Air National Guard and the Blue Ash Fire Department. ALICE is the #1 active shooter civilian response training for organizations. The Training is primarily teaching the facility members how to improve their chances of surviving during an attack by an armed intruder until law enforcement arrives. It teaches a new method to handle an active shooter versus the traditional "lockdown only" approach. The PD benefits by testing our response and ability to manage the incident through Unified Command. For more information on ALICE for your organization, contact the Blue Ash Police Department.

The Blue Ash Police Department in conjunction with Target and many other departments in the city hosted another successful Target Bike Rodeo. The Target Bike Rodeo allows children to see some of the vehicles used in emergency services, have their bikes checked for safety, and receive a free bike helmet.

Many members of the department participated in community engagement- 511 total officer hours, with over 17,200 persons engaged during public appearance details (Coffee with a Cop, ALICE, Operation Give Back, Cram-A-Cruiser, Holiday Store, Canstruction Food Drive).

The Blue Ash Police Department continued partnerships throughout the year with; the Crisis Intervention Training in Hamilton County, Special Needs and Awareness Program (SNAP), Human Trafficking Work Group of South West Ohio (HTWGSWO), Blue Ash Business Association, End Slavery Cincinnati, Freedom Center, Easter Seals, Willa Washington Scholarship Fund, Sycamore Community Schools, Blue Ash HOA's, Boy/Girl Scouts, Asian Community Alliance, Hamilton County DDS, Adult Protective Services, MADD, Women Helping Women, and many more.







Patrol Operations



About the Patrol Division

The Patrol Division of the Blue Ash Police Department is comprised of six Sergeants and nineteen Patrol Officers working three shifts. In 2018 Patrol Officers took reports for 1,869 incidents, a 0.5% decrease from 2017. The average response time for officers to arrive on scene of an incident is 7 minutes and 1 second. According to *American Police Beat*, the average response time nationwide is 10 minutes.

The listing to the right shows a breakdown of which shift each Sergeant and Patrol Officer was primarily assigned to at the end of 2018. Officers bid shifts each year and are awarded their shift bids based on seniority.

The chart below shows a breakdown of every report taken, excluding traffic crashes. Incidents may fall into multiple categories however only the primary category is shown in the chart. This shows that not every report an officer takes may be criminal in nature and in 2018 non-criminal reports equaled about 33.5% of the total reports.



Dispatch Operations

On Duty 24/7

In 2018 Blue Ash Police Officers were dispatched via calls received by the Hamilton County Communications Center and six dispatchers at the Blue Ash Police Department. In 2018 they accounted for 9,925 calls for service the officers responded to. Each of these calls was logged into a Computer Aided Dispatch system (CAD) by a Blue Ash Police Dispatcher where they also logged an additional 14,679 officer-initiated details. The chart below shows how details were reported to the Blue Ash Police over the past four years.


The Blue Ash Police Dispatchers are also responsible for notifying city emergency personnel when issues arise for the general public such as snow removal, trees in the roadway, or the railroad for issues with train crossings.

In 2018, Mary Lamping and Melissa Masten resigned from their positions. Sarah Robers and Ashley Newell were selected from a lengthy list of candidates to join the Blue Ash family. Our other dispatchers are Katie Farmer, Sarah Miller, Judie Dreyer, and Rebecca Koligian.



The chart to the right shows the number of details logged per hour for 2018. The three busiest hours for details initiated by officers are the 12:00 AM, 1:00 AM, and 8:00 AM hours respectively and account for 21.4% of the daily self-initiated details. The three busiest hours of calls for service where the public calls in to request our assistance are the 3:00 PM, 4:00 PM, and 5:00 PM hours respectively and account for 19.3% of the daily details.



Traffic Safety

About Traffic Safety

The Traffic Safety Officer is responsible for the investigation of all serious injury and fatal crashes, as well as minor/routine crashes when available. The Traffic Safety Officer also acts as a liaison between the police department and residents to address traffic-related issues. This is accomplished by working with the Public Works department to improve traffic plans, working with the traffic engineer to set light timing cycles, giving presentations to community groups and businesses to raise awareness, and providing officers with the tools that they need to actively enforce traffic violations (maintaining the Datamaster, RADARS, LIDARS, and organizing OVI Task Force enforcement hours, etc.) The traffic safety officer also coordinates the operations portion of the Hamilton County OVI Task Force and works with all city departments to plan traffic operations for the special events in the city (SummitFest, Red White and Blue Ash, races, and more).




Traffic Citations

Patrol Officers made a total of 3,899 traffic stops during 2018. During those traffic stops, a total of 3,358 traffic citations or written warnings were handed out to drivers. Written warnings are utilized when officers feel traffic violators do not meet the level of needing a fine but need a documented violation on file.



Traffic Crashes

In 2018 there were 600 roadway traffic crash reports taken. This is a 10.1% increase over 2017. During the same time, private property crashes saw a 10.0% increase to 121.



Hamilton County OVI Task Force

About the Task Force

The Hamilton County OVI Task Force is comprised of 31 Hamilton County law enforcement agencies and the **Ohio State Highway Patrol** and is currently managed by the Blue Ash Police Department. Together they conduct OVI checkpoints and a number of saturation patrols that target impaired drivers throughout the year in an effort to reduce alcohol related fatalities. The Task Force participates in two national highway safety campaigns: Click It or Ticket, held over Memorial Day Weekend, and Drive Sober or Get Pulled Over, held over the Labor Day Weekend.

Criminal Investigations Section

The Criminal Investigations Section (CIS) is responsible for investigating crimes that require a more extensive period of time or greater complexity than road patrol officers are able to handle. In 2018 this section was comprised of Lt. Rob Gerhardt along with Detectives Jeff Lewis, Jason Swartwout, and Mark Niehaus. Together, the detectives worked 263 cases assigned to their unit.

The Blue Ash Police Department participates in the Ohio Incident Based Report System (OIBRS) which follows the FBI's National Incident Based Reporting System (NIBRS). In 2018, 852 criminal cases were handled by officers and detectives. This is down 1.0% from 861 in 2017.

For 2018, 263 cases were assigned to CIS for follow up and 335 cases were assigned to officers. 486 of those were cleared with arrest, where the victim refused to follow through, or unfounded. 115 were closed with no investigative leads. 53 currently remain active under investigation or with warrants issued. The other 254 cases were solved at the time of the offense with an arrest and no need for follow up. That equates to a 86.9% clearance rate for cases in 2018.

Crime Breakdown

Of the 852 criminal offenses that occurred in Blue Ash in 2018 the majority of them were theft offenses. Theft accounted for 26.9% of all criminal offenses and are down 2.5% from 2017. Drug and narcotic offenses are the second largest category making up 25.1% of criminal offenses.

Arrest Breakdown

Total arrests for 2018 are up 9.2% compared to prior years, ending with 934 arrests for the year. The largest arrest area for the Blue Ash Police Department is in serving warrants. These include warrants for Hamilton County, Blue Ash, and other law enforcement agencies throughout the country.

Special Operations

To assist in reducing the drug offenses, 41 special operations were conducted in 2018. This is most noticeable in the increase in drug/narcotic offenses for 2018. The increase is due to a proactive effort to seek out drug offenders. Blue Ash hopes through special operations that individuals addicted to drugs can be targeted and then provided the assistance they need to become drug free. Blue Ash Officer's successfully administered Narcan to nine individuals in 2018





Blue Ash Mayor's Court

About the Mayor's Court

The Blue Ash Mayor's Court is responsible for prosecuting misdemeanor criminal and traffic violations of the Codified Ordinances of Blue Ash. In 2018 it had an operating budget of \$149,924 with total expenses of \$129,319. Through fines and costs they brought in \$117,507.







89% of the cases heard in Mayor's Court were traffic violations. The other 11% were criminal cases.


73.1% of all criminal cases heard by the Mayor's Court were found in five criminal violations shown at the right. Minor drug violations were the top cases heard by the Mayor.

85.2% of all traffic cases heard were found in the ten categories shown below. The top two categories, speed and assured clear distance, resulted in 46.8% of all traffic violations.









In March 2015, the City of Blue Ash entered into an agreement with Bair Software to provide Blue Ash crime data to the public using Google Maps' well-known, intuitive mapping interface. In 2016, Bair was bought out by LexisNexis.

Through Community Crime Map, citizens can view basic information on crime reports made in Blue Ash since January of 2012. The crime/incident type, streetlevel address, date and time are displayed for the users. The information can be viewed in a variety of formats and sorted on different criteria.

Data is uploaded twice daily by our records management system and includes all crimes occurring in Blue Ash. Currently, there are almost 14,000 incidents uploaded to the site by Blue Ash. Citizens can report anonymous tips to the police department by clicking on any incident and submitting the tip through CrimeStoppers. Citizens can also sign up for Crime Alerts that notify you daily by e-mail when a report occurs nearby.
