WHEREAS, the bid submitted by Alpha Construction, Inc., 257 Siefferman Ct, West Harrison, IN. 47060 for the Blue Ash Towne Square Renovation Project for the unit prices as shown on the attached bid summary is in line with staff estimates and is the most responsive bid based upon quality, service, past performance, and price.
