

AN ORDINANCE TO FIX THE COMPENSATION OF THE MAYOR, AUDITOR,
MARSHAL AND COUNCILMEN OF THE TOWN OF BRIGHTON.

Section 1: BE IT ORDAINED by the Mayor and Council of the Town of Brighton, That from and after September 1, 1959, the Mayor, Auditor, Marshal and Councilmen of the Town of Brighton shall receive the following compensation for their services as such:

The Mayor and the Auditor shall each receive the sum of \$25.00 per month; the Marshal shall receive the sum of \$20.00 per month; and each Councilman shall receive the sum of \$5.00 per month.

Section 2: BE IT FURTHER ORDAINED, That nothing herein shall be construed as affecting the salary of any incumbent of any of said offices during his present term.

Section 3: BE IT FURTHER ORDAINED, That this ordinance take effect on September 1, 1959, the welfare of the Town of Brighton requiring it.
