




Shared-Use Nonmotorized (SUN) Trail Program

PHASE 1: \$5.4 Million Grant - Construction Completed PHASE 2: \$7.6 Million Grant (increased from \$6.2 Million) - FY 2025 Construction PHASE 3: \$558,358 Grant – Design FY 2024 – 30% Design In-Progress - in coordination with UEP










Road Rehabilitation Program FY 2023

- 1. \$3.25 Million Local Road Paving
 - a) <u>Resurfacing began July 2023. Substantially Completed April 2024.</u> (Under Budget ~300K).
- 2. \$2.46 Million Major Road Paving
 - a) <u>Resurfacing began in October 2023. Completed April 2024. (Under</u> <u>Budget ~45K).</u>
- 3. \$715,000 Spot Paving (Public Works)
 - a) <u>Bid higher than anticipated (988K). Construction is expected to start in</u> <u>the summer 2024. (Over Budget 273K).</u>
- 4. \$300,000 Pavement Preservation
 - a) <u>Began / Completed March 2024. (Under Budget ~40K).</u>

Total pavement program under budget, \$112,000.






Road Rehabilitation Program FY 2024

- 1. \$4.6 Million Local Road Paving
 - a) <u>Awaiting Council Approval June 2024. Construction</u> <u>Anticipated to begin summer 2024.</u>
- 2. \$12.9 Million Major Road Paving
 - a) <u>Awaiting Council Approval June 2024. Construction</u> <u>Anticipated to begin summer 2024.</u>
- 3. Pavement Preservation
 - a) <u>Due to elevated costs associated with Local and Major</u> <u>Road Paving, Pavement Preservation projects are on hold</u> <u>pending funding availability.</u>






Alley Reconstruction/Paving






Water Quality Projects



Bimini Basin Mooring Field

- 1. Project approved to be reconfigured from Design-Build to <u>Design/Permit-Only</u>

- 3. Geotechnical drilling in park and in basin completed in March.
- 4. Pre-app meetings held in April with FDEP and ACOE.





Bimini Basin Anchoring Limitation Area

- 1. Project approved by City Council on February 7, via Resolution 52-24.
- 2. This Resolution approved a request for Lee County to establish an anchoring limitation area (ALA) in Bimini Basin. This limitation will enable the City to manage and enforce boating activity.
- 3. The City will enter into an Interlocal Agreement with Lee County for the necessary permits, signage, buoys, and enforcement of the ALA prior to the County enacting the Ordinance.






City Hall and Council Building Security Upgrades

Tetra Tech has been selected to perform the design and permitting elements of parking lot security upgrades to City Hall and the Council Building, as well as the Pop's Café patio. The SCP is in the process of being finalized.

A CPTED security assessment of City Hall, Council Building and the surrounding property was performed in February, and presented to CM/Council in April. PW following up making requisite improvements based on opinions presented.




Stormwater Operational Projects








City Hall Entrance Paver Median Island
