

# U.S. Gross Domestic Product


The U.S. economy grew 2.90% during the fourth quarter. While all sectors were positive contributors to the economy, the two largest contributors, consumer spending and business spending signaled a potential slowdown in the economy for 2023. Consumer spending represented the majority of growth at 1.42%, although average Consumer Expenditures growth for 2022 was 1.31%, the lowest calendar year average since 2013. After two quarters of contraction in the business spending, this sector of the economy grew 0.27% during the quarter. Government spending and Net Exports grew nominally at 0.64% and 0.45%, respectively.





# Inflation - CPI

o The year over year Consumer Price Index declined further in December to 6.5%, the lowest reading since October 2021. The Core index (Less Food and Energy) reading of 5.7% was 0.3% lower than November's figure.





# Bloomberg Survey Forecast – February 2023

o GDP growth for 2022 was 2.1%, slightly beating expectations of 1.9%. This was primarily due to Net Exports growth of 2.86% during the third quarter from petroleum exports. Economists.


# Jobs


# Job Growth continued into 4th Quarter

- o More than 4.5mm jobs were created in 2022, including 223k jobs created in December.
- o Net jobs finally reached breakeven in August 2022, twenty-nine months after losing 22mm jobs in March and April of 2020.
- The Great Resignation continues as more than 4.2mm individuals are quitting jobs on a monthly basis. This is 1mm more per month than pre-pandemic levels.

# Unemployment Levels and Labor Force Participation Remain Low

- o The national unemployment rate unexpectedly dropped to 3.5% in December as the labor market remains strong.
- o The labor force participation rate is persistently low at 62.2% in November, suggesting millions of working age people have still not re-entered the workforce although this does not include "gig" jobs and is therefore likely understated.








# Historic Interest Rate Increases during 2022

- The Federal Open Market Committee (FOMC) increased the Federal Funds overnight rate from zero to 4.50% in nine months from March 2022 December 2022. For comparison, the FOMC raised the overnight rate from zero to 0.25% in nine months during the 2015-2018 cycle and reached a peak of 2.50% over a three year period. This has been the most aggressive monetary policy in more than three decades.
- o These rate increases have resulted in an increase in overnight interest rates of more than 400 basis points (4.0%) through December 2022.
- o Longer term US Treasury rates have also increased significantly during this period. The two year US Treasury was 4.28% on September 30th 2022 compared to 0.28% on September 30th 2021 (400 basis points!). The two year U.S. Treasury was 4.49% on December 31, 2022.
- The current interest rate environment has provided the opportunity for reinvestment in yields as high as 4.5% 5.0%, the highest yields since 2007. These securities will provide much higher income compared to the securities purchased during the lower interest rate environment.
- The City's investment program includes daily liquidity investments for short term expenditures and longer duration strategies with average maturities of 1.8 years (1-3 year strategy) and 2.5 years (1-5 year strategy) and 3.8 years (3-5 strategy). This multiple duration approach is structured to providing an investment program with the primary objective Safety of Principal, provide Liquidity to meet short term and long term expenditures while also seeking to earn a market rate of return. These duration strategies are complementary and provide benefits while also seeking to minimize risks in rising and declining rate environments.




# FOMC Dot Plot – December 2021 vs. December 2022





# Inflation takes hold....Yield Curve inverts in 2<sup>nd</sup> half of 2022


Short term yields continue to increase with FOMC rate hike expectations. Meanwhile, longer term rates have declined from recent peaks as odds of an economic slowdown/recession increase.

o U.S. Treasuries with maturities of 3 Months and longer are yielding lower than the Federal Funds over night rate.















# Allocation by Moody's Rating





# **Asset Balance by Security Type**









### **Maturity Distribution by Type**







### Allocation by Moody's Rating






