


Office of Capital Improvements

- Estimated \$250 Million per year in Projects




North 1 West UEP - \$250 Million






North 1 West Master Pump Station 720 Construction Cost of \$8.2 Million




- Notice to Proceed February 2024

- Construction has not started






North 1 East - \$225 Million




North 1 East Booster Pump Station and Tanks Estimated Construction Cost of \$20 Million




- Rezoning & Land Use Applications have been filed

North 1 East Master Pump Station 725 Estimated Construction Cost of \$9.0 Million



- Construction is 75% Complete




Fire Station #10 and Public Safety Annex Design and Permitting

- Preparing Recommendations on space planning needs.




New Fleet / Property Management Facility

- Location North Cape
 Government Complex
- Fleet Facility Est. at \$49 Million
- Property Management Building Estimated at \$10 Million
- Final round of negotiation with Weston and Sampson for the Design and Permitting



- 51 Slip Transfers in Process.
- AECOM adjusting plan to account for slip transfers, 54 slips remaining.
- Site will be Permitted through Lee County.
- Working on Agreement w/ Lee County for Construction in R/W.






Oasis Multi-Purpose Athletic Field

- \$800,000 Design and Permitting Budget
- Design Elements:
 - Football, Soccer and Lacrosse Fields
 - Running Track
 - Bleachers
 - Locker Rooms
 - Pavilions
 - Concession Facility
 - Restrooms
- Final scope and fees for 3 preliminary design options and estimated costs in process with Procurement





FHWA - HURRICANE IAN BRIDGE REPAIRS



Cape Coral

A.) Repair of Bridge Structure 125724 (single structure) located over the Maxine Canal on Surfside Boulevard, south of Veterans Memorial Parkway:

- Funded by FHWA (80%) and City of Cape Coral (20%).
- Est. Design Start: January 2024
- Est. Design Cost: \$110,000 +/-
- Est. Construction Start: TBD
- Est. Construction Cost: \$500,000

B.) Repair of Bridge Structures 125717 (NB Span) and 125718 (SB Span) located over the Eternity Canal on Sands Boulevard, north of El Dorado Parkway W.:

- Funded by FHWA (80%) and City of Cape Coral (20%).
- Est. Design Start: January 2024
- Est. Design Cost: \$130,000 +/-
- Est. Construction Start: TBD
- Est. Construction Cost: \$500,000

Skate Park Building Replacement


- \$1,200,000 in FY 2023 Budget
 \$15,000 in FY 2024 Budget
 \$1,715,000
- Design Elements:
 - 3,250 Maximum SF Footprint
 - Kitchen/Snack Bar/Eating Area
 - Open Retail/ Pro-shop area
 - Recreation Offices
 - Two (2) Classrooms
 - General Seating/Covered Seating
 - Restrooms
- SAC was held in September 2023
- Final Review of Scope and Fee with Burt Hill/Pollack Krieg Architect, Inc. for Design and Permitting.





Emergency Operation Center (EOC) Addition

- \$30 to \$35 Million
 Estimated Construction
 Cost
- City received \$9 Million from the Florida Division of Emergency Management that can be used toward the Design and Permitting
- January RFP for Design and Permitting
- Proposals due March 4th



- \$530,450 Design and Permitting Budget
- Preparing RFP Advertising for Design and Permitting

Andalusia Blvd. Extension



Improvements include:

- New roadway construction
- Traffic signal at Kismet Pkwy
- Curb and gutter
- Sidewalks
- Street lighting
- Median curbing and landscaping

- \$15 Million Est. Construction Cost
- Final negotiations with CW3 Engineering, Inc. for Design and Permitting in progress.
- Design projected to begin in April
- Working through terms with property owner of Parcel 1 Update at Future COW



NE 24th Avenue Widening



- \$20.5 Million Project Budget
- Design, Permitting and Construction included in North 1 East UEP
- Negotiating Land Acquisition SE Corner of Diplomat NE 24th
- Improvements include:
 - 4 Lane Divided Roadway
 - Relocation of LCEC Transmission
 & Distribution Lines
 - Curb and gutter
 - Sidewalks
 - Street lighting
 - Median curbing and landscaping



Sirenia Vista Park Modular Restroom

- \$529,650 Const. Cost
- Substantial Completion
 November 2023
- Contract closeout in
 Progress
