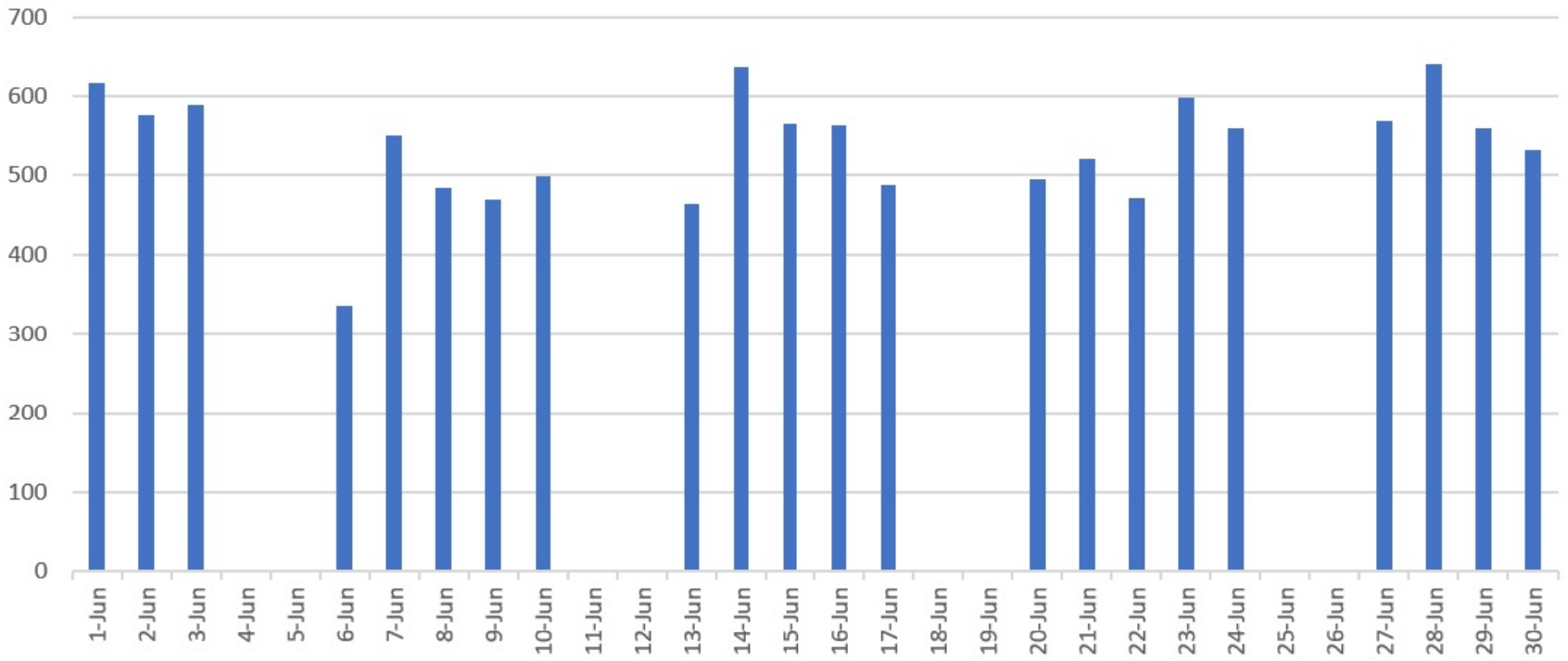

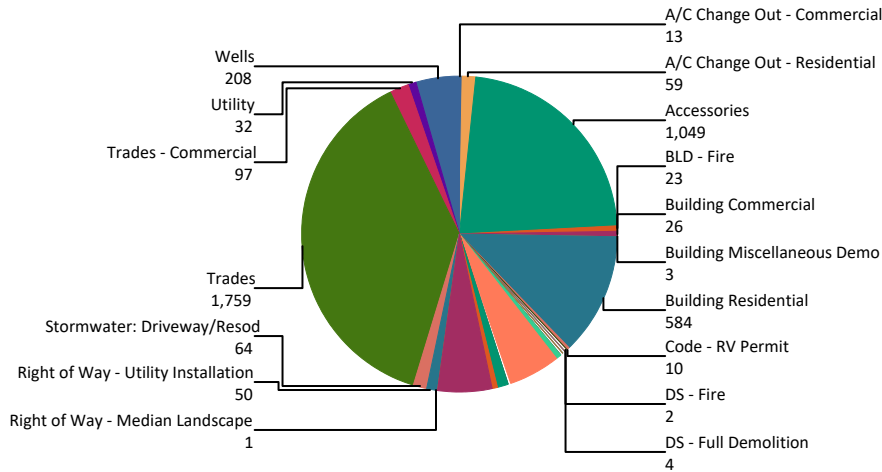


Inspections/day (June 2022)



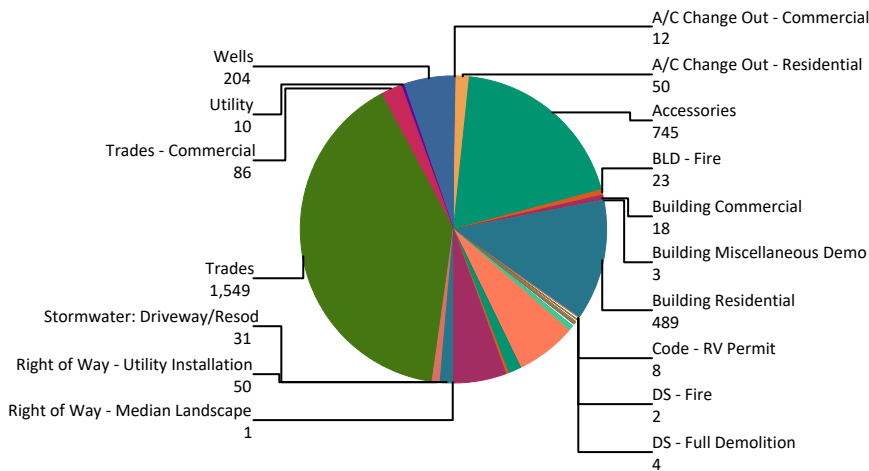
