

INSPECTION SERVICE INFORMATION

General Inspection Information

- Inspections can be requested by using the EnerGov online system at the following website: https://energovweb.capecoral.gov/EnerGovProd/selfservice#/home
- Inspections can be scheduled or canceled up to 9:00pm EST the night prior.
- Scheduled inspections can be canceled through the system before 5:30 a.m. the morning of the inspection.
- After 5:30 a.m., you must contact the office directly for assistance at 239-573-3173 (7:30am-2:00pm, M-F). While we can't guarantee same day requests, we work to achieve this objective.
- EnerGov also allows users to access permit information at all hours. To verify the status of your inspection on the scheduled day, please check status on Energov. Once an inspector name has been assigned, the inspection is active for that day. This will allow you to confirm the inspection if required.
- Inspection tickets are printed each morning and assigned to an inspector by 7:30am.
- Once your inspection has been conducted, the result and comments will be entered and are viewable when logged into the CSS portal.

Contractor Process for Inspections

The City of Cape Coral has spent considerable time, dollars, and resources in providing an efficient method to schedule and verify results of your inspections. We have two automated methods to schedule inspections:

- 1. For Limited service using the automated phone system, to schedule inspections call 855-636-2824.
 - -Note: This number works for permits created in EnerGov and there is no method to leave a message or data for the inspector.
- 2. The best method is to use the web-based program EnerGov, accessible through the capecoral.gov website, or at the following direct link: https://energovweb.capecoral.gov/EnerGovProd/selfservice#/home

EnerGov allows the contractor to input messages, phone numbers, and other inspection data which will print on the inspection ticket and are made available to the inspectors. This is the most efficient way to schedule inspections.
