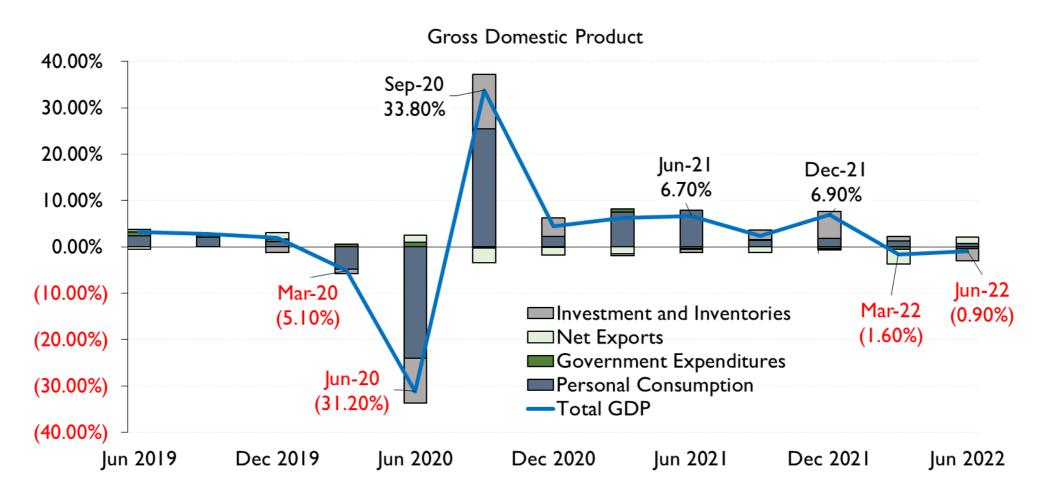

U.S. Gross Domestic Product

The U.S. economy contracted for the second consecutive quarter in June, meeting the technical definition of a recession. This is first recession since the economic shutdown and COVID19 related restrictions were implemented during March of 2020. Contractions in business spending (-2.73%) and government spending (-0.33%) were major factors in the GDP contraction. Week consumer expenditures growth of 0.4%, the lowest level since March of 2020, was not enough to overcome the declines in business spending. Net exports was the bright spot, increasing by 1.43%.

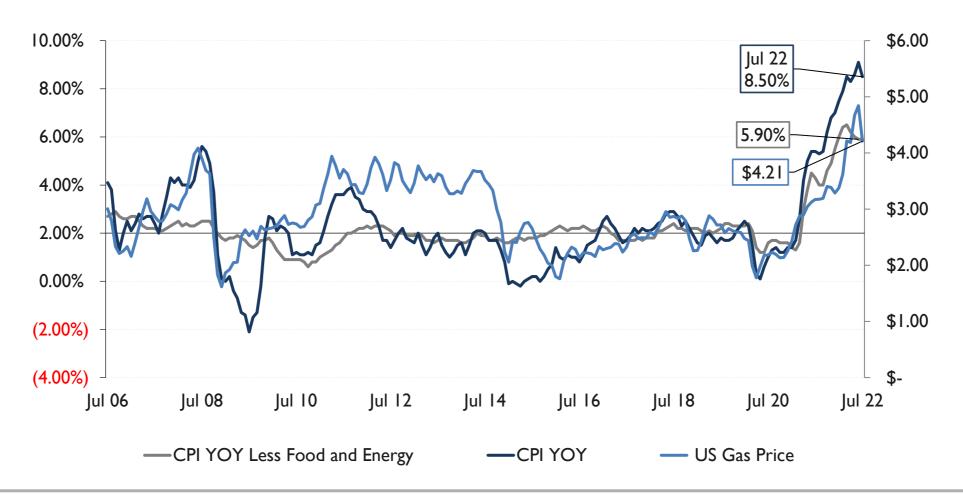




Inflation

o The Consumer Price Index declined in June with a year over year increase of 8.5% (5.9% Core), primarily due to continued a decrease in energy costs from the highs reached in July. Average gas prices declined from \$4.84 to \$4.21.

Consumer Price Index and Gas Prices

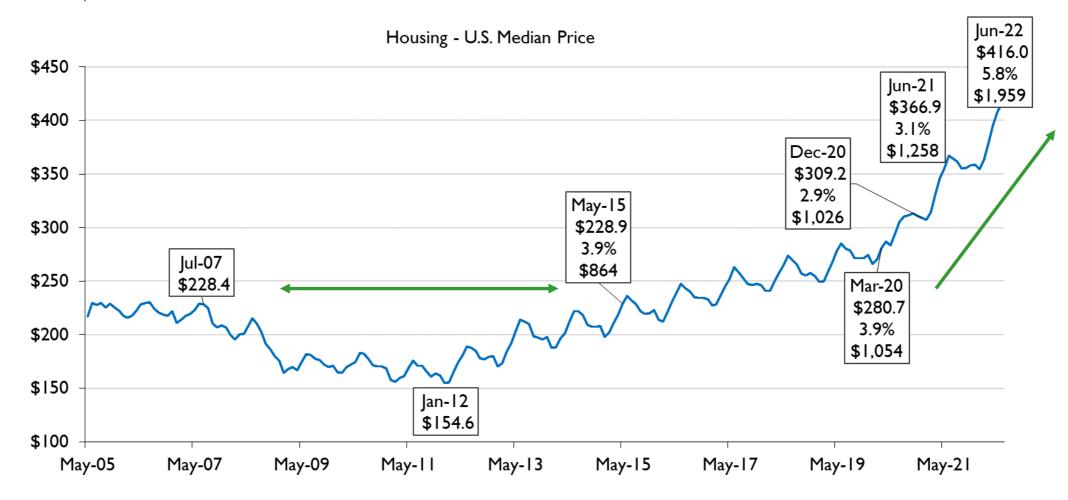




Housing Continues To Set Record Prices...Will This Trend Continue?

Investment Strategy and Maturity Structure

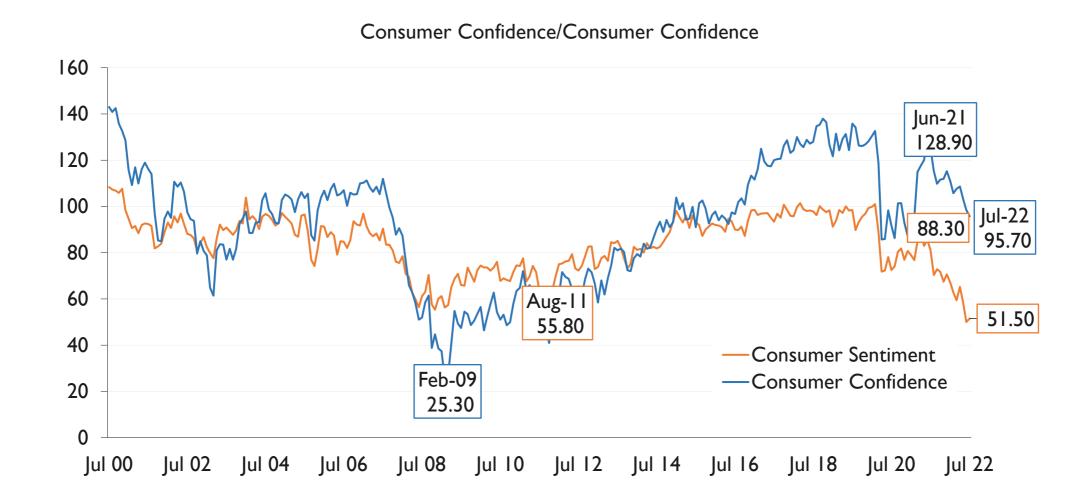
Housing prices have increased 13% YOY June 2022 and 48% since the Pandemic began in March 2020. The principal and interest mortgage cost is up 56% YOY and 85% since March 2020.

o Consumer Confidence and Consumer Sentiment Indexes illustrate the significant decline in a positive outlook given current economic conditions.





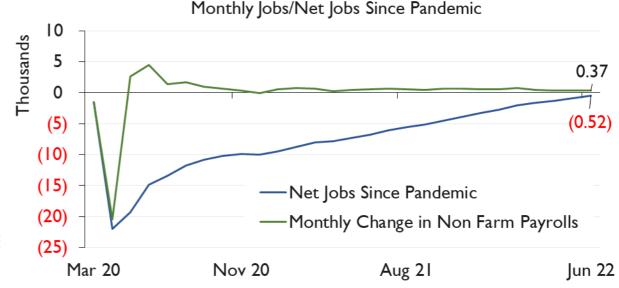
Labor Force

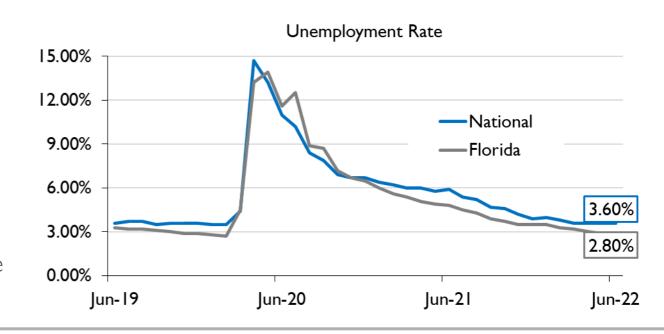
Job Growth remains strong in 2nd Quarter

- o More than 2.7mm jobs have been filled in 2022, including 1.1mm during the 2nd quarter of 2022.
- o There are approximately 520k net jobs that have not been filled from the 22mm jobs lost in March and April of 2022.
- o The Great Resignation continues as more than 4.2mm individuals are quitting jobs on a monthly basis. This is 1mm more per month than pre-pandemic levels.

Unemployment Levels Remain Low

- The national unemployment rate remains low at 3.6% and the Florida job market is even stronger at 2.8%.
- o The demand for labor continues to outpace supply even as wages increase as more than 10.7mm jobs remain open.
- o The labor force participation rate is persistently low at 62.2%, suggesting millions of working age people have not re-entered the workforce

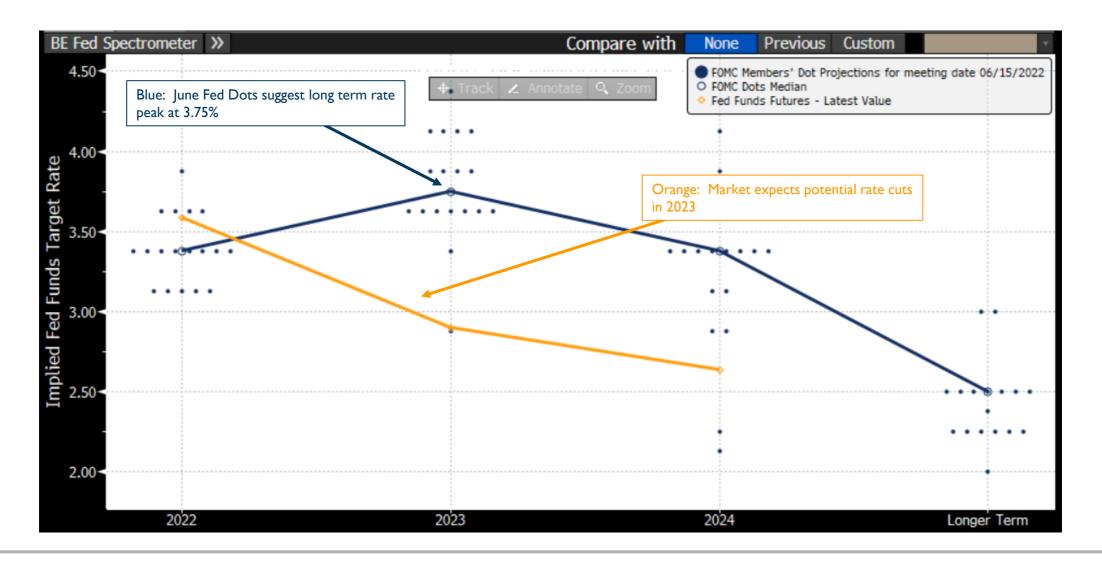
Bloomberg Survey Forecast – August 2022

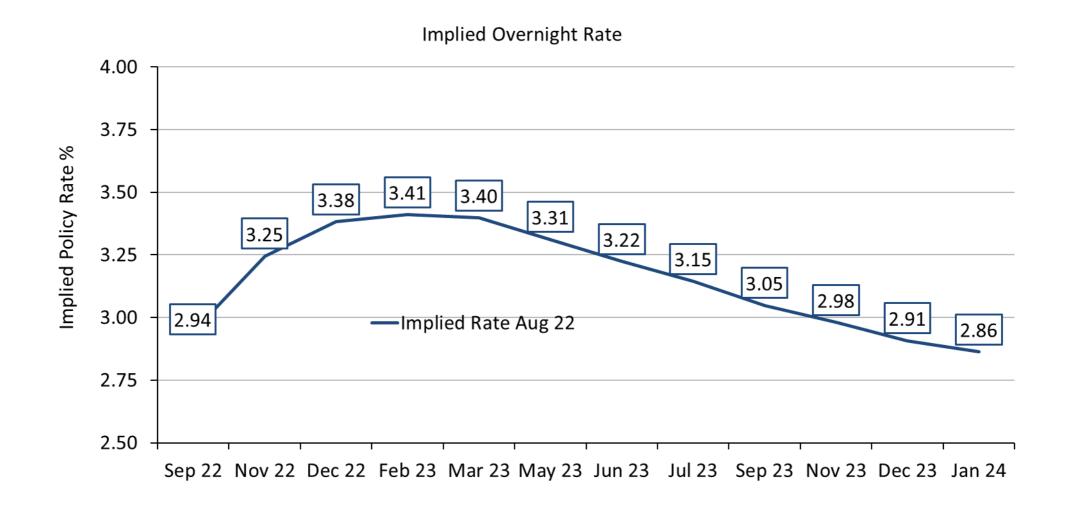
FOMC Dot Plot – June 2022





Implied Future Overnight Federal Funds Rate-August 2022

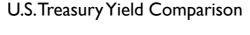

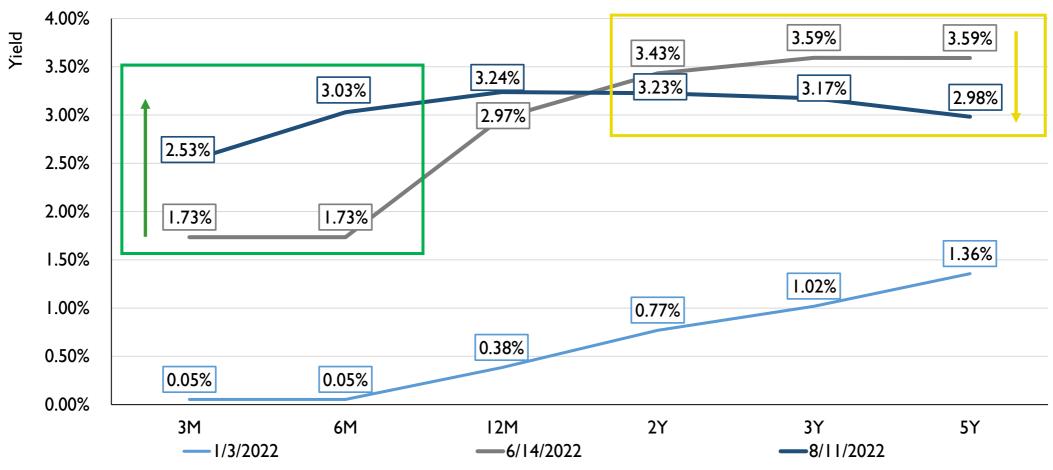




Slope of Curve Inverts over Long Term Growth Concerns

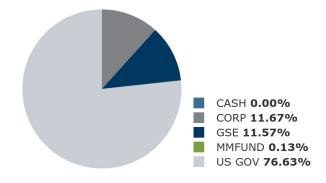

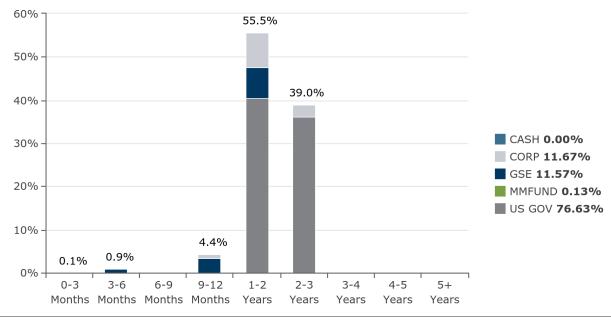

Maturity Distribution by Type



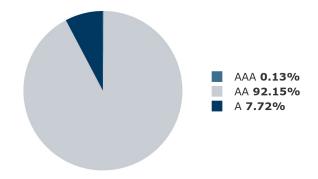

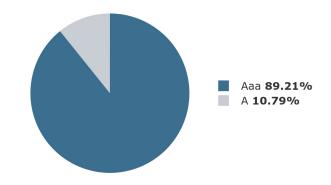

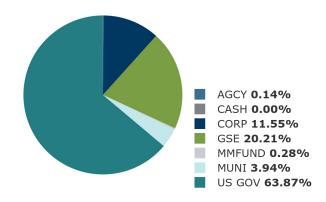

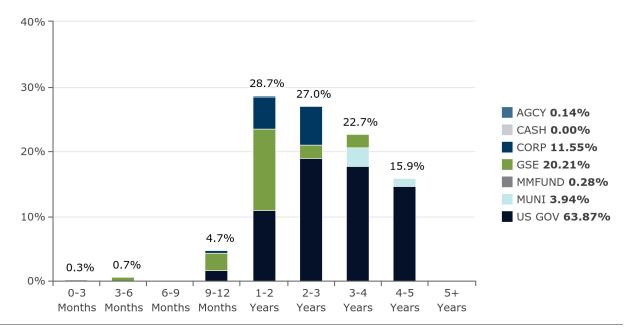

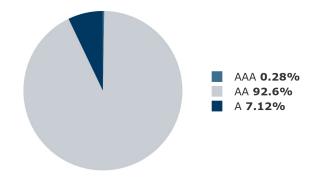

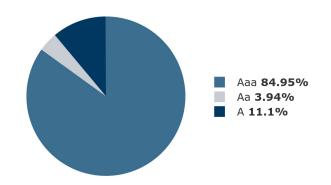

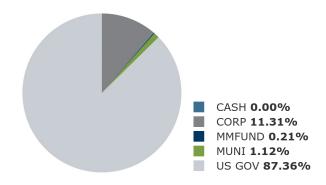

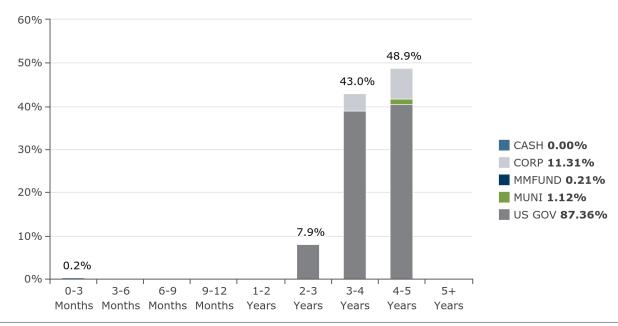

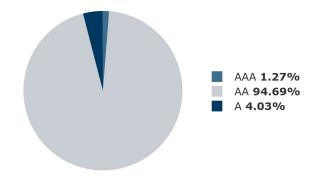

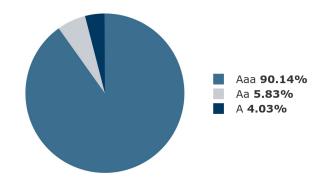

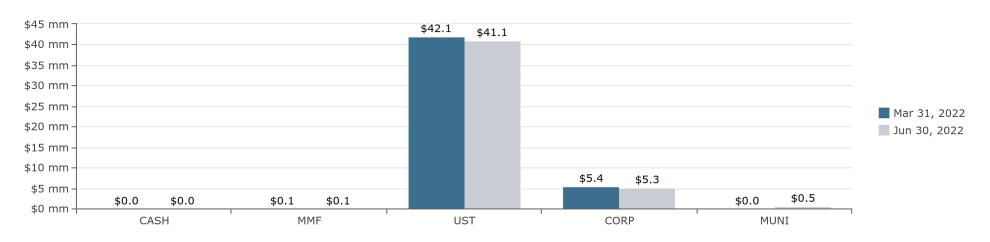

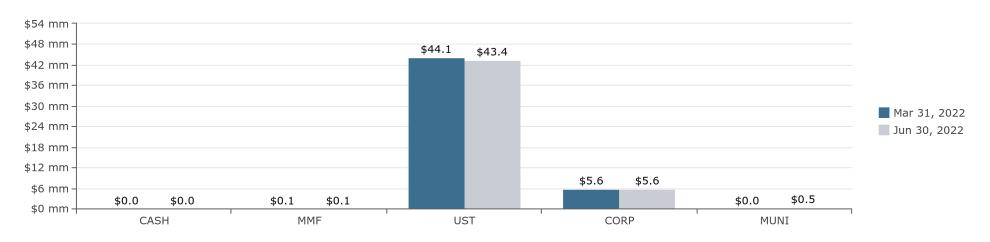

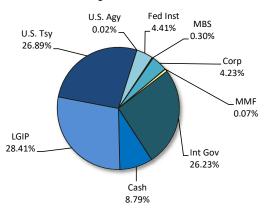
