### <u>AMERICAN RESCUE PLAN ACT (ARPA)</u>

On March 11, President Biden signed a \$1.9 trillion federal coronavirus relief package, known as the American Rescue Plan Act of 2021, into law. The package will provide \$350 billion for state and local governments, with \$13.722 billion coming to Pennsylvania. The commonwealth will receive \$7.5 billion (including a \$279 million set aside for capital projects), counties will receive \$2.8 billion, and municipalities with populations of more than 50,000 will receive \$2.3 billion. In addition, municipalities in Pennsylvania with a population of less than 50,000, which includes nearly all townships, boroughs, and small cities, will split \$983 million based on population (while Philadelphia alone will receive more than \$1.3 billion). This means that EVERY township will receive funding from this act.

Colerain Township's allocation will be \$ 409.465.96. The Township received half of this money July 7<sup>th</sup>. The other half is scheduled to arrive in June of 2022.

To date, Colerain has until December of 2024 to make an obligation where the money will be spent and until December of 2026 to actually spend the funds. Changes and clarifications keep coming in almost every day so this will be an ongoing process.

The United States Treasury Department is responsible for determining what this allocation may be used for. Unfortunately, the money can only be used for items related to the Coronavirus State and Local Fiscal Recovery Funds such as:

- 1. Responding to the COVID-19 emergency or addressing negative impacts.
- 2. Providing premium pay to eligible workers performing essential work or grants to eligible employers who have eligible workers.
- 3. Lost revenue replacement for the provisions of government services due to the COVID-19 emergency.
- 4. Make necessary investments in water, sewer, and broadband infrastructure.

This list is by no means comprehensive; before the Supervisors make any decisions, the Township Solicitor will be involved. The Treasury Department forwarded a detailed explanation and they continue to revise and clarify the more than 150-page document.

The Supervisors are hoping to be able to help out our Emergency Services but they will certainly need to take every precaution and move slowly and surely as any funds spent incorrectly must be returned.

#### Lancaster County's Proposed Comprehensive Plan-places 2040

Colerain Township is currently attending workshops with the Lancaster County Planning Commission and other Southern End Municipalities in order to discuss the County's proposed places2040 plan. Colerain has not updated their Comprehensive Plan since 2004 and will now consider entering into a South Region Comprehensive Plan with certain Southern End Municipalities that would be in agreement to join.

What is a Comprehensive Plan? Just like businesses, communities need a plan for their future. It's typically called a Comprehensive Plan (or Comp Plan, in planning lingo), and its purpose is to:

- Educate people about the community's strength, weaknesses, opportunities, and threats;
- Discuss how key resources will be protected and enhanced
- Establish principles for growth and development
- Recommend priorities for funding and new investment
- Provide a rationale for future direction and policies
- Guide community leaders in making decisions

places 2040 is a bit different than a typical comp plan, and many other plans the Lancaster County Planning Commission (LCPC) has prepared in the past. It's less of an encyclopedia and more of a guidebook.

Like past plans, it still focuses on issues that are generally within the "wheelhouse" of the planning profession: Land use, transportation, and quality of life. What's different about this plan is that it does not try to address every aspect of these issues.

Comp Plans often present a laundry list of ideas, rather than a practical "to do" list. By contrast, this plan highlights just a few things that need to happen if we really want to make a difference in the next 10 to 20 years. These are the issues that concern people the most-and the things we need most to change.

The first phase identifies seven issues and opportunities that would affect Colerain as the focus for the plan. The seven items are as follows:

Managing Growth	Create compact, walkable communities
Housing Choice	. Ensure safe, quality housing options for everyone
Employment	. Support 21st Century Industries and jobs
Transportation	. Build a Network with more alternatives and connections
Parks, Trails, and Natural Areas	Provide more places to hike, bike, and enjoy nature
Agriculture and Farmland	. Protect both the farm and the farmer
Thinking Beyond Boundaries	Promote cooperation, work together, and share resources

This process has just begun and will take many months to complete

# A Message to our Amish Community Concerning Non-Photo ID's.

Colerain Township's depository is Prosper Bank (used to be Coatesville Savings). If you are in need of an Improvement Guarantee, be aware that Prosper Bank has changed their ID Requirements to open a bank account. You will now need to submit one of the following: Birth Certificate, Non-Photo ID or Social Security card. With that in mind we would like to encourage you to acquire a Non-Photo ID from PennDot. A Non-Photo ID is also required by some Notaries.

If you're a legal Pennsylvania resident, you can apply for a non-driver ID card when you turn 10 years old. You will need to visit your local PennDOT office with:

- A completed <u>Application for Initial Identification</u> Card (Form DL-54A).
- Proof of your identity and legal U.S. presence, such as your:
- <u>U.S. birth certificate</u> with raised seal (copies will not be accepted).
- Valid U.S. passport.
- Your Social Security Card.
- Proof of your PA address (2 documents) if you're 18 years old or older, such as your: Lease agreement;
   W-2.; Current utility bill.
- **Payment** for the \$31.50 fee.

#### **ELECTION DAY- NOVEMBER 2, 2021**

The polling place for Colerain Township is here at the Township Building. Polls will be open 7:00 A.M. to 8:00 P.M. In Pennsylvania's Primary Elections, voters choose their party's nominees to run in the General Election by casting ballots.

Primary Elections in PA are held on the third Tuesday of May in all years except Presidential years when they are held on the fourth Tuesday of April. General Elections are always held the first Tuesday, after the first Monday in November, which falls on November 2, 2021 this year.

#### **COMMUNITY PARK-**

The one issue we seem to have is folks leaving their trash behind. A trash bag will be provided for you but you must take your trash with you.

**King's Bridge at Noble Road-**The State will start construction on this Bridge around August 27<sup>th</sup> until May 13, 2022. The replacement project includes replacement of the existing beams and increasing the span length from 35 feet to about 51 feet. Approximately 450 feet of roadway reconstruction is included in the project. A 11.5-mile-long detour route will be used during construction.

#### RECYCLING

Colerain Township residents have been given permission by Lower Oxford Township to use their recycling bins. There are 5 containers that are marked, please use only as marked. You can take your recyclables in any time day or night. Plastic jugs, glass bottles and tin cans should be washed out and clean. They take aluminum cans, steel cans, glass and plastic bottles (#1 and #2), office paper, newspapers, junk mail, magazines, flattened cardboard, clothes and shoes. #### FROM THE TAX COLLECTOR

Thank you to those residents that called to let the Tax Collector, Judy Beiler know that they have children turning eighteen. All residents must pay Per Capita Tax once they are eighteen and live in Colerain Township. Also, if you are eighty or disabled you know longer have to pay Per Capita. Please call Judy at 529-6267 to let her know. We truly appreciate your honesty.

#### **INTERIM NOTICES**

We have had some residents call about receiving Interim Notices from the County. Here is a brief explanation how this works: When you are issued a permit from the Township a copy is put aside to send to the Lancaster County Tax Assessment Office. When they receive it at some point they will come down to your home and inspect what work has been completed associated with that permit. Every Township submits these permit copies a little differently. Some do it monthly, others quarterly or possibly even yearly. Here at Colerain, we submit monthly as of 2016. If you have a question concerning the assessment amount you will need to call the Lancaster County Tax Assessment Office at 717-299-8381.

#### WELL ISOLATION DISTANCE WAIVER REQUESTS

Due to heavy rains, there have been several drain fields that have failed in Colerain recently. In some of the failures due to a smaller lot the requirement to be 100' from their wells could not be met. If this happens to you may come to the Supervisors and ask for a Well Isolation Distance Waiver. At our July 21, 2021 meeting the Board voted to add a condition to all of these Waivers that the water be tested each year and the report submitted to the Township. As for the procedure, your Septic System Installer will take care of this for you by reaching out to Marvin Stoner, SEO first then the Township. An Agreement must be signed, notarized and recorded. SEPTIC PUMPERS AND INSTALLERS-Make note to include a drawing of the septic and include measurements from all neighboring wells. We thank you for your cooperation.

#### **FAQ's FOR ZONING**

**Is a permit required for a roof?** Yes, anytime the UCC requires an inspection there is a permit required.

**Is a permit required for an Agricultural Structure?** A Zoning Permit is required.

**Is a permit required to re-pave a driveway?** Not unless you are adding additional impervious surface such as widening.

**Is a permit required for a fence?** Yes, this would be a Zoning Permit to make sure the fence meets the setbacks

Is a permit required for a shed? Yes, this is also a Zoning Permit

**How long does it take to get a permit?** For a simple permit that has no Storm Water projects, usually 1 week.

If I am replacing a deck and/or patio; do I need a permit? If you are replacing like for like then you do not need a permit. For a new deck, as long as it is 30" or less from the ground you do not need a permit.

#### SECRETARY'S CORNER-FAQ's

**Do you have a Noise Ordinance?** No, Colerain Township does not currently have a Noise Ordinance

**I found a dog, who do I call?** Please call the Dog Warden Travis Hess at 717-805-3442. The Township does not handle animals other than dead deer along the roads.

How do I determine my property line and do you have a plot plan of my lot? The only way to determine property lines is to have your property surveyed. The County has an online map but the lines are not exact. The Township may have a plot plan of your property if it was part of a subdivision plan that is on file with the Township.

My neighbor...fill in the blank The Township does not get involved in neighbor disputes over property lines, tree branches that hang over into your yard, etc.

Why did my mailbox get knocked down during plowing and will you replace it? More than likely, it was the snow and not the plow that did this. Please know that this does not make anyone happy and will happen every winter to someone. The Township does not replace mailboxes.

The Snow Plow came through after I opened up the top of my driveway and it is shut again, why did they do this and will they come open it up for me? It is the Township's responsibility to open the roads for the safety of the public. They usually plow a road more than once. The Township does not plow private driveways.

## Please make note of the burning rules

In Residential (R), Village Center (VC), and Conservation (CN) Districts open burning of domestic waste is allowed under these conditions:

Domestic waste is defined as any waste materials resulting from residential use, including, but not limited to, paper, leaves, garden vegetation, wood, and food scraps. Domestic waste does not include any of the following:

- Biological waste.
- Chemical waste.
- Pressurized containers.
- Plastics or rubber materials.
- Hazardous material as defined in the Code of Federal Regulations, Title 40, Chapter 1, part 261, dated July 1, 1984, or as amended from time to time thereafter.
- Any waste materials not generated by the on-site residence.
- Any other material that would produce a noxious or dangerous odor, gas, and/or explosive when burned.

All burning shall be conducted during daylight hours. Except as to the burning of leaves and brush, such burning shall be confined within a noncombustible container which is covered with a screen of one-quarter inch (1/4") or smaller mesh. Such containers shall be raised off the ground and set atop noncombustible supports.

Burning shall be constantly supervised by a responsible

person at least sixteen (16) years of age.

All burning shall be completely extinguished before the person supervising the burning shall cease such supervision.

All burning shall be setback at least twenty-five (25) feet from any building and fifteen (15) feet from any lot lines or right-of-way. Such burning shall be confined to the site's side or rear yards.

All burning shall be confined to the property where the domestic waste was generated.

A pressurized water (garden) hose must be available with a working nozzle of sufficient strength to reach the further most area being burned.

Open burning is not permitted under conditions of excessive winds or dryness. Open burning is expressly prohibited during a drought emergency declared by the Pennsylvania Emergency Management Council, other agencies of the Commonwealth of Pennsylvania, or the Colerain Township Board of Supervisors.

No materials other than wood and wood products may be burned in an open fire.

Smoke and emissions shall be so controlled as not to be offensive to others.

Outdoor fires, except within burning barrels, shall be located at least 20 feet from any property line or right-of-way and at least 75 feet from any structures.

Leaves and brush fires shall only be burned in an area cleared in a radius of forty (40) feet from the open fire. Such fires are subject to sub-section L herein, except for leaves and brush fires in a burn barrel (sub-section C of this Section).6.07.14 No fire shall be ignited, kindled, and/or maintained on a public street, alley, sidewalk, and/or other public lands within Colerain Township.
