The City of Elko Ordinance 517 requires all persons peddling/soliciting within the Elko City limits to apply for a Solicitors/Peddlers License. The applicant must complete the application and return it to the address listed above where they will pay the appropriate fee and will be issued a license. The applicant must contact the **Nevada State Health Department** if they are selling food and provide us with a clearance signature on the line provided below.

The applicant must also contact the **Nevada Department of Taxation at the Reno** office and provide documentation of compliance from Taxation. The Reno Taxation office can be reached via their website at www.tax.state.nv.us, via email at renoevents@tax.state.nv.us, fax at 775-688-1303 or by phone at 866-962-3707.

The applicant will be required to obtain the signature from the Elko Police Department and once they receive the signature, the applicant will return to Elko City Hall, at the address above, and will be issued a permit with all the solicitors/peddlers listed. They will then return to the Police Department with the permit and all the listed solicitors/peddlers will be issued their work cards. A separate fee of \$100.00 per individual will be charged by the Police Department for the work cards.

The City has the following restrictions:

Idaho Street Restriction: Solicitors, temporary merchants and/or peddlers shall not be allowed to display, sell, or solicit merchandise for sale along Idaho Street or within 100 feet of the right-of-way line on either side of Idaho Street where there are no curb, gutter, and sidewalk improvements.

City Park Restriction: No Business License shall be issued for business to be conducted within any City owned park and/or adjoining right-of-ways including, but not exclusively, streets, curbs, gutters or parks unless allowable under the Special Events License provisions (4-1-16), Title 5 Chapter 12, Section 2 and 3, or operating with a City Concessionaire Agreement.
