I agree to read and execute the following liability release agreement. 1. I acknowledge that my participation in outdoor adventure-based activities such as skiing and snowboarding rentals known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property (including SnoBowl rental equipment in my possession) and to third parties. 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks. 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Elko SnoBowl, their employees, agents, officers, directors and the manufacturers and distributors of this equipment from any and all claims, demands or causes of action which are in any way connected with my participation in this activity or my use of SnoBowl equipment or facilities including any such claims which allege negligent acts or omissions of SnoBowl. 4. Should SnoBowl or anyone acting of their behalf be required to incur any attorney's cost to enforce this agreement I agree to indemnify and hold harmless of all such fees and costs. 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity or else I am willing to assume and bear the costs of all risks that may be created directly or indirectly by any such condition. 6. I understand that snowboard/boot systems will NOT normally release. Which is a non-release system and that its use cannot guarantee this users safety and that the system does not reduce risk or injury. Any questions that I have about any equipment that I am renting have been satisfactorily answered. I agree to check the equipment including bindings before each use and that I will not use any equipment if parts are damaged, loose or missing. 7. I agree to pay for the repair or replacement on any equipment on any equipment rented by me which is damaged, beyond normal wear and tear or is stolen or lost. By signing this document I acknowledge that if anyone is hurt or property is damaged during my participation in this activity I may be found by a court of law to have waived my rights to maintain a lawsuit against SnoBowl and their employees, agents, officers, directors, the manufactures and distributors of this equipment of any claim form which I have released them herein.
