2020 GENERAL CITY ELECTION/CANVASS OF RETURNS/ ABSTRACT OF VOTES/ CERTIFICATION OF ELECTION

WHEREAS, pursuant to NRS 293C.140 the General City Election for the City of Elko was held on November 3, 2020 for two (2) members of the City Council; and

WHEREAS, immediately after the November 3, 2020, General City Election the election returns were filed with the City Clerk and thereafter, pursuant to NRS 293C.387 (2) as amended by Assembly Bill 4 on November 16, 2020, at ascheduled City Council meeting the City Clerk did present the returns from all the precincts and districts in the City to the City Council, the governing body of the City, and the City Council did meet with the Mayor to canvass the returns to the election on or before the 13th day following an affected election that is subject to the provisions of sections 2 to 27, inclusive of Assembly Bill 4 passed in the 32 Special Session of the Nevada Legislature; and

WHEREAS, in competing the canvass of the returns the City Council and the Mayor did: (i) note separately any clerical errors discovered; and (ii) take a count of the changes resulting from the discovery, so that the results declared represent the true cast; **and**,

WHEREAS, the returns from all precincts and districts within the City have been received by the City Council and Mayor and have been canvassed and the CityCouncil and Mayor having discovered no clerical errors and, therefore no changes resulting therefrom, do hereby find that the results declared represent the actual and true vote cast; now, therefore,

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED BY THE CITY COUNCIL, CITY OF ELKO, NEVADA:

1. <u>Canvass.</u> Upon review and canvass of the election returns for the November 3, 2020, General City Election, the Summary Report, being a summary of the votes cast by precinct attached to the Certification of Abstract, which is attached hereto and incorporated by reference, is hereby found to be the actual and true count of the votes received for each candidate listed thereon.

2. **Abstract.** The Certification of Abstract prepared by the City Clerk shall be entered upon the record of the City and the City Clerk shall: (i) certify the abstract; (ii) make a copy of the certified abstract (iii) make a mechanized report of the abstract in compliance with regulations adopted by the Secretary of State; and (iv) transmit the copy of the certified abstract and the mechanized report of the abstract to the Secretary of **State** within thirteen(13) days after the election, that is, on or before November 16, 2020, 3. <u>Certification</u>. The City Clerk is hereby directed to issue under her hand and official seal pursuant to NRS 293C.387 to the person so elected a certificate of election and to deliver the certificate to the person elected upon application at the office of the City Clerk.

4. **<u>Oualification</u>**. The officer elected to the governing body of the City qualifies and enters upon the discharge of their duties the first Monday in January after the election.

5. **Elected Officer.** The candidate denoted in the Certification of Abstract attached hereto and incorporated by reference who received the higher amount of votes for the office is declared elected to the offices as follows:

- a. <u>Ms. Mandy Simons</u> is declared elected to the Office of City Council of the City of Elko effective January 4, 2021.
- **b.** <u>**Mr. Clair Morris**</u> is declared elected to the Office of **City Council** of the City of Elko effective January 4,2021.

IT IS FURTHER RESOLVED that this Resolution shall be effective and shall be in force immediately upon adoption, and that upon adoption of this Resolution by the Elko City Council it shall be signed by the Mayor and attested to by the City Clerk.
