A Letter from the Chief

Thank you for visiting the Hinsdale Police Department's Annual Report to the Community!

The Hinsdale Police Department is a proud organization in the noble profession of law enforcement. We are a low-crime community. When crime does occur, we spend considerable resources on training and equipment to ensure that those responsible are caught and prosecuted. We are a values-driven agency that seeks to provide the best law enforcement services to our residents, the source of our authority.

I would like to highlight three cases from 2O22 that best exemplify the agency's competency and commitment to professional law enforcement.

In June, an armed robbery crew struck the Verizon Store in downtown Hinsdale shortly before the store closed for the day, stealing 60 iPhones. Within hours, Hinsdale officers, with their law enforcement partners tracked the suspects to suburban Ford Heights, took the gunman into custody, and executed search warrants that led to the recovery of the stolen property. One offender remains in the DuPage County Jail, and a second individual has been identified and is being sought for prosecution.

In May, a postal worker in West Hinsdale was the victim of an armed robbery while on his route. Hinsdale officers identified the offenders and recovered evidence of the crime after serving search warrants. The offenders await formal charges by the U.S. Attorney's office.

In September, Chicago gang members shot a twelve-year-old boy in the head on the west side of Chicago. Shortly after the crime, the offender's vehicle entered Hinsdale where officers were able to "spike" it using a tire deflation device. Officers pursued the vehicle back into Cook County where the car was eventually "boxed-in" by Hinsdale officers and the offenders were taken into custody.

Our success in these and other cases highlighted in this report would not be possible without the support of our residents and our local elected officials. We do not take this support for granted, and speaking for the men and women of the Hinsdale Police Department, it is both an honor and privilege to serve. Success would also not be possible without the commitment, courage, and dedication of the men and women of the Hinsdale Police Department- I am proud to serve alongside you, and I am grateful for your service.






Traffic Safety Campaigns

Hinsdale Police Department participated in several traffic safety campaigns throughout the year which are founded by I.O.D.T Traffic Grant and issued by the state.

In 2022 our officers committed 402.75 hours and issued 542 citations during the following 10 special enforcement details.






Vehicle Pursuits


Our department continues to witness a significant increase in motor vehicle pursuits. Several factors contributed to this increase. We are experiencing more armed subjects carrying weapons in what were traditionally non-violent property crimes, like burglaries and auto thefts. We also experienced a greater number of stolen autos or those wanted for other crimes in the community.

The Department recorded 15 motor vehicle pursuits last year. Those were typically short in duration in which officers engaged a vehicle that was stolen, wanted, or suspected in another crime. In a dozen other cases, offenders fled prior to the officers initiating action. We act to safeguard the community. Sometimes that means engaging a potentially armed criminal suspect and sometimes that involves not pursuing if the risk to the public outweighs the benefits of the pursuit.



Use of Force

The Hinsdale Police Department responded to over 17 thousand calls for service in 2022. Occasionally officers are required to detain individuals who either actively or passively resisted arrest. The most significant use of force involved an officer deploying a Taser on a subject in an armed commercial burglary. The remainder of the incidents involved subjects resisting the act of handcuffing. The Hinsdale Police Department prides itself in its ability to de-escalate tense situations, and our use of force incidents remain relatively rare.



2022 Highlighted Cases

Gang Members Arrested for Shooting

On September 13th, a twelve-year-old boy was shot in the head on the west side of Chicago as he was walking home from a store in the 1800 block of West 21st Place. The child was reported to be in very critical condition. The Chicago Police Department chased the offender's vehicle but that chase was terminated by Chicago P.D. supervisors due to speeds. A helicopter located the car traveling near First Avenue and the Stevenson expressway and followed it west on 47th. Chicago requested area law enforcement attempt to stop the vehicle. As the car crossed 47th Street into Hinsdale, Hinsdale police officers used spikes to flatten the car's tires and then initiated a traffic stop at County Line Road and First Street. The car fled from us and Hinsdale Officers pursued the offenders south on County Line Road, east on Plainfield, and then North on East Avenue in the Brookfield/ La Grange area. Hinsdale Officers were able to "box" the car in and take three suspected shooters into custody. Two handguns were recovered along the path of the suspect's flight which matched the ballistic from the shooting. Two Chicago men, 22 and 23 years old, both with gang affiliation, were charged with a total of five counts of First Degree Murder.

This case demonstrates our officers' willingness to engage with armed criminal offenders who have no regard for the life or property of others. According to the Chicago Police Department spokesman, the offenders "were looking for someone to shoot". Our thoughts are prayers are with the victim and his family.

Murder Suspect Arrested in the Village Center Business District

On October 3lst, Officers located a 46-year-old Montgomery man who was wanted in the shooting death of his wife. At approximately 2 p.m., a Hinsdale officer observed a car wanted for homicide stopped in the parking lane at Garfield and First Avenue. Hinsdale officers boxed the car in to prevent a chase and took the suspect into custody. A gun, later determined to be the murder weapon was recovered from the offender's vehicle. The man was charged with the homicide by Kane County Authorities.


2022 Service Excellence Award Detective Sergeant Lou Hayes

Patrol Division

The Patrol Division is the largest component of the police department. It consists of fifteen sworn officers and four front-line supervisors, constituting 76% of our sworn personnel. They are supplemented as needed by detectives, administrative personnel, and school resource officers.

The Patrol Division responds to the vast majority of the agency's calls for service, which constituted over seventeen thousand calls in 2O22. It is staffed to provide 24-hour response and preventive crime patrols in the Village. Hinsdale officers respond to a wide variety of calls for service in any given year, from something as mundane as a parking complaint to a felony crime in progress.

Patrol Officers handled 17.990 total calls for service in 2022

Investigations

Our Investigations Division includes:

a Detective Sergeant
two Detectives
a Juvenile Investigator / DARE Officer
a High School Resource Officer
an Evidence & Property Custodian

The Investigations Division follows up on crimes of residential burglary, robbery, auto thefts, unnatural deaths, financial schemes, sex crimes, school threats, identity theft, domestic violence, and other violent, property, and cyber-crimes. Investigators also conduct pre-employment background checks on prospective police officers and other non-sworn employees.

We assign detectives to a county-wide task force that handles: homicides, officer-involved shootings, predatory child sex cases, and other complicated investigations. Our members routinely form and work with various investigative and intelligence groups to handle cross-jurisdictional crime sprees and patterns, such as residential burglaries, organized retail thefts, carjacking, and financial crimes. By working with other police departments, we maximize crime-fighting resources, such as the high-tech software and tools necessary to analyze data, conduct surveillance, connect cases, and identify criminal networks.

The Evidence & Property function maintains items collected at crime scenes, as well as found property. The unit oversees the processing of these items by laboratories, forensic units, and scientists. Evidence may include recovered weapons, automobiles used in crimes, DNA, fingerprints, sex assault kits, electronic devices, and digital media.

Crime Prevention, School Resource Officer, and Juvenile functions provide public education and outreach programs including: Bicycle Safety events, Drug Abuse Resistance Education (DARE), National Night Out, Department Open House, Safety Village, and other community events. This unit works within our schools and alongside our community partners to promote safety and share crime prevention tips.

Department Training



Training is a priority for the department. Officers complete training on a monthly basis in a variety of formats including roll call presentations, individual computer training modules, regional police training seminars, and the use of specialized structures including indoor and outdoor gun ranges. Topics include law updates, recent court decisions, investigation of specific crimes, mental health awareness, resiliency, defense tactics, de-escalation techniques, and marksmanship.

Some training is mandated by the Illinois Training and Standards Boards which applies to every law enforcement officer in the state: other training is based on the goals and needs of the agency. This year it was the department's goal to enhance the familiarization with each one of our schools and rapid deployment exercises in which officers were required to respond to specific locations and quickly and efficiently to confront an intruder. We are grateful to the schools in Hinsdale that participated in the training and allowed us to conduct simulated scenarios in their buildings during the off hours. These scenarios increase our officer's confidence and ensure a professional, tactical response in the event of an emergency.

Additional training was conducted on crisis intervention, pursuit driving, and the proficient use of non-lethal force options.

Public expectation of law enforcement have never been higher. Training is an essential element to ensure that we meet those expectations. We are grateful to the Village Board for allocating funds to run a robust training program that far exceeds the standards placed on us by the Training and Standards Board.

Mutual Aid



Metropolitan Emergency Response and Investigation Team (MERIT): DuPage MERIT provides mutual aid assistance to the Village during natural-made disasters or other law enforcement emergencies that exceed staff capabilities. The establishment of MERIT consolidates existing intergovernmental law enforcement services currently provided by the DuPage Felony Investigation Assistance Team(FIAT) and the DuPage Major Crime Task Force (MCTF).

- Det. Carter Sward is assigned to Major Crime Unit (MCU) and Public Integrity Unit (PIT).





Juvenile Crime Prevention Programs and Safety

D.A.R.E Program continues to be the prime drug prevention program offered by the Hinsdale Police Department. D.A.R.E (Drug Abuse Resistance Education) is a collaborative effort by D.A.R.E certified law enforcement officers, educators, students, parents, and the community to offer an educational program in the classroom to prevent or reduce drug abuse and violence among juveniles. The D.A.R.E program generally consists of ten (IO) lessons and is taught by Officer Kowal to all fifth-grade students in Hinsdale Public Schools and in sixth-grade classrooms in Hinsdale Parochial Schools. The Middle School D.A.R.E program consists of ten (IO) lessons taught by Officer Kowal in the eighth-grade classrooms at Hinsdale Parochial Schools and five lessons taught at the Hinsdale Middle School, The program concentrates on helping students make good decisions, develop awareness of consequences, and drug, alcohol, tobacco awareness and resistance. Also taught at the Middle School level is VEGA (Violence Education Gang Awareness) which is a five-lesson program dealing with conflict resolution, avoiding gag activities and problem-solving without violence.

Officer Kowal also acts a liaison for all District 181 Elementary Schools, Hinsdale Middle School, St. Issac Jogues School, Hinsdale Adventist Academy, The Community House, local Preschools and many other community organizations and programs focusing on juvenile safety. She is an active participant on the District 181's Safety & Crisis Committee which is dedicated to ensure safety of all students and staff. She assists with training staff in A.L.I.C.E (ALERT, Lockdown, Inform, Counter and Evacuate).

The Hinsdale Police Department works closely with school administrators and participates in all annual school lock-down drills.

You Are Not Alone (YANA)

The YANA program is a free service to senior citizens who live alone and would like someone to check on them on regular basis. Residents signed up for this program are called weekly to check-in and provide information on important community events.

Special Needs Program

This program was created to assist residents of Hinsdale who may be at greater risk of becoming confused, disoriented, lost, or missing. It is designed to provide the Hinsdale Police Department with the necessary information that will allow a police officer to respond more quickly and more effectively when dealing with a special needs person.

Professional Standards



Law Enforcement Accreditation

CALEA serves as the premier credentialing association for police agencies. The standards are promulgated by a board of 2l commissioners, representing a full spectrum of public safety leadership. The assessment process includes extensive self-assessment, annual remote web-based assessments, and a quadrennial site-based assessment. Candidate agencies are presented to the Commission for final consideration and credentialing.

CALEA Accreditation is a voluntary process and participating law enforcement agencies, by involvement, have demonstrated a commitment to professionalism. The program is intended to enhance organizational service capacities and effectiveness, serve as a tool for policy decisions and management, promote transparency and community trust, and establish a platform for continuous review.

The Hinsdale Police Department was originally accredited in 1996. In July we received our 9th Accreditation Award from the Commission. We appreciate all the work that went into the award by staff, our Accreditation Manager Cathy Navara, and various public officials and community members who agreed to be interviewed by CALEA assessors.
