RE: 2024 Resurfacing Program

CONSTRUCTION ACTIVITY NOTICE (Project Start)

Activity Type: Project Concrete Work

Dear Resident,

The Village is commencing the **2024 Resurfacing Program**. The scope of work may include utility improvements, street resurfacing, pavement patching, curb and gutter repairs, ADA sidewalk replacement, and parkway restoration. The project scope will vary from street to street (see attached sheet for list of streets).

Starting Monday April 29th, the Village's contractor, Schroeder Asphalt Services (Schroeder), is scheduled to saw cut curb for all locations. Curb removals are scheduled to start Tuesday April 30th on North and East sides of streets. For residents whose driveway access will be affected, Schroeder will be providing temporary access once the curb is removed. Schroeder is scheduled to pour new curb on Thursday May 2nd. Any resident with affected access must have any needed vehicles out of the driveway before 7 A.M. on May 2nd. Curb removals on the South and West sides of the street are scheduled on Monday May 13th followed by curbs scheduled to be poured on Wednesday May 15th with needed vehicles again out of driveways. All work is weather and schedule dependent.

Curb and sidewalk removals for South Bodin Street are scheduled on Monday May 20th followed by curb and sidewalk scheduled to be poured on Tuesday May 21st. Temporary overnight parking for all locations are also attached, and all work is weather and schedule dependent.

Once street resurfacing dates have been set, residents will be notified in advance.

The Village will provide prompt project updates to residents within the project limits. These notices will provide progress information related to **potential water main shutdowns, street closings, and property access**. Notices of **major** activities will be posted on the Village website.

*Resurfacing Projects include: Curb & Gutter Repairs, Driveway Apron Patching (at curb repair locations), ADA Sidewalk Replacement, Pavement Patching, Manhole Adjustments, Asphalt Removal (Milling) & Resurfacing, and Parkway Restoration.

The contractor will repair all parkway sprinkler systems damages. Please coordinate with your sprinkler service to locate and mark ALL sprinkler heads. The contractor will take measures to protect the systems. However, the contractor is responsible for repairing all damages.
