Ordinance Approving a Major Adjustment to a Planned Development for Façade Changes at 10 N. Washington Street (O2012-04)

Mr. Mitch Hamblet, owner of Eden Assisted Living, spoke to the Board explaining they are seeking adjustments to the façade of the building due to the to light and air requirements in the building code. They are raising the windows and adding a limestone header. Also, they are installing an accessibility elevator in the back of the building in the most discreet place and will use the brick from the townhomes when they are demolished. New windows will be added on the front elevation and the air-conditioners will be relocated. He noted that the townhomes will be removed

in March or April, depending on the weather; only the interior has been demolished to date.

Trustee Saigh moved to approve an **Ordinance Approving a Major Adjustment to a Planned Development for Façade Changes at 10 N. Washington Street.** Trustee Haarlow seconded the motion.

Ordinance Allowing the Installation of Multi-way Stop Signs at the Intersection of Garfield and First Streets (O2012-06)

Trustee Geoga began discussion stating that the Village has gotten a lot of benefit from dealing with stop signs on an objective, discretionary basis. He stated, in terms of sight obstruction, this is a wide open intersection, and believes the real problem is illegally parked delivery vehicles. He questioned why the law is not enforced regarding these vehicles; trucks should not be allowed to double-park on First or Garfield Streets. He does not want to install stop signs when the criterion for installation is not met. He is worried about precedent and it seems there is another alternative.

Trustee LaPlaca pointed out there are stop signs on both intersections one block away on either side of this intersection and noted that this matter has been prompted because of a boy who was hit by a vehicle. She doesn't think a stop sign will stop people from going around a car waiting for a train or a light. This may respond to residents' concerns, but may create others.

Chief Bloom responded to Board concerns by referencing a diagram of the intersection and explaining that the dentist at that intersection has complained about the increased pedestrian traffic due to Dips and Dogs. Following the accident, the police did a full review. Chief Bloom illustrated how the accident occurred and explained that this is a line of sight issue. Trustee Geoga reiterated his concerns about the illegally parked trucks. Chief Bloom responded that he would have to look hard to see if it is possible, with all the truck traffic, not to use Garfield and First to park. He said that the accidents and number of cars don't warrant the signs, but pedestrian traffic warrants the signs and line of sight issues apply. He believes it meets the warrants for a stop sign and it will address and promote the safety issue at this corner. Trustee Geoga said he would support the Chief, but urged him to manage the truck issue.

Trustee LaPlaca commented that installation of these signs will prevent the backup that currently occurs on First Street. Trustees Angelo and Elder expressed concern regarding pedestrian safety. Trustee Elder reiterated that the trucks are a problem. President Cauley is concerned that if we are more subjective with this installation we may set an unwelcome precedent, however, he will always defer to the police's opinion about public safety. Chief Bloom said the MUTCD warrants are met and the intersection will be appreciably safer. Trustee Saigh remarked that he had reservations initially, but became convinced by Chief Bloom's presentation at Committee; there have been changes in the intersection and the downtown and believes this is a unique situation.

Trustee Saigh moved to approve an **Ordinance Allowing the Installation of Multi-way Stop Signs at the Intersection of Garfield and First Streets**. Trustee Elder seconded the motion.

Adopt the Village of Hinsdale Vehicle Policy and Procedure

President Cauley introduced the item explaining the Board has reexamined the use of Village vehicles and have determined to restrict the number of take home vehicles. The

Village Managers vehicle is in his contract, the police and fire chiefs, as well as the on call public services person. Those individuals that were promised a vehicle as part of their compensation will receive a monthly compensation moving forward. As new staff is hired, the vehicle allowance will be phased out. The financial impact will be negligible the first year, but will result in cost savings moving forward. This will put the Village in a better position to monitor use of Village property. Trustee LaPlaca noted the new policy eliminates the opportunity of misuse of fuel service by employees. Trustee Haarlow noted that there is no evidence of any misuse; this is a forward looking move. President Cauley reiterated there is no evidence of misuse by anyone. Trustee Elder moved to **Adopt the Village of Hinsdale Vehicle Policy and Procedure**. Trustee Haarlow seconded the motion.

RE: Graue Mill Flood Control Grant Application

Following the devastating floods in July 2010, the Graue Mill Home Owners Association (HOA) has been working with their consultant, Christopher B. Burke Engineering, Ltd., and DuPage County to develop a grant application to the Federal Emergency Management Administration (FEMA) for the design and construction of flood control measures in/around the Graue Mill area. The engineer's estimate for the design and construction of this project is \$1,929,731.00. The FEMA grant would be for 75% of the project cost with the remaining 25% being paid by local sources. The original deadline for this grant application was June 2012.

On January 30, 2011, the HOA was notified that federal funds have become available for an earlier grant which has an application deadline of February 8, 2012. The HOA has obtained a commitment from Mr. Jim Zay, County Board Member and Chairman of the DuPage County Stormwater Committee, (attached) that the county would provide 75% of the local contribution. The HOA will have a special board meeting on February 6 to approve a commitment of 5% of the local contribution. The HOA is requesting that the Village provide a financial commitment of the remaining 20% of the local contribution (see below). Since the FEMA grant application must be made by a unit of local government, the HOA is also requesting that the Village submit the grant application.

Request for Graue Mill Mitigation Funding Support

Lawrence Klinger and Thomas Burke, Ph.D.

On July 24, 2010 the Northeast portion of Hinsdale received 7.5 inches of rain in a short time and a fairly concentrated area. The Salt Creek overflowed its banks from the York Road bridge east to the 294 Interstate.

The Graue Mill Community which has the Salt Creek on its South and East borders suffered significant damages including –

- 17 Villas Totaled with 12 to 16 inches of water inside

- 40 cars Totaled

- Many cars damaged

- Water from 18 inches to 3+ feet in the street

- Evacuation by the Hinsdale Fire Dept.

- Electricity out for 7 days in the 4 story buildings and 3 days out elsewhere

- Telephones out for 3 days

State Representative Patti Bellock and Dave Cook were on site to help with the evacuation. Representative Bellock organized a meeting with representatives of the appropriate local, county and state agencies plus FEMA and Com Ed. Over the past 18 months we have had full participation and assistance from her office, Dave Cook, Congresswoman Biggert, State Senator Dillard, the County Board, the County Stormwater Management Staff, Flagg Creek Water Reclamation District and the County Forest Preserve District.

We contracted with the Christopher B. Burke Engineering, Ltd. Company (CBBEL) who completed a quick concept review of our situation followed by an indepth study with recommendations for action. An Intergovernmental Agreement, IGA, was developed with financial participation by the County, 75%, Hinsdale, 20% and Graue Mill, 5% Thomas will review the results of their study.

On August 26, 2011 we submitted a Pre-Application for a FEMA Hazard Mitigation Grant. After review by FEMA we were requested to submit a Full Application for a Grant which would be closed for applications on June 1, 2012 and from which FEMA could fund up to 75% of the project cost with the remainder 25% coming from local, non-federal funds –

Total Project Cost	\$1,929,731
FEMA	1,447,298
Local Share	482,433

Since FEMA only deals with government entities, Dave Cook agreed to be our local representative for submission of the application. On January 26th, Thomas Burke was contacted by Ron Davis, Director of Illinois FEMA regarding an opportunity to move up our filing date to February 8, 2010 when our chances of being funded were much better. The County Forest Preserve District also informed us at this time they would not charge us for the 7.5 acre feet of dirt we will remove from their property.

On January 31, 2012 we were informed by Jim Zay, Chairman of the DPC Stormwater Management Committee that Chairman Cronin supports our request at the 75% level. The County suggested using the former share percentages – 75% County, 20% Hinsdale and 5%, Graue Mill. On February 6th, our Homeowners Board is holding a special meeting of all owners to obtain approval for funding the Flood Mitigation Project.

We understand the concern expressed by some that the owners of the property were only paying 5%, \$24,100 for this project. Rest assured that since the day of the flood, owners have been paying funds to correct the problems. The first major problems which needed to be addressed immediately exceeded \$2 million, with no participation other than the owners. Another thing to keep in mind is that this is a 16 month project with the heaviest expenses during the final 5 months of construction.

The Owners of Graue Mill pay the same taxes and fees as other Homeowners in Hinsdale. Ogden Avenue is a false border. We are active in the Hinsdale community, shop in its stores and welcomed Mr. Cauley and Cook to a meeting of our Board to request support of the recent sales tax increase. If you have never visited Graue Mill, please call me and be my guest. We now ask your support of our effort to control any future flooding of our community.
