Hearing Procedure

1. Opening of hearing by Chairman
2. Incorporation in record of Notice of Hearing, together with certificates of publication
3. Statements of Chairman summarizing petition
4. Taking appearance of counsel (1)
5. Opening statement, if any
6. Presentation of direct case of petition, cross examination of petitioner's witnesses to follow direct examination
7. Statements, if any, of persons in favor or petitioner's request (2)
8. Presentation of objector's or other cases, cross examination of objector's witnesses to follow direct examination (2)
9. Statement, if any, of persons against the petitioner's proposal
10. Adjournment

(1) This policy is particularly important as it applies to attorneys and other branches of local government. No communication will be accepted from any attorney, consistent with the Rules of the Illinois Supreme Court, the First Judicial Circuit, the Eighteenth Judicial Circuit, the Illinois Rules of Professional Conduct and the Illinois Administrative Law Act, unless first the attorney has filed an Appearance before this body identifying the matter before this Board in which the attorney is representing a party of record. No telephone contact with any member of this Board shall be made unless all parties or the attorney who has filed an appearance on their behalf participates.

(2) Illinois Code of Civil Procedure ILCS:5/8-701 Broadcast or televised testimony. No witness shall be compelled to testify in any proceeding conducted by a court, commission, administrative agency or other tribunal in this State if any portion of his or her testimony is to be broadcast or televised or if motion pictures are to be taken of him or her while he or she is testifying.
