About The Data

The information presented in this report is derived from various sources.

Demographics information was provided by the United State Department of Commerce Census Bureau. The 2010 Population and Housing Decennial Census is the source for data represented at the City Ward level. The data was accessed and processed through the Missouri Census Data Center, http://mcdc.missouri.edu/. Since this information is provided the census block level, it is easily aggregated up to ward boundaries, in order to provide a better understanding or our community.

The American Community Survey (ACS), an ongoing Census Bureau survey that samples a small percentage of the population every year and released in 1,3, and 5 year estimate periods provides data historically collected in the Census Long Form, last conducted in 2010. All ACS data in this report is from the 2006-2010 5 year estimate which is provided in smaller units of geography than the 1 and 3 year estimates. The data was accessed at http://factfinder2.census.gov/faces/nav/jsf/pages/index.xhtml and via the use of a Census Bureau provided Excel Macro tool designed to extract lower level demographics, http://www2.census.gov/acs2011 1yr/summaryfile/UserTools/. Due to the sampling and production of estimates and margin of errors, this data is represented in the lowest level of geography and does not match up to ward boundaries. The maps for these sets of data are for general representation purposes only and data in the tables should be considered more authoritative.

Some employment and transportation related statistics are provided by a joint effort between the US Census Bureau, Bureau of Labor Statistics Office of Personnel Management and State of Missouri via a system referred as the Longitudinal Employer-Household Dynamics project, http://lehd.ces.census.gov/. A slight narrative has been provided to help interpret this set of data. The State of Missouri also provided employment date regarding their employees.

Real Estate assessment and appraisal information was provided by the Cole County Assessor and accessed through the city's internal geographic information system.

Migration data for the United States are based on year-to-year address changes reported on individual income tax returns filed with the IRS. The data present migration patterns by state or by county for the entire United States and are available for inflows—the number of new residents who moved to a county or state and where they migrated from, and outflows—the number of residents leaving a county or state and where they went. 



Employee Origins

The 'All Wards Combined' section of table below shows the origin of workers, by county, with primary jobs in the City of Jefferson. Cole County residents, including city residents, hold 20,195 of the 48,119 jobs (42%). Subtracting city residents working within the city from county residents working within the city (20,195 - 10,842 = 9,353), shows that slightly more than half (54%) of the Cole County residents working in the City of Jefferson are residents of the city.

Behind Cole County, Callaway County residents make up the next largest number of workers in the city. Slightly edging out other surrounding counties, Boone, Osage, Moniteau, and Miller counties, Callaway County provides 3,895 workers or 8.1% of the city workforce.



Daytime Population

The US Census Bureau suggests two methods for calculating daytime populations. Using the information provided previously in this document, both methods calculate daytime population for the City of Jefferson to be 73,893.

Method 1: Total resident population + (total workers working in area - workers who lived and worked in same area) - (total workers living in area - workers who lived and worked in same area) = Daytime Population, or 43,079 + (48,119 - 10,842) - (17,304 - 10,842) = 73,893.

Method 2: Total resident population + Total workers working in area - Total workers living in area = Daytime Population, or 43,079 + 48,119 - 17,304 = 73,893.

Employment Center

Ward 2 covers the central business district including many state office buildings. With the highest number of primary jobs in the city, 17,403 of 48,119 or more than 36%, Ward 2 has almost twice the number of primary jobs as the highest ranking ward, Ward 4 with 9,826 primary jobs. Ward 2 also has the lowest rate (3.9%) of persons both residing and working in the same ward. Ward 2 can be considered the major employment destination within the city.

Ward 5 has the smallest number of primary jobs, 4,589 and the highest rate (5.7%) of persons residing and working in the same ward.
