WHEREAS, funds have been allocated in the Louisville Metro Housing
Authority's Program Income to upgrade and expand alarm system, and access
control/doors at Mabel Wiggins Center and Liberty Green Community Center; and

WHEREAS, there continues to be concern by LMHA staff, city officials, and residents regarding incidents of criminal activity and security at the above locations. Current access control systems/doors and alarm systems are antiquated and no longer offer compatibility and LMHA system integration; and

WHEREAS, Advanced Digital Solutions, LLC was awarded the Commonwealth of Kentucky State contract after Competitive Sealed Bidding for security equipment, installation and maintenance on September 1, 2020 and expires August 31, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE LOUISVILLE METRO HOUSING AUTHORITY BOARD OF COMMISSIONERS, that the Executive Director and Contracting Officer, Lisa Osanka, is hereby authorized to issue a contract to Advanced Digital Solutions, LLC. in the amount of \$52,533.75 for Alarm Systems and Access Control Systems/Doors at the Mabel Wiggins Center and Liberty Green Community Center sites.

I. <u>STATEMENT OF FACTS:</u>

Mabel Wiggins Center and Liberty Green Community Center sites are utilized by approximately 3,500 visitors per year, 13 LMHA staff members as well as approximately 50 Urban Strategies and Neighborhood Place members. The LMHA properties are often utilized for special programs, training, and Urban Strategies and Neighborhood Place programs. Safety and Investigations directs and coordinates the security initiatives of the LMHA and monitors the daily operations of the contracted security teams working within the LMHA. To effectively perform these operations at the properties, Alarm Systems, and Access Control Systems/Doors as necessary to enhance the basic safety and security of the LMHA residents and staff. The new systems will effectively address liability concerns and aid in various investigations and incident inquiries. The current system remains antiquated and in dire need of upgrade to ensure that critical areas of concern are effectively monitored and archived. The system includes all materials necessary to complete the work as agreed, training, factory warranty's, and all associated labor and service charges.
