Others present: James Arnold of Madison County Community Development, Bill Ferris of Marine, Kevin Brown and Kyle Schmidt of CARD, Ben Motil of Pontoon Beach, Danny Lawrence and David Coody of Glen Carbon

Mr. Goggin opened the meeting. He then asked for approval of the minutes from the December meeting. Ms. Tracy made the motion to approve the minutes with a second from Mr. Rosen. All in favor; minutes approved.

Mr. Arnold gave the financial report. The beginning balance of the year (12/1/2015) was \$2,405,165.16; the total revenue to date is \$186,827.86 from sales tax revenue and investments. The total expenses to date are \$267,382.87. The current balance in the PEP account is \$2,324,610.15. There is \$66,093.12 encumbered (2014 PEP). There is \$673,520.58 encumbered (2015 PEP). The available balance is \$1,534,189.04.

Mr. Arnold reported on the PEP Revolving Loan Fund that there was as of 12/1/2015 a balance of \$1,018,119.89. Revenue to date is \$20,257.93 from loan repayments and interest from investments. Expenses from the loans during this period are \$0.00. The PEP Loan Fund balance as of 2/2/2016 is \$1,038,377.82. There are five encumbered loans (Livingston, Bethalto, Maryville, Venice, East Alton) totaling \$541,472.00. This leaves an available balance of \$390,975.82.

Special Requests for 2016 Funding Year:

- Highland, Mark Rosen: revegetate the area down the dam hill
- CARD, Kevin Brown, Kyle Schmidt: pave Arlington Golf course holes 1 and 2
- New Douglas: finish/complete inside of concession stand
- Marine, Bill Ferris: purchase new diesel mower
- Pontoon Beach, Ben Motil: seating for amphitheater
- Glen Carbon, David Coody and Danny Lawrence: purchase of new scag mower
- Alton: service road for bathhouse at Gordon Moore, maintenance road for Amphitheater, gut concession stand 1 and refinish, roof for Haskell House

Ms. Tracy made a motion in favor of the special requests with a second motion coming from Mr. Rosen. All were in favor, requests pass.

Discussion was had on increasing the dollar amount of small communities who do not meet the five dollar per capita. This issue will be addressed again in August of 2016. Watershed Cairns project was also brought up and agreed to a letter of support.

There being no further business, a motion to adjourn was made by Ms. Tracy with a second from Mr. Rosen. Meeting adjourned. The next meeting will be on Friday, March

4th, 2016 at 9:00 a.m. at Madison County Community Development, 130 Hillsboro Ave., Edwardsville, Illinois 62025.
