## Madison County Parks and Recreation Grants Commission Meeting Minutes

September 4<sup>th</sup>, 2015

Others present: James Arnold of Madison County Community, Ed Weilbacher and Laura Lyons of Heartland Conservancy

Mr. Goggin opened the meeting. He then asked for approval of the minutes from the August meeting. Ms. Tracy made the motion to approve the minutes with a second from Mr. Rosen. All in favor; minutes approved.

Mr. Arnold gave the financial report. The beginning balance of the year (12/1/2014) was \$2,584,783.98; the total revenue to date is \$659,474.40 from sales tax revenue and investments. The total expenses to date are \$840,669.46. The current balance in the PEP account is \$2,403,588.92. There is \$1,836.95 encumbered (2013 PEP). There is \$165,588.31 encumbered (2014 PEP). There is \$1,099,106.51 encumbered (2015 PEP). The available balance is \$1,114,804.10.

Mr. Arnold reported on the PEP Revolving Loan Fund that there was as of 12/1/2014 a balance of \$982,246.95. Revenue to date is \$60,183.72 from loan repayments and interest from investments. Expenses from the loans during this period are \$26,667.54. The PEP Loan Fund balance as of 8/27/2015 is \$1,015,763.13. There are four encumbered loans (Livingston, Bethalto, Maryville, Venice) totaling \$541,472.00. This leaves an available balance of \$474,291.13.

Alhambra requested that their 2015 funds be bumped up to \$15,000.00 which would be an increase in \$4,200.00 to their initial request of \$10,800.00. Ms. Tracy motioned in favor of the resolution with a second motion from Mr. Rosen. All were in favor, resolution passed.

Ed Weilbacher and Laura Lyons from Heartlands Conservancy put on a presentation in an effort to get Cahokia and the surrounding mounds designated as a national park. They wanted the Parks Commission to consider funding 25k to finance phase III of their project which would include national park designation. The commission turned down the idea due to the applicant not being eligible based on the PEP application. The commission also wanted Heartlands to reach out to Chouteau Township to see if they could work together using their PEP grant. The commission also recommended that Heartlands try another request with Planning and Development.

Mr. Arnold presented an idea for PEP project of the year. Mr. Arnold presented two big parks and three small parks. One of each were picked for the 2014 PEP Project of the Year. Granite City won the Big Park Award with a motion from Ms. Tracy and a second from Mr. Barnhart, Mr. Rosen and Mr. Goggin were in favor, Mr. Parente abstained.

Livingston won the Small Park Award for work at their basketball court with a motion from Mr. Rosen and a second from Mr. Parente, Mr. Barnhart and Mr. Goggin were in favor, Ms. Tracy abstained.

There being no further business, a motion to adjourn was made by Ms. Tracy with a second from Mr. Parente. Meeting adjourned. The next meeting will be on Friday, October 2<sup>nd</sup>, 2015 at 9:00 a.m. at Madison County Community Development, 130 Hillsboro Ave., Edwardsville, Illinois 62025.
