Mr. Goggin opened the meeting. He then asked for approval of the minutes from the March meeting. Ms. Tracy made the motion to approve the minutes with a second from Mr. Rosen. All in favor; minutes approved.

Mr. Arnold gave the financial report. The beginning balance of the year (12/1/2014) was \$2,584,783.98; the total revenue to date is \$560,523.42 from sales tax revenue and investments. The total expenses to date are \$782,347.81. The current balance in the PEP account is \$2,362,959.59. There is \$1,836.95 encumbered (2013 PEP). There is \$176,422.75 encumbered (2014 PEP). There is \$1,144,742.61 encumbered (2015 PEP). The available balance is \$1,015,853.12.

Mr. Arnold reported on the PEP Revolving Loan Fund that there was as of 12/1/2014 a balance of \$982,246.95. Revenue to date is \$41,338.36 from loan repayments and interest from investments. Expenses from the loans during this period are \$26,667.54. The PEP Loan Fund balance as of 8/6/2015 is \$996,917.77. There are four encumbered loans (Livingston, Bethalto, Maryville, Venice) totaling \$541,472.00. This leaves an available balance of \$455,445.77.

Edwardsville Parks and Recreation made a request for an extension until October 30, 2015 in order to finish their 2014 PEP grant trails down at the Watershed. Mr. Rosen motioned in favor with a second motion from Ms. Tracy.

Alhambra requested that their 2015 funds be bumped up to \$15,000.00 which would be an increase in \$4,200.00 to their initial request of \$10,800.00. The committee requests a letter stating why they need more money for a mower purchase. Mr. Parente motioned in favor of the request with a second motion from Ms. Tracy contingent upon the letter documenting the request comes in.

Mr. Arnold presented an idea for PEP project of the year. The committee entertained the idea and would like options at the September meeting.

There being no further business, a motion to adjourn was made by Ms. Tracy with a second from Mr. Parente. Meeting adjourned. The next meeting will be on Friday, September 4th, 2015 at 9:00 a.m. at Madison County Community Development, 130 Hillsboro Ave., Edwardsville, Illinois 62025.

Proposal to Madison County, IL: Establishment of the First and Only National Historical Park and/or National Monument in Southern Illinois – Cahokia Mounds and Thematically-connected Satellite Mississippian Culture Sites

OVERVIEW: Over 563 mounds have been documented in the St. Louis region, once connected through trade, trails, and culture to Cahokia and to the Mississippians it was the "Center of the Universe". Furthermore, Madison County, Illinois is home to the largest earthen man-made mound in North America—Monks Mound. It ranks highest in significance along with the Great Pyramids of Egypt and the Mayan ruins in Mexico and yet it is not part of our National Park system, unlike less significant mounds throughout the country.

Since 2013, HeartLands Conservancy prepared a feasibility study (including an Economic Study by Development Strategies) that makes the case for the establishment of National Historical Park and/or National Monument honoring the Mississippian Culture that once thrived in our region. After many public meetings, surveys, and outreach efforts to the archaeological, civic, business, and Indian tribal leaders, tremendous public support for this effort has been documented in participation, social media, and letters.

HeartLands Conservancy continues to lead this effort through the establishment of a noncontiguous National Historical Park and/or National Monument that would thematically connect Cahokia Mounds (a national landmark, state historic and UNESCO World Heritage Site) with other significant mound sites in the region. Establishment of such a park/monument adds to the economic vitality of the region and provides for National recognition for a world significant cultural feature and puts the region including Madison Co. on the world stage. Opportunities like this do not present themselves often and we have a unique window of opportunity to establish the first National Historical Park and/or National Monument in Southern Illinois. (see attached Feasibility Study and Economic Study).

Parks come in all shapes and sizes and serve many audiences. Madison County is uniquely positioned to have a world class national monument and/or historical park that will benefit local residents while at the same time being able to add to the tourism opportunities that will benefit the local businesses such as restaurants and hotels and motels not to mention the other dollars that are spent in the region as a result of an additional stay. Madison Co. will benefit from another park without the burden of operating and maintaining another park. The opportunity exists to link the vast network of trails in Madison County to these cultural sites and to encourage visitors to get out and explore the wonders of Madison County.

HeartLands Conservancy has been leading the effort to gain this designation for the region and ensure that is owned and managed by local, state, and federal agencies also spreads the costs and benefits of offering such facilities in the region. In order to continue our tasks to establish a National Historical Park and/or National Monument that would include Cahokia Mounds State Historic Site (including Monks

Mound), a few select others in the region and the interpretation of Mitchell as well as other mound sites in Madison County, we are in need of support to move this effort to completion.

BACKGROUND: We could not have achieved so much, by so few, in such a short amount of time without the support of the region's communities and generous donors. As Heartland Conservancy stated when the Mounds Project Team undertook this effort, this is a world class resource worthy of national recognition and that the effort will be daunting, but achievable. The large community outreach, individual letters of support, and social media call for this elevated National Park Service designation and feel it is very much overdue. We are very close to seeing the completion of what we set out to do 3 1/2 years ago. When the entire initiative is complete, its success will ensure that the epicenter of America's pre-Columbian Mississippian civilization will be protected. It will secure the story of our ancient heartlands both built and unbuilt - to be shared within our community and with our global neighbors. This is a winwin for the region, Illinois, and the story of our national contribution.

Throughout the history of humankind, certain episodes and events stand out as particularly important in the evolution of societies - human adaptations, social organization or cultural fluorescence. Students of world archaeology easily recognize the importance of the Ancient Civilizations of the Near East, Egypt, Greece, Rome and China. When attention is turned to the western hemisphere, great achievements in the archaeological record are often limited to the Inca, the Maya and the Aztecs. In North America four archaeological complexes stand out: Poverty Point (Louisiana), Hopewell Culture (Ohio), Chaco Canyon (New Mexico), and Cahokia Mounds (southwestern Illinois).

This area, the American Bottom and along the Mississippi River was the first known organized settlement, agriculture, and government north of Mexico at that time. Some of the mounds built between AD 1000-1400 stand as earthen monuments and remnants of Mississippian - North America's greatest ancient culture and ancestral to many of today's great Indian nations. Southwestern Illinois represents one of the most important cultural landscapes of this ancient continent. The two largest Mississippian Mound Cities were in our immediate region, situated at the country's crossroads along the Mississippi River: East St. Louis and Cahokia.

Our initial *The Mounds: America's First Cities Feasibility Study* was completed in early 2014 and has been fully vetted with agencies, legislators, community leaders, Native American Nations, the general public and extensively within the archeological community. Regarding successfulness: we have essentially achieved 100% support from all sectors for moving forward the recommendations provided within the report. The benefits of a national designation are plenty, and with collaboration with the Native American Tribes, partnerships with institutions and expanded outreach, implementation of the next steps is paramount. There is a groundswell of support to elevate Cahokia Mounds and thematically connected non-contiguous sites. There is a sense of healing the bond, land and the cultures who harken from or migrated though the fertile lands of the American Bottom.

The generous support of our funder's and partnering communities has been leveraged to expand the project team's ability to do the following over the last 5-6 months simultaneously, while achieving positive results thus far:

The Project Team's focus remains on simultaneous fundraising, growing support, and advancing the national designation; to that end, the team has been working with the assigned Technical Advisor from National Park Service (NPS) and congressional staff in Springfield and Washington DC on pursing both the National Monument designation through the Antiquities Act with President Obama as well as pursuing introducing a bill through Congress.

- The Mounds: America's First Cities Feasibility Study was awarded the OLGA Award for Leadership in Planning and Design Innovation. The Outstanding Achievement in Local Government awards, known by their acronym as the OLGAs, are presented yearly by East-West Gateway to the local governments or individuals who have demonstrated a special commitment to their community and the region.
- The National Park Service was in town May 6-8, 2015 with a team of specialists conducting the Reconnaissance Study of The Mounds as requested By Senator Durbin. With them was Tim Good, NPS (The Mounds Technical Adviser) and Bob Bryson, NPS- the Midwest Archaeology Center's Director. It was a positive visit. Our team will continue to implement the Next Steps and keep them apprised of any developments or provide data collected. This study should be completed within 12 months. In the meantime, the project team will continue to work with legislators and the community at large to move the project forward and towards the elevated national designation.
- O Current development pressure is threatening the integrity of the archeological record and footprint. During the construction of the Stan Musial Veterans Memorial Bridge, a major discovery uncovered a previously unknown Mississippian Village, culturally connected to Cahokia Mounds. This find will help to understand daily life and history of the Mississippian people. Since this significant find, there have been renewed calls for the establishment of the Mississippian Culture National Historical Park and/or Mississippian Culture National Monument inclusive of Cahokia Mounds. Pursing this site as a Welcome and Interpretive Center for Illinois, Mississippian Culture, Stockyards, and Transportation hub.
- Regarding successfulness: we have essentially achieved 100% support from all sectors for moving forward the recommendations provided within the report. The project also included: extensive mapping components, identifying 563+ locations of existing or previously destroyed sites: correlated cultural assets with the extensive natural assets found within this region: prioritized protection of multiple natural resources; and advanced community outreach and education about sites.
- Executive Order Legislation has been drafted and is being reviewed by staff; integrally, the Project
 Team are developing boundaries via GIS for the designation of multiple non-contiguous sites.
- o Protection of individual sites (ESTL) has been raised again with legislators and funders. We are seeking appropriate funding channels once again. This includes \$2-3 million for the East St. Louis mound site acquisition as a new site to interpret Native American arts, culture, and the history of settlement, as well as operating as a new gateway and welcome center for the state of Illinois.
- o Kept the communities, agencies, and legislators engaged and informed during Pullman's process of becoming a unit of the National Park Service (NPS). We re-engaged our timeline to take full strategic advantage of any opportunity that may arise. Our Technical Advisor from the National Park Service is still very confident in our recommendations and in our strategic approach. He says, "we are batting 1000".
- We received our second challenge grant from The Grand Victoria Foundation for \$50,000 if we raise \$150,000. These monies allowed the team to continue working on implementation whilst also fundraising to meet the challenge grant. We have met 100% of the first year's match of \$75,000. Madison County, The William A Kerr Foundation and The Crown Family, as well as other donors, enabled us to meet our challenge grant requirement through the Grand Victoria Foundation to receive the first payout of \$25,000. We have already begun fundraising in order to receive the second \$25,000 next year.
- We continue to apply for grants to organizations and foundation in both Illinois and Missouri. We have requests out to multiple foundations, private donors, and grant opportunities. We have found that that many Missouri funders are already committed to the CityArchRiver project in St. Louis.
- o Gained support from Native American Tribes and Nations, who ancestrally herald from here

(Absentee Shawnee Tribe - Shawnee, OK; Cherokee Nation - Tahlequah, OK; Chickasaw Nation - Ada, OK; Eastern Shawnee Tribe - Seneca, MO; Loyal Shawnee Cultural - White Oak, OK; Miami Tribe - Miami, OK; Osage Nation/Tribe - Pawhuska, OK; Ottawa Tribe - Miami, OK; Peoria Tribe - Miami, OK; Ponca Tribe - White Eagle/Red Rock, OK; and Quapaw Tribe - Miami, OK.), organizations and the archaeological communities. We continue to reach the diaspora through Facebook, social Media, and info tables.

- O To date the effort to elevate the National designation for the Mississippian Culture Historical Park and/or National Monument has developed GoFundMe crowdfunding online campaign raising \$1,135 from individuals at http://www.gofundme.com/The-Mounds, and achieved 3,153 Facebook followers https://www.facebook.com/TheMound, 940+ letters of support, 760 surveys, and many resolutions adopted. We encourage individuals to share and spread.
- Continued outreach to Illinois Historic Preservation Agency. IHPA has stated and will put into writing their support for this project.

ECONOMIC BENEFITS:

National Parks Conservation Association's "Made in America Report" states, America's national parks are huge economic generators for the local communities that surround them. In 2013, national parks were visited by more than 273 million people who supported nearly \$27 billion in economic activity and over 237,000 private-sector jobs. Each federal dollar invested in the National Park Service generates \$10 in economic activity, a tremendous return on investment to local economies. There is a clear and direct correlation between the establishment of a National Historical Park and/or National Monument to our local, regional and state economic benefits. During The Mounds — America's First Cities Feasibility Study, an economic feasibility report was completed by Development Strategies. It outlines a modest, yet robust outlook to our local economy, below.

Currently Cahokia Mounds State Historic Site generates:

- \$12.2 million in economic activity,
- \$3.4 million in household earnings and
- o 133 jobs are supported.

Elevated National Designation will increase visitorship to and viability of the site, thus the benefit to Metro-east is an additional:

- o Add +\$9 million in economic output,
- Add +\$2.2 million in household earnings and
- o add+101 direct and indirect jobs

The benefit to the St. Louis region, there is an additional:

- o add+\$12.6 million in economic output,
- o add+\$3.6 million in household earnings and
- add 131 direct/indirect jobs for the St. Louis metropolitan area.

The benefit to the State of Illinois, there is an additional:

- Add +\$16 million in economic output According to the 2013 National Park Visitor Spending Effects, National Resource Report, this would be 133% of Illinois' NPS visitor current spending effects of \$12 million (1 National Park Site – Lincoln Home).
- Add +\$4.7 million in household earnings and
- O Add +144 direct/indirect jobs for the St. Louis metropolitan area.

FUNDING REQUEST:

HeartLands Conservancy has now moved the Mounds Project Team forward with the implementation of the recommendations in the study. To support this effort and see the creation of a National Monument/National Historical Park for the Mississippian Culture, the Grand Victoria Foundation has, once again, stepped forward with another challenge grant of \$25,000 if the Mounds Project Team is able to match it and raise \$75,000. HeartLands Conservancy is seeking \$25,000 from Madison County to continue to support the establishment of this National Historical Park and/or National Monument. We will meet with St. Clair County and MEPRD to ask them to be equal in this ask to secure the challenge grant.

PROPOSED DELIVERABLES:

- Quarterly report on progress of attaining appropriate national designation for Cahokia Mounds as well as thematically connected, publically-owned, sites within the greater St. Louis region.
 - List of Presentations to bring awareness to the significance of the Mississippian Culture and provide an interactive forum for discussion;
 - List of Outreach with Information Tables, Presentations, & Exhibits (outreach opportunities, traditional and nontraditional venues and special events. Mobile exhibits placed in community venues, libraries, and schools, etc.);
 - Update on Funding;
 - Update on Legislative Outreach and Draft Legislation; and
 - Update on Project Timeline and developments.
 - o Update on The Native American Indian Tribes/Nations Outreach

Study Report to include:

- A parcel list of recommended tracts for inclusion in the national designation
- Develop MOU/MOAs to develop a diverse partnership, whose purpose shall be to provide technical leadership, to identify projects, and to leverage financial resources and focus public and private investment in a manner which best advances the initiative.
- o List of Potential Partners in recreation, educational, cultural institutions to develop interpretative, service teaming and programming opportunities.
- Develop priority linkages to other efforts to preserve and promote the Mississippian Culture along the Mississippi River and the Mississippi Watershed.
- Study on preferred sites (parcels) for opportunities for voluntary protection of remaining mound sites and/or future selected open space for interpretation of the Mounds; including lands in both public and private ownership.
