JOINT EXPLORATORY COMMITTEE

Overview

St. Clair Special Emergency Services and Madison County Technical Rescue Team would like to discuss the possibility of entering into an agreement to combine teams to form a single MABAS division that is capable of responding to larger events in Southwest Illinois. These discussions would require the overall approval of MABAS Illinois.

Logistics

Each team would maintain their individual identities and be the first level of response within their area of responsibility. This would include maintenance of their own equipment, vehicles, training records, etc. The combined MABAS asset would operate off an automatic aid agreement that would alert both teams for all emergencies through Active 911.

The combined team would need additional roster and training slots to ensure the team can maintain its ready status. Ideally, each team would have twenty roster slots and ten training slots, similar to an individual team. The combined team would then have forty roster slots with twenty training slots. The combination of the two teams would allow for a greater pool of individuals to become Technical Rescue assets within Illinois.

Positives

- Access to training roster slots supported by MABAS.
- Become a MABAS asset within Madison County.
- Call outs would now be covered by MABAS (Insurance/Overtime).
- Access to additional equipment, training opportunities, and trained personnel.
- Immediate “automatic aid” dispatched upon team activation.
- Greater community asset.

Negatives

- Additional cost for more team activations.
- Dilution of assets across a greater geographic area.

Team Leader Report

1 December 2022

Operations

For 2022 the team has received 11 requests for service. 3 of those were full team activations. The incidents include a structure fire that contained hazardous materials (2), spilled diesel fuel (2), a crude oil pipeline breach (1), an herbicide spill (1), sprinkler water threatening a water reactive chemical (1), battery acid leaking from an electric left (1), drums of corrosive liquid leaking (1), chlorine leak at a water treatment plant (1), tanker trailer overturned (1).

No injuries were reported. No vehicles were damaged.

MABAS is becoming strict on deployable teams having their personnel listed in the MABAS CIMS 3.0. We have to have 20 people on the deployable roster, or our team will be incrementally removed from MABAS support. I working on a way to access the list on CIMS to know who needs motivation to register.
