Special Revenue Fund - 020420-10-000 This account is held by the Madison County Treasurer’s Office and is used to pay operating expenses. Unspent monies from previous fiscal years are deposited and to be used, if needed, to supplement VACMC operations.	\$945,364.48
Busey Checking Account – 5401 (Petty Cash/Tax Fund) This account is reimbursable from VACMC Administrative and/or Aid-to-Vets accounts. This account is reportable yearly to the County as part of Fiscal Year Comprehensive Annual Financial Reports (CFAR).	\$1,404.29
Busey Checking Account – 6201 (Corporation Fund) This account is funded through private donations from various sources. These funds are typically used to purchase items not normally included in the annual VACMC operating budgets or as directed by those who donated.	\$6,145.97
