2020 CENSUS POPULATION FOR MFT

MUNICIPAL ENGINEERS / DIRECTORS OF PUBLIC WORKS / MAYORS / METROPOLITANPLANNING ORGANIZATIONS – DIRECTORS

The Illinois Department of Transportation (IDOT) has updated populations to reflect the 2020 Census as certified by the Illinois Secretary of State for State Motor Fuel Tax (MFT) allocations to municipalities. The September allotment, disbursed in October is the first to use the updated populations. As with past and present policy, there will be no retroactive changes made to previous allotments.

As a result of the challenges faced by the U.S. Census Bureau with the 2020 Census, there have been delays with the release of all information typically used by IDOT. The U.S. Census Bureau is still releasing additional data from the 2020 Census, including urban and rural designations, detailed demographic information, and reviewing unexpected census results.

JOSEPH FEYERBEND'S ADDRESS TO THE BOARD:

Hi, my name is Joseph Feyerabend with Denise Carroll, my wife. We're here on behalf of asking for a special use permit for chickens. We put in an application at the first board meeting, we were approved there. We did ask for a request for six chickens instead of five due to the fact that at any store Rural King, Farm and Home, you have to purchase the minimum of six. We weren't aware of that you had to have a special use permit for that. One of our neighbors out of spite, contacted and reported us but since then, we've been doing everything right to keep our chickens because fresh grown eggs are good. It's cheaper than going to the store and buying them and plus we were recently last year have a foster child with us and we want to teach him how to start your own homestead and stuff, grow your own vegetables, take care of your own animals and stuff like that. We're just asking if we could have approval for our chickens. We did recently rehouse one of them, so we are down to five chickens now within your guys ordinance. We were also informed by Eric Foster that if we were to get rid of one, that we would be accepted for our special use permit. The chickens are not loud. We don't have a rooster. The reason why we did get more chickens is because that's the minimum that you can buy and chickens don't lay eggs every single day, we might get

one to two eggs a day, but every day they're not laying eggs. So I mean with a family of four and two boys, they can eat us out real quick. We're just trying to teach our boys how to do things right. I attended a school in Sparta and did Future Farmers of America, so I know a lot about farming and growing your own crops and that kind of stuff. We do use their feces for our plants, because it's good for the soil, it makes the soil really good. We're just asking for acceptance for our special use permit to keep our chickens. We are down to five now in your guys ordinance. So if there's anything that we can do in order for this permit to be passed, we are willing to do that also.

Mr. Foster: For clarification, I did speak with this gentleman on the phone. I think he may have misinterpreted what I told him. I said if he reduced his amount of chickens to five, he would be in compliance. I never said it would allow for this ordinance to be passed.

Mr. Madison: Is Chris Doucleff here? Chris, could you come down and explain something to me? For everyone please? Sorry to put you on the spot, Chris. So my question is after hearing what we just heard from the speakers. And so everyone knows, the committee denied zoning resolution Z22-0071, the last one that we have listed, because it was a regular subdivision, apparently attracts some raccoons occasionally, which does make chickens loud when there's raccoons around. And raccoons do like chickens so the neighbor said it kind of smelled and it was kind of loud sometimes and it's in a regular subdivision with pretty small lots. My question for you, is it allowed in regular subdivisions or is there a certain square footage of lot because I don't remember.

Mr. Doucleff: It's not allowed in residentially zoned areas. It has to be a special use permit, and you can have up to five.

Mr. Madison: So you can have one with a special use permit in a residential, small, regular neighborhood?

Mr. Doucleff: Yes, and that's what they're applying for, the special use permit for up to five.

Mr. Madison: Thank you, I appreciate that.

Ms. Kuhn: Was the subdivision an association?

Mr. Doucleff: This is an area just north of Granite City city limits, and it's an established mature neighborhood there on Courtney Boulevard.

Ms. Kuhn: Is it just one neighbor complaining or a lot of people complaining? Because if it's just one neighbor...

Mr. Doucleff: We received a complaint from the neighbor, yes.

Ms. Kuhn: It's just one neighbor?

Mr. Madison: Next door neighbor.

Mr. Doucleff: The neighbor did complain and expressed her concerns about it.

Ms. Kuhn: Doesn't that make a difference? If it's just one person compared to if they have other people saying it's not a problem?

Mr. Madison: By state law in Illinois, the adjoining property owners have a legitimate say.

On the question:

Mr. Babcock: Is there precedent in our county for this and any other subdivisions that might be considered in a lawful manner as to why we're denying them versus why we're not denying somebody else that might have gotten it done? And maybe it might be the size of their property? I really don't know.

Mr. Doucleff: This is a normal city lot, it's not very big, and we did get a complaint from the one neighbor that was contiguous. And there's only probably two neighbors are contiguous.

Mr. Madison: In my time here, I've never seen this allowed on such a small lot, or even requested.

Mr. Doucleff: It usually depends on the situation itself, whether it's approved or denied, like the size of the lot.

Mr. Madison: It generally comes down to something the neighbors are complaining about if we deny something.

Ms. Harriss: So this is denied on two parts, right? My understanding they could have up to five chickens, right? But then, they also want a variance for the location...

Mr. Doucleff: The chicken coop and run. They're asking for a variance for that to be eight feet instead of the required twenty. They were asking originally for a variance to have, I think one or two extra chickens. I think they had seven chickens originally, they said they needed to buy six at the store and they bought an extra one I think, if I recall correctly. But I get from what they spoke this evening, they're down to five, which you still need a special use permit to have any number of chickens in the county, and our special use permit allows for up to five and you can ask for a variance for more though, that's what they did. But it sounds like they only are

asking for five now, but they're still asking for a variance for that chicken coop and run to be within eight feet from the property instead of the required twenty.

Ms. Kuhn: A yes is supporting them... no is supporting them...

Mr. Madison: Supports our denial.

Ms. Kuhn: Your denial, okay. So, are you saying then that they could have had five chickens?

Mr. Doucleff: No, you can't have any chickens and unincorporated Madison County without a special use permit. Excuse me, to redress Erica's question, it was eight feet from the east property line and five feet they're asking for the north property line. So it's pretty close there. The normal requirement is 20 feet, so they're asking for the variance.

Mr. Goggin: About the five chickens versus the seven chickens, the resolution before us says seven so if they show up tonight saying they want five, that's cool, but what we're voting on says seven unless someone amends this.

Mr. Doucleff: Its two separate things. One is a special use permit to even be allowed to have five chickens, and a variance to have seven. That's one of the variances to have more than five. The other variance was for the run and coop.

Mr. Foster: I'm confused, do we currently have a special use permit that allows the five, or are they applying for that also?

Mr. Doucleff: They're applying for this special use permit just to have five chickens and a variance to have two more, but it sounds like they're only having five now.

Mr. Madison: And a variance to move closer than allowed.

Mr. Doucleff: Twenty, that allowed the coop and run to be eight and five feet from the boundaries.

Mr. Holliday: I'd like to know why they want to have the smaller amount from the edges, if they can expound on that. I want to know why.

Ms. Doucleff: If we take a look at the map, their lot size is very very small. It looks as if their lot is 90x37. So I'm guessing that is probably why they want the variance to be closer to the fence.

Mr. Madison: It may possibly be because it's already there.

Mr. Doucleff: This was brought to our attention because it was a violation. We did receive a complaint about the property.

Ms. Kuhn: Are the chickens going in the other people's yard?

Mr. Doucleff: No, that wouldn't be allowed. There's no free range chickens allowed. They'd have to be contained within their yard still.

BE IT FURTHER RESOLVED, that only those operations as listed and described on the approved Estimate of Maintenance Costs, including supplemental or revised estimates approved in connection with this resolution, are eligible for maintenance with Motor Fuel Tax funds during the period as specified above.

BE IT FURTHER RESOLVED, that <u>County</u> of <u>Madison</u> shall submit within three months after the end of the maintenance period as stated above, to the Department of Transportation, on forms available from the Department, a certified statement showing expenditures and the balances remaining in the funds authorized for expenditure by the Department under this appropriation, and

BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit four (4) certified originals of this resolution to the district office of the Department of Transportation.

NEW BUSINESS:

Mr. Foster: Thank you, Mr. Chairman. As you remember in September, the Finance Committee provided you a platform to discuss the auditor rotation, and you appeared at that meeting, and you brought us a handout, and we discussed that handout briefly because you said you were unprepared, which is fine. But in your one of your recent mailings, you said you've been working on this since 2017. And I thought it was odd that you came to that meeting unprepared. But at that meeting, I asked you three times what would be the proper amount of time to rotate auditors and you and I agreed that three to five years was probably a relative term, but you were happy with no longer than five years. But three was probably a good time to start looking at auditors.

Mr. Prenzler: Actually, I've always thought in terms of five or six years. That's what I've heard from most counties that I've spoken to. One county said that they thought every seven years, but mostly every five or six years. But yes, I favor auditor rotation, regular auditor rotation.

Mr. Foster: Okay, well, you might understand the risk of confusion created with you bringing this auditor rotation to the county board, because at the time this was going on, myself and other board members were in dialogue with another district, a fire district, where you were chastising the board for rotating auditors. And we asked, well, how long have you had this auditing firm? He said, well, it's in our fourth year. So that created some confusion why he would bring it to us to rotate auditors every four years.

Mr. Prenzler: I was not chastising a fire district for rotating auditors.

Mr. Foster: Well, I'm sorry, Mr. Chairman, but I wasn't the only one in on the conversation. It was more than one person that reported this to us. So with this confusion, we did some investigation of where this confusion would lie. And the only thing we could find was the year that you appointed the new director to the Troy Fire Protection District was also the same year they chose this auditor. And I'm not here to discredit the individual that was the director or the auditing agency, but coincidentally, it was the same year that both individuals started donating to your campaign. So we looked into it a little further, and we found a distinct pattern between your donor list and your appointment list. As of October of last year, you brought a county

board appointment by the name of Wesley Paul Nicolussi. The following month after he failed, you brought his mother, we looked into that, that very same month, you received a \$300 contribution from him. And as early as of June of this year, June the 10th, to be exact, a person approached myself and other board members and said you personally called him on the phone and requested a donation because you had taken care of him on a committee. Now it appears that the longer and the more I looked...

Mr. Prenzler: Mr. Foster, I don't make conversations like that. I can tell you, I don't say things like that. I know.

Mr. Foster: Unfortunately, Mr. Prenzler, what you weren't aware of...

Mr. Prenzler: So if a person is making a complaint about something they should say it in public, and this should not be hearsay.

Mr. Foster: It wasn't hearsay sir, because the phone call that I'm referring to took place in Boulder Junction, Wisconsin. Now, you might be confused of why it would happen in Boulder junction, Wisconsin, because the person you called, happened to be an individual I was on a fishing trip with and you called at 7am in the morning while we were at breakfast. And while we're at breakfast, he put it on speakerphone.

Mr. Prenzler: You know, I remember that conversation and money was not discussed in that conversation, Mr. Foster.

Mr. Foster: I have three witnesses willing sign affidavits that say there...

Mr. Prenzler: Let them do it. Because I do remember that conversation and money was not discussed.

Mr. Foster: So, having said that, and the more we look into your donor list and your appointment list and that correlation, I am directing or asking the state's attorney to advise this board of what we need to do to begin an investigation to whether there is a pay to play a political scheme going on with Mr. Prenzler's campaign.

Mr. Prenzler: I think what you're doing, Mr. Foster, if this gentleman that you're talking about he should be willing to come forward and make the complaint himself.

Mr. Foster: Mr. Prenzler, he has come forward. He's come forward to several board members.

Mr. Prenzler: Did he do it in writing?

Mr. Foster: He's going to do it in writing.

Mr. Prenzler: Very good, let him do it.

Mr. Foster: He's going to do that. I'm not finished yet.

Mr. Prenzler: Because I'm willing to match my credibility with this individual any day of the week.

Mr. Foster: Mr. Prenzler, I hope you're prepared to match your credibility because I have several people that you've done this with that is willing to sign affidavits. And we will be discussing this with the state's

attorney's office or whatever office we feel necessary to bring this to light because it seems as you like to say this is deja vu all over again except this time it's not Fred Bathon, this time it's Kurt Prenzler.

Mr. Prenzler: Very good, Mr. Foster.

Mr. Foster: So I'm directing the state's attorney either to prepare whatever documents necessary to start this investigation or to advise the board of what is necessary to get this investigation started. There's just a lot of coincidences going on between this donor list and this appointment list along with a lot of other positions.

Mr. Madison: Mr. Chairman, I have a question just for the room in general. I've been getting a lot of calls from people wanting to know and other board members have asked, as well as me. How is it a person that works for the county can also be a state senator in Illinois and do both of those jobs at the same time? I can tell you, that the county board job in little Madison County, takes a significant amount of my time, and it made my job suffer. And I worked for myself, so I can assure you that it made my job suffer. Now, I don't think it's fair to the taxpayers that were allowing that to happen. I don't know what the law is on that, but it seems to me that it shouldn't be right, where somebody can do a full time job and a part time job. And I've been seeing this individual going through the schools lately in the newspaper so we know that's during the day.

Mr. Prenzler: Is this a question that you would rather address to that individual or the superior to that individual?

Mr. Madison: Yeah, I guess so. Yeah.

Mr. Prenzler: So I mean, that individual that you're talking about does not work for a county board department, correct?

Mr. Madison: Correct.

Mr. Prenzler: So he works for another elected official, correct?

Mr. Madison: Correct.

Mr. Prenzler: Well, maybe that should be brought up with that elected official.

Mr. Madison: I think it should be, and I think we need to move quickly on it. Because I mean, this has been going on for a while, and I've been waiting for somebody to say you can't do this. Nobody has.

Mr. Prenzler: Very good.

Mr. Eaker: A long time, I've been asking questions on this for the last two months and everybody keeps telling me because they're out of session, it's okay for him to do it. But it doesn't make sense.

Mr. Prenzler: Well, I guess the question is, who should this question be brought to?

Mr. Madison: Ms. Nielsen, could you look into seeing what the legality is in this?

Ms. Johnson-Nielsen: Thank you, Mr. Madison. We were asked about this situation and we did research this and provided answer. There is an AG opinion on point in the state of Illinois that allows this. In the future, when you have compatibility of office or position issues, I welcome any of the board members to contact our office. It's our job and responsibility to look into those AG opinions, there are a ton of them. Some of them are inconsistent, but there is one on point that allows that gentleman to run for office and also be a full time county employee at the specific department that we're talking about.

Mr. Madison: Thank you for that. You said that was an AG opinion. Is that opinion of theirs pointed towards an actual statute?

Ms. Johnson-Nielsen: It's not in a statute.

Mr. Madison: Case law?

Ms. Johnson-Nielsen: There's no case law on it.

Mr. Madison: So it's just an opinion?

Ms. Johnson-Nielsen: The authority comes solely from the AG's opinion that we were able to find.

Mr. Madison: Okay, thank you. I appreciate it.

Mr. Holliday: Thank you, Chairman. Tomorrow, I'll be chairing a summit about broadband in Springfield. Broadband is essential to fuller participation in modern life, as stated in the Infrastructure Investment and Jobs Act. The federal government is investing billions of dollars to help rural and underdeveloped communities to build and gain access to this infrastructure. This summit will offer local officials an opportunity to better understand the process, share experiences, and connect with federal, state and private resources to advance the process. I just hope that anyone in Madison County would look into broadband a little further.

Mr. Madison: In response to that, Doc, I'm glad you brought that up. I know under the ARPA funds we are using those to expand some broadband out of this area to branch out a little bit. We're working on that now.
