LESLIE KOTH'S ADDRESS TO THE BOARD

Thank you for allowing me to say a few words today. My name is Leslie Koth and this is my daughter Mia Koth. Mia has autism and she's a student at CA Henning Elementary. A few key points from my family stands on Mia possibly being forced to wear a mask in order to return to school this year. Mia has all the required vaccinations, physician, dentists appointments in order to attend public school. She has already had covid documented by the Health Department. Her immune system has already fought this virus with no issue. I am not willing to give my special needs daughter a vaccination with no long-term studies or complications and or risk versus benefit ratio. It's a fact that harmful side effects of these vaccines have not been thoroughly studied, and I'm not confident in giving this to my children yet. No way. As far as wearing the mask itself, Mia already has a hard time receiving social cues. She's a strong visual learner. She reacts and responds appropriately based on people's facial gestures. Having a mask on doesn't give her the opportunity to see facial responses and understand peer/teacher emotions and reactions thoroughly. These expressions are vital for her learning atmosphere and she definitely struggled this past year because of this. But I have to say what bothers me the most about the CDC stating vaccinated people have freedoms to not wear masks is a discriminating factor. It's generating rhetoric that vaccinated people are good, and us over here are bad. This is just separating us more as a community. Let's not bring that to our kids in school either.

I have advocated so hard for her for inclusion, and for her to be included in the general education population in the Illinois School District. It's disheartening for me to believe that Mia would not be given the same freedom as other children all because of a vaccine that she doesn't need and isn't even required to have in order to attend public school. I'm requesting that you support to not discriminate against those who choose to not vaccinate their children. It's not right. Let's start bringing these kids, teachers, and staff together instead of separating them. Thank you for listening.

ERIKA KOHOUTEK'S ADDRESS TO THE BOARD

Thank you for the opportunity to speak. I'm a Madison County resident and a mom of two children in the Edwardsville School District. My son is a vaccinated eighth grader. My daughter is nine years old and is unvaccinated. She is starting fourth grade this year. She's really excited to be in school. As many of you know, the vaccine is not available for children ages 2 to 11. The adults in my family are vaccinated, and we continue to wear our masks, as I'm doing today, indoors to protect my daughter from the virus and to protect ourselves from contracting the highly contagious Delta variant. We also wear our masks indoors to protect all of you and your kids. In case we are asymptomatic spreaders, we mask up for our family, we mask up for our community. Like all of you here, my family and my children want to get back to normal. Like most of you here, we don't like wearing masks either, and yet we do it. It is our family's duty. It is our civic duty. A few facts about the current covid landscape, currently, Madison County's vaccination rate is 43% 27 percentage points away from the vaccination goal of 70% set forth by the CDC. Zero to 11 year old children have a 0% vaccination rate. The recent rise of infections due to the Delta variant, and recently the CDC shared that the highly contagious Delta variant is making up over 80% of new infections, especially in our region. Madison County's current positivity rate is hovering at or above 8% daily over the last 10 days. And yesterday, the positivity rate was 8.4%. We're going the wrong way on this folks. Currently, we do not know the long-term impacts of covid on children. It is just now being studied. The NIH recently published that 13% of children have covid symptoms five weeks after infection. Who knows what longer-term impacts there are? Because of the current landscape, I am asking you to support the CDC, the IDPH, the Illinois Board of Education, and the American Academy of Pediatric guidance for upcoming school year. That masking be required for all students and staff regardless of vaccination status. This is the only way to ensure student, staff, family, and community safety and to minimize school disruptions. I recognize there is a push from some parents to stop the masking requirements for the upcoming school year. I believe we are all here trying to do what's best for our individual children. But instead we need to do what's best for our community. We need to remember what I do impacts others in our community. What you do impacts our community and me and my family. If nothing else, this virus has shown us that we are all interdependent.

NATASHA BOX'S ADDRESS TO THE BOARD

My name is Natasha Box. I'm here representing the Collinsville School District. We've been meeting with the school board for the last couple of meetings discussing this very thing. Over and over, we've heard from parents how mandated masking has affected their children's health, social and educational development, and even their desire to attend school. We've heard of children who have fought bacterial rashes from the masks, children who felt physically impaired by lack of oxygen, headaches, impaired ability to focus in class due to mask. Peer interaction and social development has stalled. We have heard from IEP families, IEP s are unique educational plans and involve children with developmental or learning delays who need extra support. I have one of those children. He's a super smart, funny, and caring nine year old boy whose intelligibility among peers is about 80%. This means the peers, which are both teachers and other students, struggle to understand his communication. From a young age, he was taught to model words, which means he watches mouths to learn to understand and form the words themselves. Once masked, his ability to

understand people is diminished. Once the educator's mouth is covered, it becomes a vicious game of telephone which nobody wins. Because of this, I had to pull my elementary aged children, not the oldest, from the district and homeschool them my son still receive speech through a zoom meeting, and his progress slowed dramatically. I spoke to several of the speech teachers within the district who told me of their struggle and inability to get the district to approve face shields for their speech students some of which are hearing impaired, they can't see mouths. This is a travesty. 15% of students in Illinois have IEP s. This means that these children who have to fight hard for benchmarks, have to fight even harder than others when the masks are on. Let's talk about the filled beds in St. Louis right now. Right now in St. Louis, there's a bed shortage at the Children's Hospital for children experiencing mental health crises. St. Louis Children's Hospital has seen a steep increase, about 50%, in pediatric patients a day. Many children having to wait in the ER for 24 hours for a bed to open up for them in the behavioral health unit. They are so full they had to expand to include another floor. What are these children in for? Thoughts of suicide, depression, anxiety, eating disorders, psychosis. We have created a mental health crisis among children and they deserve the right to have a more normal childhood. As parents, we've always worked to do what is best interest of our children and we need to return that children's health decisions to the parent. I'm not here to say all individuals should unmask. I'm merely stating it should be a personal choice. We do not discriminate against those who wish to continue masking. We understand that this is their freedom and we ask for the same respect. Why is this your problem? Well, we can't just leave it to the schools. In four weeks, is the first day of school and we do not know what it'll look like still. I have enrolled my children in good faith that the school board will make masking optional, but I still don't know their plan. Our superintendents and school boards waited for the ISBE and the IDPH to roll out their guidance for the year. Parents realize that should the state remove that local control, our schools will normally follow. This means you need to get involved as the county. Many of the schools in the county are still waiting for their school boards to make the return to learn decisions and submit them to the public. We the parents, and the faculty, are at their mercy, which directly involves our family and the quality of our lives. If the state removes local control, we'll be back in the same boat as we were last year.

THOMAS DEVORE'S ADDRESS TO THE BOARD

My name is Tom Devore, I'm an attorney here in the area, I live in Bond County. I was asked to come speak by a few parents, I was happy to do so. Isn't it ironic now that here at this point, we have local control, but we didn't have it a year ago. When you think about why that might be, I think some reasons will come to mind, but nonetheless, here we are. It's interesting, too, that we have people who have concerns about what will happen if a child catches the Coronavirus, even though the statistics show the chances are almost zero that they have any significant effects. But they're not just as concerned about taking a vaccine that really has no history. But you know, the times are crazy, that's for certain. A couple of things I wanted to point out, one of them having to do with this resolution that's being considered by the Board of Health. I think that resolution is significant because one of the things that does accurately say, is they have a role in advising school districts. In advising school districts, they advise on things of the status of the health of the people in the community. And in my opinion, on behalf of the people that I represent, this should be adopted. And what it does, it's taking the position inferentially, from my perspective, that there's not a local state of emergency as it relates to Coronavirus and the need to have masking of children because they're saying that masks aren't necessary, which I deduce from that that they believe it's not a sufficient emergency. The reason I think that's significant is because some of the history of our law in Illinois talking about a school district having the authority to create these condition precedent to letting your kid in the school it has to be predicated on an actual emergency in the community. Is there one or not? This resolution I would suggest, if passed, would suggest that there's not. The other thing I wanted to point out is the new ISBE resolution talks about in order for your kid to have to engage in remote learning and not otherwise be in school, there has to be no vaccine and an Order of Quarantine. If you read ISBE's resolution, it specifically says Order of Quarantine. It doesn't say phone call from the Health Department or the school nurse or the

superintendent that your kids quarantined, it says Order of Quarantine. That's an actual document, it's a legal document. And if you research 20 ILCS 2305, subsection C, of the Department of Health Act, an Order of Quarantine is a specific document. And in that document, the only way that a child or any citizen for that matter can be quarantined is consent of the parent, if they're a minor, or a court order from the court. That is the only two ways that can happen. So if ISBE is taking the position in their resolution, which they are, that your kid must be in that school unless no vaccine and an Order of Quarantine, it's conjunctive, it's even bolded in the "and". They have to have an Order of Quarantine. So the parents that I represent, I've told them if they're saying your kid can't come in the school, because of a quarantine, they better have a copy of an order from the Health Department. And the reason I think that's significant dimension here today, this is the Board of Health. They have employees at the Health Department that work for them. And if they want to quarantine your child, again, they have to have an Order of Quarantine and the parent has to sign off on it, which they could and maybe should under the right facts, or they have to have a court order. I think that's significant. It's something that parents should keep in mind, it's kind of independent of the mask issue. But it's certainly going to be a big issue as this year goes on. And again, going back just briefly as to the issue of the masking. Again, regardless of your personal beliefs, I hope that we can follow again, in some fashion, the Rule of Laws, we've moved on and this issue of this pandemic. And again, if there's a local emergency in this county, school districts do, in my opinion, I'm not advising this board, Mr. Haine and I've talked about that make, I make that clear. I'm just suggesting school districts, in my opinion, do have some discretion on a short term basis to deal with emergencies. But what those conditions are, have to be predicated on an emergency, you know, so kid can't come into the school unless they have a mask on, to me, that's medical intervention. Is it possible or not? Again, is there an emergency in that community? Who determines that? School Board Members? They're no more apt to do that than somebody like me. It's a Board of Health. So has the Board of Health taken a position that there's an emergency or not? It's my belief, that if this is passed, you can infer from it that it's not. Thank you very much.

The following resolution was submitted and read by Mr. Walters:

RESOLUTION ENCOURAGING PERSONAL CHOICE RELATING TO MASKS IN SCHOOLS

WHEREAS, as the Board of Health of Madison County we have a role in providing local guidance in regard to the public health crisis of COVID-19, and

WHEREAS, students residing in Madison County will soon return to school for in-person instruction and related activities for the 2021-2022 school year; and

WHEREAS, the Illinois State Board of Education has reportedly permitted local school districts to determine how to implement the CDC's Guidance for COVID-19 Prevention in K-12 Schools as adopted by the Illinois Department of Public Health, including whether to require the wearing of masks within school buildings; and

WHEREAS, while many local school districts are still determining how to proceed some have already determined that the wearing of masks in classrooms will be optional and, as one Superintendent of Schools stated, "The decision to wear a mask or not should lie with the individual..."; and

WHEREAS, the Board of Health recognizes that requiring children to wear masks can interfere with their education and ability to communicate with teachers and fellow students; and

WHEREAS, the Board of Health believes in the innate common sense, responsibility, and reasonableness of Madison County families and respects their desire to decide for themselves whether their students will wear masks at school depending on individual health and educational concerns; and

WHEREAS, many families have contacted members of the Board of Health and the Madison County Health Department seeking guidance on this important issue; and

WHEREAS, while the determination of whether masks will be required ultimately lies with local school boards we believe the Board of Health has a role in advising school districts on all decisions relating to public health.

NOW, THEREFORE, BE IT RESOLVED by the Board of Health of Madison County, Illinois, that all Boards of Education for school districts containing territory within Madison County are strongly encouraged to allow families the option of whether to have their students wear masks in school buildings and classrooms for the coming school year.

Mr. Madison moved, seconded by Mr. Ross to approve the resolution as presented.

On the question:

Mr. Madison: I was talking to the Chairman a few weeks ago, and we were talking, you know that the rules haven't come down from the state yet. Then last week, while we were deciding to work on a resolution to work on something towards this resolution. We weren't really sure what to put in it yet. And last week, the state granted that the local school districts would be able to choose for themselves what they were going to do locally, which we appreciated. But at the same time, when that came out, we started hearing from parents, and we've been hearing from them ever since. And what ended up happening was, it was kind of the first time I've ever seen something like that happen, is the parents started writing letters to us telling us what they wanted us to say. And we've worked on it since then. We've honed it down. We think this is very reasonable. It doesn't tell anyone what they must do. It recognizes people's own constitutional rights. It forces no one to do anything except let others decide. And one thing we have not heard anything about from government, from the CDC, is no one is talking about natural immunity from someone having had Covid-19. And there's been very brief discussions on it, I don't know of any studies. And I think before we decide to ignore people who have natural immunities, we don't even know, I don't even know in Madison County, what that percentage of the population is, but I know it has to be significantly high, because I received the hospital reports every day for you know, since covid started. And I know we had a lot of covid infections, so I know there are a lot of people with natural immunity. And they're also wondering the same thing that I just mentioned. So that's basically how this started, how it came to what it is today, and I'll let somebody else discuss it.

Mr. Holliday: Mr. Tom Haine, does the Madison County Board have the authority to mandate the wearing of masks?

Mr. Haine: Nothing in this resolution mandates anything. It's a non-binding resolution. But, you know, it stands and falls on the merits of all non-binding resolutions that the county board sees fit to pass for various reasons. They can be compelling on their own merits, and it can provide for a kind of moral authority, but they have no legal mandate attached to them.

Mr. Minner: I cannot support this. I have complete confidence in our Administrators, our School Board, and our Regional Superintendent of Schools. And I'm sure they will seek the advice of experts. I think they're well qualified to take care of this and I don't think we need any more politics in it. Thank you.

Ms. Dalton: I'm on the Institutions Committee, and our Superintendent of Schools for Madison County spoke to us last week, and informed us about the authority that the County Board or the Health Department, we do not have any authority over the school districts. The school districts are elected by the citizens in that area and they are the ones that make the rules and regulations and we have no authority over them. They have their legal counsel, consulting them constantly on state and federal levels so that they do everything that they are to conform to. We spent three days or more with one of our state's attorney people writing up this proposition or this resolution, which even if we voted in tonight means absolutely nothing. If we want to do something positive as a health board, that we should be helping the Health Board, bring people or help people to get out there and get vaccinated or whatever we can do to control the pandemic. But the school system is not anything that we have authority over. Thank you.

Ms. Pace: I'm voting in support of this resolution tonight. I and the vast majority of my district who have contacted me believe in the parent's right to choose if their child should wear a mask. Masks have been made optional in many other settings in our community, and I believe that we should not force this on the least vulnerable people or age groups to wear for several hours a day. This just negatively impacts them with their social interactions, their decreased learning abilities. I do believe in our teachers, and our school boards, and even the Regional Superintendent. However, I know that they are going to make the best choices and consider our best interest for our children. But at some time, they might have to, you know, based on the concrete data, they might have to give this guidance a change. But at this point, I feel that we need to put this decision back into the parents hands. Thank you.

Mr. Stoutenborough: I have read all of the, I think it's about 30 emails that have gone out, there's one thing I hope that we could all agree on, and that is we look forward to the day that no one has to wear a mask. Until we get to that point, right now, the cases are increasing, and this is basically on the variant Delta they're calling it. India also thought they didn't have to worry about it early, and now they are suffering immensely. And there are three new variants coming out of India, one is called Lambda that has already been identified in United States. The majority of the letters were addressed, I as a parent can take the risk for my child, I as a parent should be able to say what they do. I think that I will agree that they have that right to take the risk for their family, for their children, their parents, whoever, if a child comes home as possibly a carrier. They take that risk on their own family that's there. But I don't think they have the right, nor the responsibility to take that risk for the asthmatic child sitting in that class, for the diabetic, for the overweight, they say these kids are not subject or very prone to getting it. Well, if you've watched Fox News, St. Louis, locally, they had a parent sitting at the bedside of a 13 year old daughter on an inhibitor. and she's pleading, I didn't take it serious, and now I don't know whether she'll leave the hospital. It does happen. We do have carriers. So please, I think we ought to take that every child has the right to a free safe area. That's not the case if we allow anyone that just doesn't feel like it to not wear a mask. There are special exceptions. I would think some of the cases have been mentioned here, where it does or maybe affects a child's ability, etc. to let the school decide on something like that. There are better solutions than just saying anyone at their own choice can go out. children 12 and over can now get a shot. And you know, I have a daughter in law that teaches school, they don't have a problem with wearing the mask. And they said they will go with any way they can to help on that. The emergency authorization, yeah, it is an emergency operation, but I think that Pfizer and these others have proven themselves. Pfizer is saying that they expect to have a serum out for emergency approval in September for kids 5 and older, well excuse me, 5 to 11 because they can already address it up to that point. I would hope that parents, being parents, would take a proactive approach to it saying to their kids, you know, do you know a kid in school that's got asthma? Do you know a kid that's got diabetes? Do you know what the danger is to them? If they get it, you know, to my child, you may get sick if you get this covid, to the diabetic, to the asthma, it's a death sentence. We do not have the right to yell fire anywhere. That's what we're doing at this point saying, hey, you can yell and

do whatever you want to. You don't have to wear a mask for one reason, if you have your shots. And they've pretty well proven themselves by the decline in the in the rates of cases that happened as people were getting their shots. So you know, I don't think we want to make winners and losers out of this today. You know, the people that are for the motion. I think they have some concerns. The people are against the motion, they have their concerns, but let's not make winners and losers because of that. I move that we table the motion.

Mr. Stoutenborough moved, seconded by Mr. Holliday to table the resolution as presented.

On the question:

Mr. Foster: First, I'd like to thank Rob Werden and Toni Corona for their exhaustive hours and trying to get this matter resolved. I'd also like to thank our state's attorney for the time they've put in with other board members working on this resolution. I don't think there's anyone in this room that does not believe parents do not have a choice. My feeling on this, I don't think the board should be involved in this. We have no legal authority, we have no legal standing. I've had multiple phone calls, people that we're proud of this resolution because it gives us the authority to write our school boards. And I want to make it perfectly clear that an opinion from Mr. Haine that this resolution does not give the county board any authority to override the state or local school boards.

Mr. Haine: No, it does not give the county board that authority. I mean, this just to be clear, this would be an action of the Board of Health, which is the same body, it's just a different legal construct. And when taking an action as the Board of Health, it has a certain moral authority similar to the recommendations of other health organizations. It has no legal binding authority. It has a certain kind of moral authority as the Board of Health. But you're right to say this doesn't mandate anything for any school district. It in no way changes the relationship between the school district and the county board or the school district and the Board of Health. It doesn't assert control. It merely makes a recommendation as the Board of Health. Does that clarify your question?

Mr. Foster: Yes, sir, thank you.

Mr. Ross: The last paragraph of the resolution says we strongly encourage to allow families have the option. I think that's the bottom line is we're trying to just give people the option on whether their children wear a mask in school buildings and classrooms in this upcoming year. I know being with Stacey Pace and Triad Unit 2, I've had a large outreach of people confronting me wanting just the option on whether their students wear masks. My district also covers into the Highland School District where their school board has passed where students will have the option to wear a mask. So it's just, you know, I will be voting yes on this resolution. Thank you.

Ms. Mueller-Jones: First of all, I would like to express that I do not agree with this board doing advisory resolutions. One, because it wastes the taxpayers money. We paid for Mr. Carruthers to write this. We've been on the phone. There's all this paper. I mean, there's nothing going to happen with this resolution because it's advisory. We should trust our people that are educated in the education system including the

superintendent, and I'd like to know how many board members spoke to their superintendents because I did personally, not only the public schools but principals of the private schools in my district. The Catholic Diocese is doing parent option at this time, until or unless the numbers go up. Collinsville School District is doing that as well, unless there is a child that is immunocompromised or a teacher. And then that classroom is required to have a mask. If numbers go up, they have given themselves a fluidity to be able to do masks and require them. They are doing this to keep our kids in school five days a week. First and foremost, the most important things for our children and I have three plus two bonus kids. First and foremost is to keep them safe, and give them an education and then being in school every day five days a week is the most important thing for them. Homeschooling, I mean, people who want to homeschool, that's fine, but I'm saying in this process, the remote learning, I don't know about everyone else, but it didn't work for me. I had a kindergartner and eighth grader last year and we didn't do it. We went to school every day. That is first and foremost. Our special education students need school every day. Our kids that don't get enough food at home, like the kids at Kreitner School and a lot of other schools in the Collinsville School District need school every day. Kids who don't have parents, yes, they're out there, that don't have parents to take very good care of their kids. And it's sad to say, those kids need school. I don't remember the number of homeless kids we have in this county, I think they gave that number was within the year and it was astonishing. Those kids need school. The Superintendent of Collinsville said to me that they really pushed hard with the state of Illinois to be able to have autonomy and Madison County because Chicago isn't the same, Bloomington isn't the same, what happens there isn't the same here. We as a board are now trying to say every school in the district should be the same, and that's not right either. I have two kids with asthma so I totally get the underlying condition. I'm all about civil liberties, 100%. But I'm also about our kids getting an education. If we're going to keep our kids in school, then giving the superintendent the ability to say, you know what, the numbers are high, we need masks, or we don't, is what we need; not us sitting here, who have never taken a class in education, have no idea how to run a school district, have no idea how it is on the ground. We should be supporting those people and not making their job harder just because we want to take some political stance or look good, or do some cockamamie advisory resolution that doesn't do a hill of beans to help anyone. This board should be helping the people in Madison County, we should be helping the homeless, we should be helping the mental health, we should be helping our kids, all of that and they should be in school. And if masks is what it takes, then the people on the ground should determine that, not us. We're not the experts. That's all I have.

Mr. Malone: There's not much I could add to that, she pretty much, thank you, you stole my thunder. I haven't heard from any of my constituents. Everybody I heard from was from Glen Carbon, Maryville, all the districts that you're referring to. I haven't spoken to anybody from the Alton School District, but I have great faith and trust in the superintendent and the school board, the teachers, and the union to work together. Because we know there's going to be outbreaks. And what you're going to have to do is you're probably going to have to isolate one building. You know, I haven't taught in a while, but right before I left, things started happening. And then, when I left, they had to shut the junior high down, send teachers home. So you're going to have to give the school's flexibility and we're not the ones who can give them that flexibility. I have trust in the schools to be able to do that, local control right?

Mr. Goggin: I'll probably vote yes on this. But you know, times gone by and I've been here longer than I thought, and I've seen a lot of these non-binding advisory resolutions over the years from both parties and every one of them stinks. It's just pandering and divisiveness to throw us into a middle of an argument to make someone look good and I don't appreciate it. I think a lot of people here, don't appreciate it to be put in this position to vote on something that we really have no control over just to make some people, who ever, look good. I just don't appreciate it. Thank you.

Ms. Doucleff: I am in the classroom on a daily basis, and it is tough wearing these masks. These kids are affected by it socially, academically. We have put a wall in front of their faces. There they are suffering, they're suffering bad. When they have free time to socialize, they don't even know how to talk to each other anymore. They sit there. And you know, we talk about wearing the mask at school, those masks come off

at lunch, those masks come off and they take a drink of water, those masks are being touched and they're getting dirty with their fingertips. There's more germs going on with those masks than anything else. I do have full trust in our superintendents. They know exactly what our school districts need. This resolution is just letting our community know what we feel is that parents need to have a choice. Our superintendents and our assistant superintendents are there to finalize exactly what our district needs.

Mr. Messner: I just want to say that I'm very grateful for the public comment that we heard tonight. I think that public involvement in these meetings is critical. And it's probably part of the reason we're actually discussing this tonight is because so many citizens got involved and reached out to their board members. I think my job is to represent my district, and the people in Madison County in my district. And it's been pretty clear that there's strong emotions on both sides. There's strong beliefs on both sides. I don't know, maybe I missed something, but I thought this was non-binding, but there's been comments that make it sound like we're trying to tell somebody what to do. But I look at this as encouraging parents and school boards, that we support them in their right to maintain and exert local control over their district in their area and their students and their kids. That we support them. We're letting them know that. I don't know how that can be construed as anything else.

Mr. Stoutenborough: I didn't want there to be winners and losers, that's why I asked for the table. I don't think, let me go back, when Kurt interviewed me whether or not he wanted me on the board or whatever, I gave him the toughest time you could imagine. He went to Bloomington High School, I went to Mount Pulaski, and he said how did you know that Bloomington were the Iron Man? I said because little ole Mount Pulaski just beat the crap out of them. I gave him a tough interview. But at the end of the interview, I said one thing, I've been around politics for a long time, I worked for Senator Nick Hubbard for seven years. He was a strange kind of guy. He was elected by one party, said there was corruption in it, ran on the other ticket, and won on the other ticket, said it was more corrupt than the first, and he got defeated when he tried to go back to the first party. But I said at the end of that interview, I've been around politics, I know there's some crappy stuff that goes on, but I will never vote for something that goes against my Christian faith. Now, some of you will think I'm a radical. Well, if Lutherans are radical, I'm radical. But I have a friend named Matthew. He described where there was division and some were divided to the left and some to the right; some that went to the right said, why did you choose me? I never offered to give you a drink when you were thirsty, I never gave you food when you were hungry, I didn't help you when you were sick. But the response was what you did the least of them, you have done to me. And I stand for the kids to have asthma, diabetes, maybe you're overweight, if they have a weakness that they can catch it, we are taking the responsibility for very severe illnesses to the kids that might be prone to it. In olden times, they took care of these plagues very easily. You had to go out and kill a lamb and you had to put blood across your mantle of your door so the angel of death would fly by. We have been blessed by having a vaccine that will reduce significantly the possibility of covid affecting our lives, our nation, our ability to put our businesses back to work and for people to have normal lives. You guessed it, I am not going to vote for this motion. And I ask those, if you say we're Christian, now is the time to say, lets exercise our Christianity, and let's not do something to the least of them, the kids with asthma or whatever, let there be special exceptions for those that have learning disabilities, or have a disease or otherwise.

Mr. Madison: I'm Lutheran also by the way, and I'm on the opposite side, I believe that I'm following my Christian values, because I'm not telling anyone what to do. So our first duty as elected officials, Mr. Chairman, is to protect people's constitutional rights. That's all this does. It doesn't tell the local school districts what to do whatsoever. What it does do is, it gives them back up to say, look, the county board overwhelmingly agreed that we should be able to allow the parents to have a choice. It's not telling anyone, your son or daughter cannot wear a mask to school, if they're compromised, they should, maybe if it's really bad, they shouldn't go. At the same time, every day is a risk. The damage that has been done to young kids with Covid-19 has been less than that of automobile wrecks annually. So are we going to stop letting kids in cars, too? At what point do we feel that we have to tell others what they will do no matter what, even though they live in a free country. So I don't think that's pandering. I don't think it stinks. I don't think it's

crazy. I don't think it's unchristian. I think it's what you do in a free country. That's why it's called a free country. Not sure what people don't understand about the term free country. So that being said, all the things that everybody said to poopoo this and to give themselves less risk because they want to win the next election or whatever it might be. That's not what this is about. This is about parents exercising their constitutional rights to do what they want to do for their own kids. One member asked me last week why I said because they're their kids, they're not ours. We pay the school teachers, we pay the school districts, the money they earn goes to the unions, the teachers unions and the other unions. They pay for all of it, the taxpayers pay for it all. Not so they can let government, local government, school boards, county boards, whatever it might be rule over them. We are government by the people, of the people, for the people, and that's the way it needs to be. Thank you.

Mr. Madison moved, seconded by Mr. Ross to approve the resolution as presented.

NEW BUSINESS

Mr. Haine: I know everyone's tired out after that very active participation prior to this during the Board of Health. I just want to have an opportunity to say a few words, which I think I've said to everyone here individually, and in the meantime, Andy and John from my office are going to be passing out just a simple graph just for your consideration that will provide the somewhat of a background to my comments today. So I promise not to take to much your time. So my office in conjunction with the Public Defender's Office has proposed a Criminal Justice Revitalization Plan in Madison County. It's something that is very important, I would say essential to the criminal justice system and Madison County, it's balanced, it's proactive, and I would encourage the board to vote for it. I'd like to explain a little bit of the background and just to begin with the ending, you know, this is not something that is before the board today, but it will

be before the board next month. That's the plan. So the basic idea behind this plan is that we have an opportunity, Madison County has an opportunity, and it's coming out of a crisis. But we have an opportunity to send a message, a real message with real substance to the surrounding areas that Madison County is committed to public safety, that we are going to do what is necessary to make sure that we can aggressively and fairly prosecute crimes in Madison County to make sure that we have safe streets, safe neighborhoods. So it's an opportunity, but it comes because of a crisis, and that is a crisis caused by Covid, which is the pandemic related pause in the courts, that's created an enormous backlog. But it's also a crisis created by years of deferred maintenance in the criminal justice system, and that's the chart that I'm passing around to you. The deferred maintenance comes in the form of over the past 10 years, we've had a steady uptick in crime and criminal filings in Madison County, specifically the most important being felonies. So in the last 10 years, we've had a steady increase, there's a slight dip and as a steady increase in felony filings so that in the past 10 years, we've had upwards of a 40% increase in felony cases in Madison County. We've had a steady decrease in the number of prosecutors. So this is a combination of 10 years of needed increase in order to actually service these prosecutions in the way that they deserve to be serviced because they are real victims. They're very important cases, and on top of the Covid crunch, so that's why we need to do it now. So now, this is essential because we've had about one and a half years now of court pausing where the Supreme Court has lifted the requirement that a defendant be given his speedy trial rights, which is the concept that you have 120 days if you demand a trial; the state has to bring that case to trial. October 1st, the Supreme Court will lift its stay on speedy trial right. So all of a sudden, October 1st, all of the cases that have piled up 6000 plus felony cases in Madison county will suddenly all have speedy trial clock starting on October 1st. So my plan is going to reduce the number of felony filings assigned per felony prosecutor from the range of about 500, which is where it is now, which is very high. Imagine having 500 felonies assigned to you, you have almost twice as many file felony cases to review as you have days in the year. So my plan of hiring 9 new prosecutors and 1 new service personnel and the Public Defenders plan of hiring 3 new public defenders will bring our per felony prosecutor number down to about 300. And the reason why that is essential to do now is come October 1st, we need to be able to have the staff to potentially handle a number of trials at the same time. And if you don't have the staff, things can get very hairy very quickly, and that's, I think, is the last thing that Madison County citizens want. So that's from the standpoint of personnel that this is years of piling up of a problem. No one likes spending money. This is, you know, it's a big ask, in a sense, it's 9 new senior prosecutors in my office, and 3 new prosecutors in the Public Defender's Office. But it's an ask that's commensurate with the basic needs of the criminal justice system. And those are just defined by the numbers. I'm not here to just make an ask that's coming out of my head, a sort of start high, go low negotiating approach. This is my estimation after doing the full internal review, in conjunction with the Public Defender's Office of what we need to make sure that we have a smooth operation of the criminal justice system in Madison County that protects the rights of defendants. It will also allow us to prosecute cases as they come through the door, or as the police departments are bringing us these cases. So in my sense, this is the bare minimum if we're going to have an aggressive, proactive law enforcement community, which we should have in Madison County, if we're going to have safe neighborhoods, and if we're going to send a message to the surrounding regions, that Madison County is where you go if you want to have a strong, safe community that respects the rule of law. This is the way to do it, I believe. And I think it is a true opportunity to have a positive distinction from our surrounding communities and Madison County is standing for something else. Madison County is standing for strong, proactive justice. The other part of this besides the personnel, which is the biggest ongoing chunk, it would be a 22% increase in my office year over year. I can give you all the numbers if you'd like. But the other part of this is the license plate reader program. So I believe you know, this is sort of a three part program; Public Defenders, very important; Prosecutors, very important; Enabling law enforcement, also very important. I just came back from Madison earlier today in Madison, we just charged an individual in the murder in Madison. Similarly, three weeks ago, we had a murder in Granite City, yesterday, the US Marshal's Office picked up the individual that we've charged in that murder in Granite City, both cases license plate readers were pivotal in the investigation of that case, both cases, they actually cleared individuals who were possibly suspects. So they work both ways. They just clarify the situation for everyone. Right now we have approximately 120 license plate readers active in Madison County, most of those are hooked up to the nationwide network through the DEA. And this would increase that by about 46, which would sort of fill in the gaps of the current system and would allow for Madison County, again, to really make a profound statement about its commitment to giving law enforcement these incredible tools which are cognizant of civil liberties and you know, they only keep the data for 90 days. We're very cognizant of that. We would own them, so if we didn't like what was happening, we can always just pull the plug, which is always nice to do if you own the system. And so the license plate reader is sort of part of what I think the call from the citizens of Madison County to reinvigorate our focus on especially violent crime. Because we look across the river and we see a real crime crisis. We actually see a criminal justice crisis over there as well, frankly, which if you've read the news about the murder prosecution that was dismissed by the judge due to the inactivity of the Circuit Attorney's Office, you'll see what it looks like. Well, that would never happen. But you'll see what it looks like when you have a criminal justice system that starts to spiral downwards. We don't want to go that direction in Madison County and we can send a resounding message to everyone in the entire region that Madison County is committed to public safety. We're committed to the rule of law. We're committed to supporting our law enforcement agencies, we're committed to fairness, and we're going to back it up with real action, we're going to back it up with appropriate dollars and appropriate support that means something to the citizens of Madison County. Just some numbers to end with, from 2016 to 2020 20% of Madison County homicides were committed by Missouri residents. So those are charged homicides committed by Missouri residents. 2020 was the first time since we can look back, we did our own internal review since 2010, that a full 10% of all felonies committed in Madison County were committed by Missouri residents. So far in 2020, over 50% of charged homicides so far this year, were committed by Missouri residents. So we have to do something to make the message abundantly clear that Madison County is not welcome to this kind of behavior and we're going to make sure that we do everything we can to stop it. And we're going to make sure that we empower those institutions, of a criminal justice system that actually do that kind of work and do it well, to do it with the professionalism and with the aggressiveness that the citizens of Madison County expect. So it's a real opportunity and I would love to answer any questions anyone has without belaboring the point, because this is not actually up for vote today, but this is a good opportunity to talk.

Mr. Holliday: Mr. Haine, where does Madison County stand by counties in Illinois on felony prosecutions by a number?

Mr. Haine: It's among the top.

Mr. Holliday: Among the top?

Mr. Haine: Yes.

Mr. Holliday: We're doing a pretty good job then.

Mr. Haine: I believe so. I think that this is not an opportunity for us to reduce felony charges. These are real cases that law enforcement are bringing us. We're not willy-nilly overcharging felonies, I think these are discrete cases, and this is a year over year trend that's steady, it's a steady trend. And so I think we're doing a good job of charging, the question is, whether or not we're doing a good job of supporting that system. At a certain point, if you have a reduction in the number of prosecutors, but you continue to pile on more cases which are justified, then what happens is cases grind to a halt. Judges are reluctant to schedule trials if they know that the prosecutors on that case and the defense attorneys on that case, literally have no free weeks for the next six months. How are you going to schedule a trial? So this would this would allow the system just more flex provide for speedier dispositions, that is my true hope, and also help reduce the ongoing year over year problem of long term stays in the Madison County Jail, which costs the taxpayers and an inordinate amount of money. If you can dispose of these cases professionally and well with defense attorneys and prosecutors, it helps every part of the system work better. It doesn't solve all the problems, but it helps every part of the system work better.

Mr. Holliday: Why such a small amount of Public Defenders?

Mr. Haine: the Public Defender's handle about 70% of the total felony filings. So their office is much smaller than my office. And that was there, I worked with the Public Defender, she reviewed her own cases and determined what her appropriate level of support would be to meet the problem not just to make a statement but to actually solve the problem. That was the number that she came up with. I'm not aware of the inner workings of her office. A lot of people have private attorneys, especially for the more serious cases, my office handles every case, every serious murder case, I think that that explains the distinction. I fully think that the Public Defender's Office ask and my ask are joined at the hip, and I've always approached it that way. I called her from day one, and I said, this has got to be a balanced investment in the criminal justice system, we got to tell the county board what we need and why, we got to tell them the numbers, and we got to approach this as a whole network. Otherwise, if I get 100 new prosecutors and there aren't enough public defenders to actually deal with the cases, the system still isn't loosened up. So does that answer your question?

Mr. Holliday: That does, but also, you know, we have people with mental issues that need help.

Mr. Haine: Yeah.

Mr. Holliday: Is there something that is going to be available where you have counselors or people who can deal with them with their issues before they are incarcerated or put in jail, anything like that?

Mr. Haine: That's a complicated part of the equation that this program does not account for just because it can't account for anything. This is about the State's Attorney's Office, Public Defender's Office, and license plate readers. It's not here to solve all the problems. It's just here to propose a solution to what I think is a large chunk of the issue.

Ms. Kuhn: I just had a quick question. I don't know exactly how to put it, but over the years has a definition of a felony kind of changed, because at one time, we thought of it as a murderer or somebody really bad. But I have seen things where felons are people that it wasn't that drastic. So has the definition changed over the years.

Mr. Haine: It hasn't. No. And I would love to tell you that the numbers aren't as bad as they look but we have a real crime problem and the crime problem is getting worse. I think if you talk to anybody on the street they'll tell you that, but the numbers bear it out. We need to be able to respond to that in a dynamic way, and when we see a wave of long-term increase in felony cases, the basic operations of the criminal justice system would demand also a commensurate increase in the personnel that are going to prosecute those cases on behalf of victims. And, frankly, I wish perhaps this problem had been steadily solved as the felony filings had gone up, perhaps one or two, you know, felony prosecutors per year over the last 10 years. In fact, my office's personnel has gone down 20%. So you know, these are the problems that I hope to in the future keep you very informed of, and as the numbers come down, we would love to reduce through attrition our personnel. We're just not here for an infinite increase, although, as Ronald Reagan once said, the closest thing to eternal life is a government program. So I recognize there may be an issue there, but I will keep you informed on a year to year basis about the numbers and hopefully we can solve the problem in small pieces here going forward. But this is currently to get us back to the basics.

Ms. Kuhn: With the crime committed, what I'm trying to say.

Mr. Haine: It hasn't changed, there's just more of them.

Ms. Kuhn: There's more of them, but what determines, I mean, say a young kid goes out and slits tires or something. That's horrible. What determines?

Mr. Haine: It's set out in statute, Illinois state statute, it has always been the same. So there are just certain kinds of crimes that are categorized as felonies. We don't see a new crime that's accounting for these numbers, we just see law enforcement agencies bringing us these cases to charge. And when they're good cases, we charge them, which is what sends a message to everyone that, you know, crime doesn't pay in Madison County. Well, you know, if it takes 3 years to dispose of the case, that message is a little cloudier, right? So we need to have the teaching function of the law, if you commit the crime, if you're charged with the crime, the prosecution needs to come right on the heels of that, otherwise, the word doesn't go out, the message doesn't go forth, that crime doesn't pay. So this is a long term problem. This will hopefully be you know, this will be a long term solution. I think if anyone else in this room was sitting in my chair, I think they would ask for the same thing. Because this is looking five years in the future, 10 years in the future, these are the kinds of long term trends that if we don't do this now, maybe you won't see the impact next year, but you probably will in 3, you probably will in 5. And if we take action now, hopefully the same thing will occur just in a better trend line. And with safety, you know, ideally, I'd like to succeed myself out of a job in the sense that if there's no crime, you'll need fewer prosecutors. I'd love to come and report that to you one day, Judy.

Mr. King: I support you 100%. How does that work now with your caseload? You're not increasing the number of judges. So my question is and I know, and I'm dumb to this, so you'll have to explain it to me, but are you going be able to work with the judges? You know, because I know they set their own dockets, don't they? How many cases they see or what have you? How do we speed that up?

Mr. Haine: Yes. I don't see trial weeks increasing. Right now, we're moving to 2 trials per trial week. This would just allow us to staff in a more aggressive way all of the current dockets. So right now, you have a docket call, and you have cases that are set for hearing, you would just have fewer prosecutors assigned to the same number of cases. I've spoken with the Chief Judge, and I've also spoken with Judge Knapp who is the Chief Criminal Judge, and there might be a slight sort of downstream effect of just more people in my office handling these cases. But really, this is allowing us to staff better current dockets that the judiciary is holding. So we don't see the need for an expansion, more courtrooms or anything like that, especially because we hope this number will go down after the Covid crunch is done. But this is really dealing with the current cases that we have before us so I don't think it would require any long term downstream effects with the judiciary, frankly. But I don't want to speak for the judiciary. I can't, in fact, speak for the judiciary.

Mr. Madison: Quick question. It dawns on me that some individuals are charged with multiple felonies. Does this graph show cases or total felonies?

Mr. Haine: Great question. It shows cases, each case has multiple felonies attached to it often and so the actual total number of felony cases is much higher than 6000, sorry, the total number of felony charges is much higher than 6000. For example, we did the numbers today, we're on pace to charge over 4000 felonies this year, even though part of this year is Covid restricted in a sense, movement wise. There are many more total charges out of those 4000 individuals that have felonies assigned to them.

Mr. Madison: Just wanted to know what we were looking at.

Mr. Haine: No, that's a good question. Because that can drive the numbers one way or the other. We did the lowest number that we could find and that's the lowest number.

Mr. Babcock: I'm kind of a numbers guy, Tom, and I certainly appreciate what you're asking for, number 1. Number 2, I certainly support your office. I support the men in blue. But with the numbers, as I've communicated with you in the Judiciary meeting, as well, as you know, that Judge Mudge was asking for

more. And, of course, other departments are asking for more as well. So I'm not sure you've indicated the actual dollar amounts necessary to fund it, but I want to share some things with you. In the last 5 years, I looked up the budget for your office has actually climbed about \$200,000. So I'm not sure exactly, is it \$500,000?

Mr. Haine: 5 years, is that what you said?

Mr. Babcock: In the last 5 years, it's increased by \$200,000. So your numbers on prosecutors might be absolutely correct. And I appreciate you sharing that with us because it does look like 5 or 6 or 7 less than what you had. And I realized that your felony cases have gone to 6200, from about 3000 10 years ago, and about 3900, if I'm not mistaken, somewhere around a year and a half ago, if I'm not mistaken, before Covid took place. So Covid has definitely put a crunch on your situation as you've taken office over the last 8 months. And I can see where that would be a major problem for you to be able to handle it, as well as what Matt King mentioned, the judges to handle it. But here's what you're asking for, I mean, so that we all know and understand you're asking for a million dollars for readers, you're asking for 1.3 million that might have changed per year.

Mr. Haine: I could tell you right now. So what we've done, just to provide you with the nuts and bolts, so the license plate proposal would be \$1,061,000 and that would be fully funded through ARPA, under our current analysis of ARPA. And then we would with ARPA, part of it, we believe can be funded, can fund the prosecutors and some of the defense attorneys, but not all of it, because not all of its pandemic related. As you can see, it's a 10 year trend line. So what we've settled on internally is sort of a 60/40 split. 40%, funded through ARPA, for the next three years through fiscal year 2024. And then the remaining 60% is sort of a permanent increase relating to this deferred maintenance over the last 10 years. And so the ARPA portion of that would be an immediate allocation of \$200,000, to fund that 40% for this year, and then an allocation of an additional 1.7 million from ARPA, to fund it for the next three fiscal years. So that would give me four new prosecutors for the next three fiscal years. And then hopefully those numbers would go down and through attrition, I can make changes internally that would work, I think. But for future fiscal years, the additional increase for both myself and the Public Defenders, that's non ARPA, would be \$790,000 per year, additionally, which would fund 5 new prosecutors and 2 new defense attorneys.

Mr. Babcock: So that would come out of the General Fund?

Mr. Haine: Yes, and 90% of it would come out of the Property Tax Levy, and the remaining \$700,000 would come out of the General Fund. So the increase of \$90,000 out of the Property Tax Levy would have to be offset by corresponding decreases in other property tax levies totaling 90k. If that offset is done, and again, the total Property Tax Levy is 30 plus million, then it wouldn't necessarily result in an increase in the Property Tax Levy. And then the projected revenue increases of the General Fund would be about \$700,000 that the chunk that this total ask would take out of the General Fund. The projected increases year over year for the next fiscal year are more than that \$700,000.

Mr. Babcock: Projected from what though, Tom?

Mr. Haine: Projected for next fiscal year.

Mr. Babcock: But where's those dollars coming from?

Mr. Haine: The Auditor.

Mr. Babcock: Yeah, but that's not sustained. Well, anyway, I don't want to get into an argument.

Mr. Haine: Those are the numbers, \$700,000 out of the General Fund, 90 grand out of the Property Tax Levy that would have to be offset.

Mr. Babcock: My understanding that surplus that we're actually running right now is a one-time surplus, I could be wrong on that. But here's my biggest concern, and again, I support your office 100%. I do think you do need some help, and I think personally, I think the ask is a little bit to high. But we got we got a \$50 million payroll that needs some form of an increase this year, because my understanding is they didn't get an increase last year. If at 2.2%, that's a \$1.1 million increase. The Tort Fund, as we can all imagine, what we had to do this past year, if we ask Annette, is down at least \$800,000, almost close to a million. So now we're up to 2.1 million. Your ask, I know is possibly coming out of ARPA that could solve some problems for us. But your ask is \$2.3 million.

Mr. Haine: 2.3? Where are you getting that?

Mr. Babcock: The \$1.3 million on your increased payroll and the readers.

Mr. Haine: That's \$790,000 on the increase payroll per year.

Mr. Babcock: The grand total every year?

Mr. Haine: Yeah, 790 per year.

Mr. Babcock: I got you. So, if by chance, we can't take that out of ARPA, we'll have to take that out of the General Fund.

Mr. Haine: Yeah, 90 out of the Property Tax, 700 out of...

Mr. Babcock: The numbers on this amount right here, not including judges, not including anybody else is close to \$4 million.

Mr. Haine: Where'd you get that, Mike?

Mr. Babcock: Again, I want to go back over if in fact, there's an increase on people's pay, and the Tort Fund that we need to replenish at some point in time because it's down about 800 to a million, and your ask for readers, and your ask for your office for payroll increases is close to \$4 million.

Mr. Haine: So the license plate readers are fully funded by ARPA.

Mr. Babcock: Tom, at the end of the day, I support what you're trying to accomplish and I didn't want to bring this out. I'd like to talk to you about it, but I support what you're doing. But there's so many more things that we as a county board still have to fund, and I'm not interested, honestly, because that's my mentality and philosophy of increasing taxes on the people in the county of Madison County. We have a good track record over the last 5 years. Personally, I'd like to keep it that way and I want to just simply say that if by chance your attorneys could handle a 500 caseload, and you had 2 or 3 more attorneys in there, then that would take care of a lot of the case load off your other people and would bring the level down to a substantial level, maybe 4000, where it was just a year and a half ago before Covid hit. Now, again, I support you, but the ask might be just a little bit to high for me, may not be for everybody else on the board, but for me.

Mr. Walters: I think the numbers that you 2 are have, I think you 2 should get together and talk.

Mr. Babcock: I understand.

Mr. Walters: Ok, because I'm listening to you and I'm listening to him and I think you 2 could agree on different numbers. Does anybody else have any more questions on this?
