VOICE VOTE BY ALL MEMBERS.

Mr. Madison: This is regarding the public speaking, and it's regarding the Staunton Road realignment. I just thought a little information in the beginning might help everyone in the room. There's a lot of speakers regarding the realignment of Staunton Road. The section we're talking about today, that you'll hear from the speakers, starts at Highway 70 and goes about two-thirds to three-quarters of the way up to Highway 143 and it's just on the east side of I55. We think it's going to get busier out there. This project began I believe in 2008; two highway directors ago. We don't have any plans set in stone yet. A study was done. We were surprised that it ran close to a few houses, but we are looking at alternatives to try to do our best to make this a good situation for everyone. And I wanted to thank everyone for coming out.

HELEN HICKAM'S ADDRESS TO THE BOARD:

My name is Helen Hickam. I live at 3210 Staunton Road. My husband and I have lived there for 30 years. Madison County, they want to build a road across the Wetzel farmland and across the back of my back yard for whatever reason. From what I understand, they have \$20 million to spend. So hey, let's build a road, don't fix any roads. If you drive down the roads around here, you'll see the shape they're in. They want to build it across the edge of my backyard. Staunton Road goes across the front of my yard. So at two o'clock in the morning, they're dragging across the front of my yard now they're going to build a road so they can drag race across the back of my yard. And everybody wants that, right? I'm talking to the board members. I was told this had nothing to do with Pin Oak Township. I live in Pin Oak Township, so I think it has a lot to do with Pin Oak Township. I don't understand why they're doing this. It makes me very nervous standing here in front of all you people to talk. We never see any policeman out there because we don't have any crime out there. We have wonderful people who live in our neighborhood, and we have nice farmland in

back of us. If you've ever drove down to Mitchell to see what they did with the farmland by 111, to see what happened there with all the warehouses? Is that what you want to do with the farmland in back of my house? Or do you want to put a subdivision back there? Or do you want to put apartments back there? Not anything that's going to grow food for you people to eat, or for your family to survive on. Let's do away with all the farmland and have no food grown because that's what's happening. Plus, the crime. Look at Jamestown Mall. Look at what happened over there. Maybe some of you don't even remember Jamestown Mall. I do because I'm old. Look at the crime rate over there and what happened to the mall. I'm just waiting to see when the same thing happens to the warehouses on 111. Now you want to put them in my backyard so that it'll be the same thing. You talk about transparency. There has been no transparency in this situation. When I talk to the farmers, they tell me they've made no deals with anybody, but when you talk to the people who are wanting to buy land, they act like everything is a done deal. I hope it's not a done deal, and I hope that you people can come to your senses.

RAY TAKMAJIAN'S ADDRESS TO THE BOARD:

Hi, my name is Ray Takmajian, and I'm against this realignment of Staunton Road project. My wife and I live in the 3100 block of Staunton Road. And yes, you're trying to build a road right through my property. My wife and I bought this home and land in 2005. We wanted to get away from the city and have our son grow up in the country. For the past 18 years, we've groomed this property in a way that benefits us. We've returned the land behind our house to native prairie grass, we've added a chicken coop with lots of chickens, added a pole barn, and many plants and trees which take years to grow and mature. Myself and my wife enjoy sitting on the back deck watching the wildlife in the backfield. I also breed, train, and run AKC field trials with my bird dogs. This field is where I spend every single evening. I want it left the way it is. My wife and I like our property on Staunton Road just the way it is. Why is a new major road needed directly behind my house running parallel with Staunton Road in front of my house? You just heard Ms. Hickam say it's ridiculous. It doesn't make sense. Who's it going to benefit? Think about that. The existing Staunton Road would be 90 yards away from the new Staunton Road. That is stupid. At the last Transportation meeting, I spoke about transparency; transparency definition in business and government context is simply defined as honesty and openness. Being transparent is to let the people see what a government does, what a government intends on doing, and why a government is doing something. Really? Being transparent builds trust, shows honesty, integrity, and exposes corruption. I quote the Madison County website which states transparency is about the ability for the public to have full access to the information and not just the information that the agency is willing to provide. This hasn't been done period. It's ridiculous. In 2021, I'll give an example, I actually put in for a FOIA through Madison County, and I was denied very simple questions, questions that should be answered. They weren't. It was denied. In 2023, on July 29th, several Staunton Road residents sent an email to many County Board members that were here. Guess what? None of those were answered. I'm going to read that letter. While speaking with neighbors on and around Staunton Road, it was astonishing to see how many neighbors and how many people in the area have never even heard of this project. Why? Because it's not being transparent. That's why. The only residents that were aware of this were the ones that the property was needed to build the road. That's kind of interesting. What is the entire route of this realignment? These are some of the questions that I asked. What's the entire road realignment construction project? Where is it? What's the estimated cost of this project? Is there a current and accurate map of this project? What is the reason for the realignment? I could go on and on. These are simple questions that could be answered, should have been answered. Will the residents of Madison County be voting on this to approve or disapprove a project when it costs this much money? Most of these questions were never answered just like I said. Is this transparency? Not hardly. There was a thing that I heard one time saying it's like putting lipstick on a pig. Guess what? It still stinks, and it's still a pig. Thank you.

BRANDI KASSA'S ADDRESS TO THE BOARD:

Hello, my name is Brandi Kassa, and I am on 3168 Staunton Road. I have grown up on Staunton Road for 38 years. I obviously lived with my parents first on Staunton Road, and then I was fortunate enough to work my butt off at my job tirelessly to finally make enough money to buy four acres of land and I was so proud of myself. Then to build a house, and then to later find out that now some of that land wants to be taken away from me. And yes, I say taken away, because I don't want to sell. I absolutely do not want to sell. I've heard the words eminent domain, and that's definitely abuse of power, and I hope that it doesn't come to that. It's a little bit scary. I'm growing my life on this road. My parents moved out to Staunton Road because they wanted to live in the country. We people that live out on Staunton Road, we call it the country, right? It might not necessarily be much, but to us, it's the country and we enjoy the fields, and we enjoy the land, and we enjoy being able to have children run around and ride their four wheelers or whatever it may be. Now, basically, many of the neighbors on the road are going to be boxed in by these two roads. I don't know if you guys have seen these roads, but there's a road in front of our house, and there will be a road built directly behind our house that will completely box us in. I know somebody has said oh, well, you know, the dangerousness on that road. There's going to be two roads. If I decide to have children someday, my kids can't play in the front yard, my kids can't play in the backyard. Yes, there's such thing as fences, out in the country, there's not. There's no such thing as fences. We roam free. We enjoy our lives. We get to look out at the cornfields and the beautiful trees. This is what we want. We know that there is more to this than just another road to fix the dangerousness on these roads. These curves that are on these roads, we've never had issues. I have lived here my entire life, and I can tell you, there has not been major accidents on this road. I know. I've lived there. I know that's one piece that goes into this. Another piece is that they believe the community out in that area is going to grow, so we need this road. I can tell you that's not accurate because it's the same as it's always been. I can tell you that you can hope that it's going to grow, but with the taxes in this state, I don't think that you're going to have that. The other thing I want to put out there is, kind of like Helen said, the green space; we're taking away more green spaces, adding more concrete. I don't want to see more concrete. Let's enjoy the land that we have. Let these farmers keep farming. It just doesn't make sense. Who's going to pay the taxes on this road? It's all of us. Are we okay with that? It's a \$20 million project. How many taxes do you think we're going to be paying?

TOM PACKARD'S ADDRESS TO THE BOARD:

My name is Tom Packard. I live at 7846 East Mick Road. Mick Road dead ends at Staunton Road, actually, at Mr. Takmajian's house. I bought 25 acres of ground there 40 years ago. It was a cornfield. I built a house, barn, and fences. I farm corn and beans, and I raise horses. I have a 120-foot-long Morton Barn. At one time, I had 30 horses. I moved there to be out in the country. I do not want to live in the city. I like to go out in the morning and see deer in my yard, see turkey on the road. It is beautiful. I guess I would ask all of you if any of you have ever been down East Mick Road? I'm sure you haven't. I know none of you have ever been to my farm. I butt up against I-55 We're in the process of having brand new power poles put the length of our property to run from the power station on Maple Grove up to Edwardsville. I agreed to it, being kind of naive. I see now that it's all part of this plan to build subdivisions behind all these houses. I don't want this road changed. When I moved there, there were two houses, mine, and my neighbor's house. He would be here tonight, except he's 93 years old. He signed a petition. He and his wife have had ambulance service at least a dozen times in the last two years. I don't want them to have to go and weave around to get there. I don't want the fire truck to have to weave around to get to my place. I want it to stay like it is. If you've got this money, go down to where Maple Grove comes together with Staunton Road. It may be the most dangerous place in Madison County. It used to not even have a stop sign. It used to just be run as fast as you can through there. I almost got hit last night. We now have stop signs, but of course,
nobody ever stops there because we never have a cop out there ever. I almost got hit. I told my wife, I said, I think I should have got hit last night because it would have made a great point today to tell you this is the dangerous place. There has never been an accident to the best of my knowledge. Please let us alone.

STEVEN COAD'S ADDRESS TO THE BOARD:

Good afternoon. My name is Steven Coad, and my wife Denise is with me here today. I just wanted to introduce myself. I thought it might be a long queue to get on to your schedule so Monday night I said can I speak to the council. I don't have charts or anything elaborate to share with you, but I wanted to introduce myself. I'm a 28-year resident of Glen Carbon. My wife and I raised both our children here, and we are embarking. I'm a retired AV aeronautical engineer from the Boeing Company, my wife is an environmental chemist, and we're retired and we're looking to purchase the airport in St. Jacob, which is the Metro East St. Louis Airport, Shafer Field. I wanted to make people aware of that. We're on contract to purchase the airport, and we're going to be closing in September. The airport is currently still active, run by the Shafer Flying Service. The Shafer family still owns the property, and they run the airport. I'm going to be not buying the business but taking over the operations there. I'll just tell you a little bit about my plans real quickly. We want to run a sustainable general aviation airport that's a partner in the St. Jacob and Troy communities and an asset to Madison County. I'm not looking to become a big airport. I want to be that rural airport that everybody goes to. The first priorities are going to be seamless transition of current services to current customers. There are still 30 current hanger holders at that airport, as well as the homeowner's association in the air park that relies on that airport to fly their aircraft. There's still some flight training going on there at a low level. There are still people from the Shafer Company that will come and work for me. There's a small amount of maintenance service going on there. My first approach is going to improve upon the facilities there and modestly return the aircraft services to the levels that they were under Ed Shafer. That would include aircraft storage, runway access for the HOA, some fuel oil sales, a small flight school, aircraft maintenance, and some small concessions and gifts. Next steps down the road, I want to expand the airport services and increase community outreach; maybe a bed and breakfast inn, some STEM education collaboration with SWIC, and triad High School is right up the road. These are things I did within the Boeing Company. Solar energy is an opportunity in the future as well as testing and other opportunities. In the end, there's going to be a lot of challenges. I can't run an airport without my government working with me. There are some challenges even in zoning now. I found out the airport is not currently zoned to be an airport. I need a special exemption, even though it's been there 50 years, but I'm working with the Zoning Commission. You guys are supportive. I'm here to work with you. I just wanted to introduce myself. I'm looking forward to making this a viable airport and a resource for our community. Thank you.

DAVID STOPHER'S ADDRESS TO THE BOARD:

Good evening, everybody, Mr. Chairman. Again, I'm here with the Illinois Separation Referendum. As many of you know, I've addressed you several times here on the board, and we're just keeping you aware of our progress. Some things that have happened since the last time we spoke, and just for everybody's knowledge and information, we're trying to get this on the ballot next November. What we would like to get placed on there is shall the Board of Madison County correspond with the boards of other counties of Illinois, outside of Cook County, about the possibility of separating from Cook County to form a new state and seek admission to the Union (United States) subject to the approval of the people? Again, for clarification, this is not dumping Cook County. This is about putting it in front of the voters. Do you trust your voters? We obviously have voters here tonight who are a little upset with you. Some facts and figures, more facts and figures. Illinois spending since 2018 is up 95%. In 2018, we spent \$99 billion, this year is

\$193.5 billion. The Illinois general fund spending is up 36% since 2018. The governor, more legislation since the last time I was here. We now have a law in the state of Illinois that will allow non-citizens of the United States of America to be police officers. I'm sorry, this is not going to end well for anyone. \$429 billion dollars, that's the Illinois pension deficit. The Equitable Institute said there's four states that are under 60% funded. Illinois is the number one or shall I say the 50th of 50 states with a pension funding of 50.8%. I've brought to you facts and figures about the spending out of Cook County. They spend 60% of the state's revenues, they contribute 52. We have a problem here, folks. This is something for the voters. I'm asking for your approval. I will be addressing different committees as the need be to bring this in front of you for a vote from you folks. It's not about separating from the state. This is about allowing Madison County to have a voice with the 28 other counties in Illinois that have already approved this motion, most of which has been by a county board. We have a signature drive going on. If anybody would like to sign up I'd be happy to provide you with a petition. This is about the possibility, having a voice, let the people be represented, let the people make the choice. Thank you.

CHRISTINA HILL'S ADDRESS TO THE BOARD:

Sorry, my husband wasn't able to make it. Members of the board, I am here today to speak on behalf of my family and neighbors. We live at 3222 Staunton Road, and we are here with a heavy heart. We specifically chose 3222 Staunton Road for our home for many reasons, but mostly a country setting to raise our family away from the noise and traffic of city life and city living. Growing up in the city comes with traffic, noise, and crime. We want the opposite. We wanted to be in a rural area, enjoying what nature has to offer, quiet and free from disturbance along with low or no crime. Coming from another community, my husband was terrified how high the taxes were in comparison to our previous location. I assured him the price of those freedoms this home and area provided for us would be worth it. It appears I may have been wrong. This wonderful place we chose to live is being invaded by the same people elected to protect its taxpayers from the consequences of putting in this road. We have two young daughters and having nothing behind our house, as designed, we feel very safe and private. We installed a pool for our children with a large deck across the back of our home where we spend our summers, having coffee on the back deck, watching the sunrise, and watching the deer and wild turkey forage in our yard and fields behind our home. Having the farmer stop by and ask if our daughters would like to ride in a combine to cut down the rows of corn, wheat, or beans. We have privacy for family swimming and playing in the backyard while not having to worry if our two daughters are going to get hit by a car. We invested a large amount of money in a pole barn and placed it so it wouldn't block our peaceful and private view. This is what families dream of and we are very fortunate to have found it. You are now looking to destroy this and all the wonderful memories we have made as a family. In the process of building the pole barn, we had to have a survey of our property. In doing so, we found that our property has already been invaded once by this county. Our property line runs down the middle of Staunton Road all across the front of our property. At some point the county took land from our property and we would assume our neighbors as well. Now, because you have a new plan, you want to negatively affect our property again at the cost of millions of taxpayer dollars to replace a road that works perfectly fine as it is. Not one neighbor wants this. Those people who are empowered to protect this will negatively affect those that live here, pay taxes, and vote. Please understand I am not ignorant enough to believe for one minute this is about safety. This road, if allowed to be constructed as you've wanted it, will become a racing track and a safety issue. As I drive down Lower Marine Road, Hess Road, and many others in the area, they all have 90 degree turns and many of those turns have houses directly in harm's way. If 90 degree turns make a road unsafe, this county should look at those roads instead.

IMMEDIATE EMERGENCY APPROPRIATION

WHEREAS, the Fiscal Year 2023 Budget for the County of Madison has been duly adopted by the County Board; and,

WHEREAS, subsequent to the adoption of said budget, the County has received a grant in the amount of \$27,990 entitled the Self-Represented Litigant Coordinator program, with the purpose of creating and overseeing domestic violence services related to drafting plenary orders at the Order of Protection and Stalking No Contact dockets and outreach programs; and

WHEREAS, the Illinois Supreme Court Commission Access to Justice has authorized funds of \$27,990, with the County providing no matching funds; and

NEW BUSINESS:

Mr. Madison: I just wanted to clear a few things up and take up for the Highway Department, the Director, and the past directors a little bit. I just want everybody to understand that the Highway Department has a long-term plan for most roads in the county. If you fail to plan, you plan to fail, however that goes. Anyway, there's nothing nefarious going on. These things generally run 15 to 30 years before they come to fruition, long term plans are happening. You're trying to get ahead of sometimes more development into the country. The one thing we can count on, when we live in the country as I do, I assume one day, I'll be living in Bethalto if I live long enough. The only thing you can count on is change unless you own the property. Some property owners want to sell their property developed. There are no plans by Madison County to have warehouses anywhere out there, subdivisions out there, that all comes from the private sector, they can bring anything they want here, and then this board, and the zoning department will vote on that. There's no plans trying to hurt anybody. They're looking at taking some 90-degree curves out to make the roads and traffic smoother and less dangerous on those 90 degrees. It doesn't mean we have to do it. It doesn't mean we will do it. These are just the plans that we go through on all the major roads. This isn't even a major road, it won't become a major road, it will still just be Staunton Road.

Mr. Babcock: Chairman, I'd like to ask you a few questions, if you don't mind. I'm very curious. The reason I'm asking these questions, as I remember, just a very short few months ago, you brought many people before us. My first question, and I can ask all four of them or I can ask them one at a time, it's up to you. I'm very curious as to why you decided to take money from a company named MBI LLC Trash Hauling Company?

Mr. Prenzler: I'll tell you that was sent and I returned it, because it came to my attention that someone had a question about that, and I returned it immediately.

Mr. Babcock: You returned it, but you took it. You took it originally?

Mr. Prenzler: Yes, I did. I don't want there to be any appearance of any conflict of interest.

Mr. Babcock: Just out of curiosity, did someone call you?

Mr. Prenzler: Yes.

Mr. Babcock: Did they indicate to you that if you didn't return it, and you indicated to them that you sometimes take money...[inaudible 48:32]

Mr. Prenzler: This is something I care very deeply about, the litter issue. I've been a leader on that issue, and I don't want that to be in the middle of that.

Mr. Babcock: Can you explain to every board member why you paraded so many people before us and basically they indicated to us that we were not doing our job? While at the same time accepting MBI's money? Can you explain? We had two months of people coming before us.

Mr. Prenzler: I had nothing to do with people coming before the board complaining about litter. They came out on their own volition. These people are truly independent citizens. I can say that. I can say that many people have worked hard to make progress on the litter issue, particularly on 255. I think we have made progress and I expect that next spring, as the winter ends, that's when the litter is most visible. I think we're going to have a much improved situation.

Mr. Babcock: Is it true that you asked to have \$150,000 to \$200,000 set aside to pick up trash?

Mr. Prenzler: I don't think I was the initiator on that number. No, I have pushed for adopting the highway program. I think it's positive that we do have a tipping fee fund what's called a host fee fund and that fund is dedicated towards improving the environment. I think it's perfectly acceptable that money is used. It could be used more as they do in Missouri. I could talk a lot about how I see good things happening in Missouri that I would like to see in Illinois, but that's more of an issue with IDOT.

Mr. Babcock: One last question. Again, you got a phone call last week from an individual that asked you to return the money, but until then, you weren't going to return it?

Mr. Prenzler: I didn't want there to be any appearance of a conflict, so I returned it immediately.

Mr. Babcock: After he asked you to do that.

Mr. Prenzler: Yes.

Mr. Babcock: Then he also said if you don't do it, I'm going to call the media.

Mr. Prenzler: No, he didn't.

Mr. Babcock: Yes, he did.

Mr. Prenzler: Were you listening to that phone conversation, Mr. Babcock?

Mr. Babcock: I have firsthand knowledge from the individual that called you up and asked you to return the money.

Mr. Nicolussi: We've heard wild allegations like this, Mr. Babcock. Do you have any proof? I don't want to say you got a phone call. Who actually said it? You said he paraded people out. Once again, do you have any proof that he got people to come up here and speak about the litter? Are you just making things up?

Mr. Babcock: No comment.

Mr. Nicolussi: That's what I thought.

Mr. Madison: Mr. Chairman, I believe the comments are supposed to be made towards the chair.

Mr. Prenzler: I think that Mr. Babcock made an accusation. It was unfair and untrue. I'm just going to leave it there.

Mr. Gray: I just want to thank my constituents that came out to speak on the Staunton Road project, the realignment. Government is at its best when its citizens are engaged. I just wanted to thank them for coming out this evening.

Mr. Stoutenborough: Not only do I want to thank those people that came out and spoke, but I think maybe we ought to go the Department of Transportation and send them back to the drawing board so that these people's properties are respected.

Mr. Schmidt: Mr. Chairman, two things. I want to thank the sincerity of those people who spoke. This is the second time I've listened to them and in both cases, I took to heart what they had to say. I understand that. I lived a Governor's Parkway situation, which I expressed that night, but the Transportation Committee is looking at it. Adam has already addressed it to some degree and sent us an email today. You could probably find that out by calling the Chief Engineer. Is that his correct title? Adam? The other thing, number two, Mr. Babcock, it seems to me that you should be more professional in expressing yourself towards our chairman.

Mr. Madison: Point of order. Comments should be made towards the County Board Chairman.

Mr. Prenzler: Mr. Madison, you're out of order.

Mr. Schmidt: Listen to me. Don't shut me down, sir. Don't shut me down.

Mr. Madison: I said Point of order.

Mr. Schmidt: Don't shut me down. You have no right to shut me down. You have no right to speak over me.
