The following (5) public comments were received and read aloud by County Clerk, Debra Ming-Mendoza:

To: Madison County Board Members

Thank you for allowing me the opportunity to express my views on the request of Mr. Bryan Patel to rezone the property noted above from the current R-3 Single Family Residential to B-2 General Business District. This business, located on Airline Dr, is at the corner of Airwood Manor leading into a residential subdivision with a church and private residence adjoining its property line. Both of these property owners have spoken out in opposition of the rezoning request in addition to a petition list of 204 signatures, of which 182 are Rosewood Heights property owners and taxpayers, also opposed to the rezoning in regards to youth safety, potential accidents, changes in the store's clientele, and current design of the area. In an

informational meeting on Oct 9th, 2019, several residents encouraged Mr. Patel to consider adding a larger grocery line of products or reestablishing a local laundromat in the unused area of the building, but he made it clear to those of us there his intentions were to add the sale of alcohol and video gaming to increase profits to the business. Since 1970, RH Farm Fresh has been a mainstay in our community, patronized by all within, and we want it to stay, but stay zoned R-3. I am a 50 year resident of RH, and like so many others, feel responsible to ensure this area continues to conform to family values. I am currently a local school board member, previous Rosewood Heights Sanitary District board member and past President. I value where I reside and understand how vital it is to maintain a healthy and safe area to entice future homeowners. We, as an unincorporated community, do not have a city, village or town government entity to protect us. We must rely on all of you, and future county board members, to protect us and keep us safe. Please, each of you, focus on our concerns as if this was a property zoned R-3 for 50 years adjoining your residence, now requesting a B-2, giving the current owner or future owners a list of approximately 29 use options to choose from! If rezoned a B-2 for the sale of alcohol at this time, how can we be assured Mr. Patel or a future owner does not, in the future, request a Class "A" liquor license by a future county board? Mr. Patel knew the property was zoned R3 and must have known the minimum wage law was already in place when he purchased the property on Sept 2019 under the name of SSM Dairy Corp dba Dairy Fresh. All business owners realize products, wages, pandemics, etc are valid concerns and must always be ready to address them for the betterment of all. In closing, please vote NO to rezone from R-3 to B-2! Allowing B-2 will just enable Mr. Patel to pursue his final goal to establish a gaming location in our community, which already has four of these locations in our small neighborhood. Thank you.

I am the pastor at River Bend Calvary Chapel, located at 4 St. Kevin Dr., which is the adjoining property on the east side of the Dairy Fresh store. We are not in favor of changing the zoning at the Dairy Fresh store. I feel that if the zoning were changed it would likely change the nature of the store, even increasing the chance that the focus of the business would change entirely. In time, the current owner, or a future owner, could convert the property to a gambling and drinking establishment (which, as you know, was the owner's first intentions). Changing the zoning here would likely increase the store lot's property value, while driving down those of the residential neighborhood. Our softball diamond, which is currently being used by a girls' softball league, is just outside the front door of the milk store, with one of the dugouts no more than 40' away. Girls from the teams frequent the store for refreshments, as do kids from the neighborhood, and youth groups from the local churches. This is the last remaining store in Rosewood Heights in which groceries are sold. There are plenty of places on Airline Drive in which customers may purchase alcohol, but there is only one place that a parent can send their kids to buy milk and bread, along with a candy bar and soft drink. I, and many of the surrounding property owners, desire to keep the zoning as it is. The overwhelming majority of public comments made at previous hearings have indicated just that, as did the 5-0 vote to oppose the change at the recent review board hearing. Please vote "No" on this motion to change the zoning at this property.

County Board,

I would like to thank each and every one of you who are present at this County Board meeting for allowing me to share this message with you regarding the Rezoning of the Milk Store location. It is very difficult to share this message with you by email and then have it read aloud in a meeting. I want you to know that there has been a Town Hall meeting where about 40 people showed up to voice their concerns about this issue nearly three months ago. Each and every one of those individuals were adamantly opposed to the Milk Store changing to a B2. We have since then had 6 more zoning board meetings and county board meetings that we have attended and spoke at each meeting in opposition to this type of business being established in the neighborhood. As Township Supervisor I am involved in many things just like you are when it comes to our districts or in my case Township. This is one of them that I was asked by as many as 30 people to speak on their behalf. All of them opposed to this change in zoning. I might add that we have received over 200 signatures from the people of this Rosewood Heights area. I might mention for full disclosure that about 20 of these signatures are from out of the area but they have lived there before and they have a vested interest in the neighborhood just like we do. Their concern is changing the rating of an R3 building to a B2 zoning for the very purpose of changing it to a package liquor establishment and of the people have the same concern I do that it will not stop there. Their concern is that the owner will eventually get his way and get the pour liquor license and eventually get gaming machine in this small Rosewood Heights town of about 1500 people. Their concerns are real due to the fact that Mr. Patel and his corporation have indicated that this is his intent at this location. He has said this from the beginning and I am certain that this is what he intends to do. I might add that he already has an establishment of this sort and he knows how to get it done again through the County. We as a group of concerned citizens are asking that you please do not allow him to move to a B2 for the very purpose that his full intent is to move to a Pour Liquor license in the back of the store that has plenty of room to open this type of establishment up and then eventually add the gaming slot machines to the mix of things allowed on that location. At this location there is over 1000 square feet of space that was once a laundry mat that has since been closed. This is where he wants to put the gaming location. I will ask you once again: PLEASE do not let Mr. Patel establish a gaming location in our neighborhood by moving him to a B2. This just one step away from getting exactly what he wants. Oh by the way there is already four gaming locations within one mile of the store. I might mention 2 of them are directly across the street. We really do not want any more in our neighborhood!!!Please vote NO on the R3 to B2 zoning change.

We are residents of Madison county, Glen carbon, IL. I am a primary care physician myself working in a clinic in O'Fallon, IL called Family Medical Clinic. It's heartbreaking how COVID 19 is spreading all over the world and taking so many lives. I have been closely following the trends in Illinois as well, where it was primarily distributed in Chicago area and now it has spread quite a lot involving most of the counties in the state, just within a matter of 2 weeks. Looking at our county, it has been on the rise exponentially within the last week or so. We had stay at home order since mid-March. In spite of this, I believe it has lessened the social gathering, but I am concerned this might not be proving to be enough at this point. There might be more opportunities that we can do to lessen it further. I still see a lot of families at various different stores mostly for groceries and home essentials. This certainly is a concern from a family perspective as they need these essentials on a daily basis. There are also a known fact now that asymptomatic patients also linked to spreading the disease in the community. I hope the county is looking at options to eliminate this. Looking at this, I questioned myself how are people not going to come out and stay home, especially when they do need these home essentials. Will it be possible if we have these minimal essentials delivered to each

door so people do not have to wander around looking for these? So this will minimize a great load of social contact that I still see in the community. **Mr. Prenzler:** Yes, any questions or comments?

**Mr. McRae:** Mr. Chairman, what was the agreement? That's news to me.

**Mr. Parkinson:** Tom, it's going to be brought back to the committee to be presented and that's why we're asking for a month on this so it can be brought back to the committee for everybody to review.

**Mr. Moore:** To what committee?

**Mr. Parkinson:** I guess it would be to the Finance Committee.

**Mr. Moore:** The first I've heard of that.

**Mr. Prenzler:** We have a motion to postpone until the next Finance Committee meeting.

**Ms. Kuhn:** I want to hear what Mr. Moore has to say, please.

**Mr. Moore:** I understand there has been a change to the Union agreement between the Sheriff's Department and the Union and that this resolution is something that has already happened. I think it's important for the county to get on the record with a vote today to let people out there know what they thought because what's coming forward is different than what we voted on and discussed on this resolution. This resolution is about giving additional comp-time to all essential personnel in the four departments that are on this resolution. I get a feeling that the new MOU is different and that that we should look at that differently in time but we still vote and discuss this.

**Mr. Parkinson:** I understand but that's why I'm asking to postpone. I made the motion and it was seconded because this is a moot point and is not on the table anymore. So, there's really no reason to even pass this resolution or vote on it tonight until we hear everything else throughout this next meeting.

**Mr. Prenzler:** Mr. Moore, I have a question for you. Does this resolution involve three departments, I'm sorry, four? So the change in the MOU that Mr. Parkinson is talking about, does that involve only one of the four?

**Mr. Moore:** I believe so but I'm not sure. I guess I haven't really heard about this. I only talked to Major Connor just recently that expressed there's another MOU in what sounds more agreeable as a county official than the previous resolution that we're talking about here to vote on. I'm not sure what's forthcoming.

**Mr. Parkinson:** I believe AFSCME is involved with that as well.

**Mr. Gibbons:** The States Attorney's Office is also consistent with the MOU to make changes to our as well.

**Ms. Meyer:** Yes, I'm here. This is Amy Meyer and we'll be working the AFSCME as well. We've already been in talks with them on this.

**Mr. Prenzler:** Back to you, Mr. Moore.

**Mr. Moore:** Ok, I just still feel that it's something that we should take a vote on to let people know how we thought about the original resolution and deal with this new version coming up, I guess, in the near future that I thought we'd still get on the record but we put a lot of time and efforts and expressed a lot of points of view this last week and I just thought that it would be important to, why not just go and vote on this and let Madison County residents know how we feel about the way it was presented.

**Mr. Prenzler:** We have a motion on the floor to postpone until the next meeting. Any other comments or questions?

**Mr. McRae:** Yes, we have spent a couple of hours on this topic and it's about almost \$400,000 and I agree with Mr. Moore. The Finance Committee spent a good deal of time discussing this thing. We actually sort of gave people the weekend between the last special finance committee meeting and the regular finance committee, we gave them four or five days to change that and I think Mr. Moore's right, we should vote this one down if they want something else considered, that should be considered independently, my opinion, because I think this was made in good faith but maybe not thought through as well as it could have been. You know, when we have so many people losing their jobs and all that kind of thing, I think it's a stretch in the end. The Chesterfield Police Department actually just cut their salaries by 10% that was on the St. Louis news a couple nights ago so that they can all stay employed. So, I think this was well intentioned and I agree with Mr. Moore, we should vote it down.

**Mr. Moore:** It's a yes vote because I would like to you agree with the finance committee in voting that down. We have six no's on the finance committee and one yes and one abstention. I'm asking that you agree with the finance committee and voting down this resolution.

**Mr. McRae:** It's a revised resolution to approval additional comp-time.

**Mr. Moore:** It's not intuitive to everyone, I understand, but it's what I'm asking for you to agree with the finance committee's votes and vote down this resolution.

**Mr. Madison:** Mr. Moore, this is Mick Madison, may I help you out?

**Mr. Moore:** Please.

**Mr. Madison:** Don and I had a conversation about this earlier because in the Planning and Development Committee, we affirm or deny what the Zoning Board of Appeals does in turn, then the committee makes its vote and then in turn, the county board affirms or denies the vote or the finding from the Planning and Development Committee. So, in some discussions that we're having today, we're trying to figure out the correct way to do this looks as though upholding the committee's or having a vote on what the committee voted on is maybe the correct way. If the States Attorney's Office would like to weigh in that might be helpful.

**Mr. Gibbons:** To vote on a resolution, it just takes a recommendation of the...

**Mr. Prenzler:** Would you like to sit here, Mr. Gibbons?

**Mr. Gibbons:** I'd be happy to, sure.

**Mr. Prenzler:** Go ahead.

**Ms. Ming-Mendoza:** They're asking for a no vote, right?

**Mr. Gibbons:** Thank you, Chairman, for all those sitting in the room with me today, I'm wearing a mask for your protection, not for mine. I live with an individual who is in nearly constant contact with individuals who \*inaudible\* so I'm doing this for your protection. When a committee makes a recommendation on a resolution, it is definitely a recommendation. The resolution then goes forward to the full board regardless of the vote of a committee and both anew on the resolution so a yes vote is to approve this resolution, a no vote is to disapprove of this. Any questions?

**Mr. McRae:** Ok, that's what I thought, so it is a no vote if you don't want to approve this, it is a no vote. Ok, thank you.

**Ms. Kuhn:** Can I ask a question to the State's Attorney? If I recall correctly, it seemed at one time what happened in committee was that it did not go to the full county board after it failed committee. Am I wrong? I don't know, it seems like that's the way it used to be.

**Mr. Gibbons:** It may have been done incorrectly in the past at some times, but we have consistently given the opinion that regardless of how a committee votes, if a committee bases a vote on a resolution it has to go in front of the county board according to the ordinances of Madison County. So, it's a requirement regardless of how the committee votes; committees do not take final action on issues.

**Ms. Kuhn:** Ok, that makes sense, thank you.

**Mr. Gibbons:** Before I get up from the Chairman's seat, any other questions?

**Mr. Moore:** Mr. Gibbons, if I could just try to clarify again then. So, a no vote by board members means that they disapprove of the resolution and the yes vote would mean that they approve of the resolution.

**Mr. Gibbons:** Yes, Mr. Moore, that is correct. Any other questions?

**Mr. McRae:** Second. I make the motion.

**Mr. Prenzler:** Ok, we do have a motion of the floor. Any other questions or comments?

**Mr. Walters:** Yes, real quick. Mr. Moore, are you wanting a yes or a no vote?

**Mr. Moore:** At this point, it's the opposite but I do want a no vote saying you disagree with giving out the additional comp-time.

**Mr. Prenzler:** Very good, any other questions or comments?

**Mr. Parkinson:** I have a comment. I'm going to be voting no on this not because I necessarily agree with any of it just because it is a moot point and they've already taken it off the table. So, what's the difference, this is all just political.

**Mr. Prenzler:** Any other questions or comments?

**Mr. Guy:** I mean, this is to my knowledge, here just a few minutes ago that this is off the table and I appreciate that but since I haven't seen what the proposal is, I'm just going to follow up what I mentioned in the Finance Committee on Wednesday. First off, thank you to all of our county employees working during this pandemic. Especially thank you to our employees that are still working with the public and thank you to our county law enforcement for working during these difficult times. I appreciate your dedication to Madison County. As we combat this pandemic, we must face the realization that our sales tax revenue has gone down. As of today, the Governor's office estimates Illinois' forecast for sales taxes is down \$737 million. On April 5, Google updated their community mobility report for Madison County. Retail traffic is down -45%, grocery and pharmacy is down -15%, Transit is down -28%, residents traveling to work is down -36%, people staying at home is up 11%. 5 days ago, the Chesterfield police took a 10% salary reduction to avoid being furloughed. With that said, the county can't afford to award nearly \$382,000 in comp time benefits. The majority of the county departments and other countywide offices have not made this request, so thank you for your good management. Awarding \$382,000 in comp time is not something that can continue without raising property taxes. And I ran on a platform to NOT raise property taxes. The good news for our county employees is they are still getting a pay check and have a job. The fact is, we have frontline healthcare workers that are furloughed right now. We have medical professionals that work in our region either at risk of being furloughed and/or not getting paid at this time. 500,000 individuals in Illinois recently filed for unemployment. Thousands are unemployed in Madison County. Thousands of families are struggling in our county to pay their mortgage, pay their taxes and I don't expect them to pay for this comp time. The taxpayers should not have to foot the bill for this. Now is not the time especially during a pandemic to take advantage of the taxpayers in Madison County. Again, thank you to all of our county employees for your public service during this pandemic. I support you making sure you get compensated for your work for the taxpayers. But paying additional benefits for time NOT worked is something the taxpayers can't afford. Thank you.

**Mr. Parkinson:** I'd like to hear from the Sheriff or Jeff Connor on this issue.

**Mr. Prenzler:** Is the Sheriff or Major Connor available to speak?

**Major Connor:** Major Connor is here.

**Mr. Prenzler:** Yes, Major Connor, would you like to speak?

**Major Connor:** Sure. I've been speaking with Mr. Moore and Mr. Cooper and let them know that over the weekend, the Union came to us with a proposal that we negotiated. We believe we came to a fair resolution to this. We are removing all of the comp-times that's been added, it was classified as COVID-19 comp-time, and that is being removed from the payroll because we are going to switch to personal leave, which is a time off and you don't get paid out for that time. So, there's an expiration date of use it or lose it which will give us time to manage the time off in the future. The 300 and some odd thousand dollars in this resolution is not an accurate display of what the actual time would be for our employees.

We think we may have found one and we would like the chance to move towards that along to the States Attorney's Office to see if we can make that happen.

**Ms. Kuhn:** Mr. Chairman? I would like Matt King to speak on this, I think it's his district.

**Mr. Wesley:** I'll second that motion. I think we have to get it out there before we can discuss, is that correct?

**Mr. Prenzler:** We have a motion to postpone, any comments or questions? Any questions or comments on the motion to send it back to the Planning and Development Committee?

**Mr. Chapman:** Yes, sir. You know we've dealt this a lot of time in committee and we've had a whole progression of people that live closest to this establishment express disapproval and I don't see how we're going to be able to find a compromise here.

**Mr. Madison:** Well, maybe you should let me discuss that with the committee

**Mr. King:** Can I please speak?

**Mr. Prenzler:** Any other comments or questions?

**Mr. Walters:** Matt King is trying to speak.

**Mr. King:** This is Matt King, can I please speak, and this is in my district.

**Mr. Madison:** I'm sorry, my word doesn't come up on my picture because I had to call in because of the background noise. This is not what maybe you think it is, the issue that the neighbors have and some of the folks who have been discussed there. The lady that was the person that took around the petitions has had this discussion and then Mike Babcock has had this discussion and the agreed with this possible solution instead of just saying no. Actually, what we were going to vote on was whether we should rezone it so they could have a package liquor license but what the neighbors were thinking is that they would later get a Class A liquor license, not just packaged but open liquor and a gaming license. So, what this compromise could do is take that off the table completely and only address as it should have been anyway, only address the liquor portion. I think we have some agreement there. We would just need to know that we could do it legally for sure. I would ask for a little leeway to see if we can make both parties happy here because I think we may have found the solution.

**Ms. Kuhn:** I think, Matt King, this is his district and has worked on this for a long time so I think I'm going to respect his opinion and I'm going to be voting no.

**Mr. Parkinson:** I do understand Mick's point that this guy's a property owner, however, the majority seems to always rule and Matt seems to have the pulse of his district and I always try to support the person whose district it is and what they want. I've been consistent on that and I urge everybody to support Matt in voting no on this.

**Mr. Walters:** Yes, thank you Mr. Chairman. In this instance, if we vote this down, could the gentlemen still come back to the Planning and Zoning Board with this additional or with this other plan that Mick is talking about?

**Mr. Madison:** I'm sorry, I didn't hear all of the question, Mike.

**Mr. Walters:** Ok, if this gets voted down tonight, can they still bring this other idea before the Planning and Zoning Board?

Yesterday, the Illinois Attorney General issued the following statement, the Office of the Attorney General worked with the multi-agency task force that had initiated an investigation of a certain allegation said Raoul’s Senior Press Secretary, Annie Thompson and an email statement Tuesday after the completion of that investigation, this office concluded that there was insufficient evidence to support charges against any of the potential targets. I’m announcing that as Chairman of the Madison County Board that this is now a disciplinary matter and these charges will be reviewed by an independent third party for investigation. Discipline of these county employees is the prerogative of the Madison County Board Chairman, discharge of administrative employees requires the consent of two parties, the Chairman and the County Board. I’m announcing today that I’m putting Doug Hulme and Rob Dorman on paid administrative leave while a third party investigation is conducted that will frame their activities within the boundaries of the existing policies and procedures of the Madison County Board. I believe this is the best course of action to achieve a fair result, provide due process for the employees and protect the county against future losses.
