Public Comment/Announcements: Dorothy and Toni attended the Opioid Town Hall, February 28, 2018 at Alton Memorial Hospital. Steve Nonn gave an overview of drug overdoses in Madison County. Three categories: homicide, suicide or natural causes. 2018 – 4 (through February); 2017 – 85; 2016 – 71; 2015 - 75. Discussion.

Make Health Happen/Obesity Reduction – Next meeting is March 15, 2018 at 2 p.m., University Extension office, Collinsville IL.


