Public Health Administrator's Report: Introduced and Welcomed Dr. Paul Frohnert, replacing Dr. Yablonsky on this committee.

COVID Update: Madison County continues to be in High transmission (High is >100 cases per 100,000). Today the case rate is 115 cases per 100,000. Approximately 52% of Madison County residents are fully vaccinated.

COVID Boosters now are approved for Pfizer, Moderna, and Johnson & Johnson.

- Pfizer vaccine booster - 6 months after 2nd dose of series.
- Moderna vaccine booster – 6 months after 2nd dose of series.
- Johnson & Johnson booster – 2 months after vaccination.

Vaccination Clinics have been provided by the Health Department on Wednesdays and Fridays for Pfizer, Mondays for Moderna. We are still awaiting for the official CDC approval for pediatric doses (Pfizer only), 5-11 years of age. We are currently working on getting that vaccine and being ready to start setting up appointments. All available appointments at the Madison County Health Department are on our website, www.madisonchd.org.

Reminder, we do not have a Health Advisory Meeting in December.

We are posting the COVID numbers on Mondays and Thursdays only on social media and website. The Dashboard will still have daily updates.
