The following public comments were received and read aloud:

Hello, my name is Nick, I am a musician and team member of KTS. My job is to go on meet ups with Kyle and make sure he has security, should it be necessary, as well as avoid any potential risk to the community. I became involved with KTS and their work when Kyle reached out to me about doing an awareness video and a song for it because I'm a musician. We made one and are working to release it. The video is expected to be released in November and its purpose is to raise awareness on human trafficking and sexual assault. It shows the ugly truth of what happens to the children and the emotional trauma the parents go through. The ultimate goal of the video and our work is to unite and educate. After seeing the work that KTS does, I decided I wanted to be more involved in the process to help save children and make a positive impact on local communities. It has shown me the evils in the world are as close as next door or right in front of us.

The question we would like to pose is what can we do to unite ourselves with the police and law enforcement so we can arrest them?

* * * * * * * * * *

My name is Angel, I am the Business Manager and Head Decoy of KTS Predator Hunters, LLC and the Vice President of KTS: Stop Sexual Assault. We as a team work very hard outside of our full time jobs every day. We are committed to helping bring down child predators in any community that is willing to work with us no matter what state. Whether it's forwarding on evidence we obtain during our chats and letting the proper authorities handle it from there, or exposing them on camera for the areas that do not return our calls or e-mails. I am writing because in a previous e-mail from September of 2019 that Kyle and I received on behalf of the team, Mr. Gibbons stated, "We can only prosecute cases that meet the extremely rigorous standards for sufficiency and admissibility of evidence required by the Constitution, Illinois Law and the Supreme Court rules." When we met last year, we talked about the methods your group employs do not appear to meet those standards." I would like to ask what his standards are that need to be met? Other states including Alabama and Pennsylvania have had no issue with our work and being able to make these arrests. They were very thankful for what we do and responded quickly and were able to make arrests in a timely manner and by the book. We are willing to work with the local police departments or county and state agencies to assist them with getting these predators off the streets. We have followed the guidelines that were given to Kyle in their in person meeting with still no follow through from the States Attorney.

* * * * * * * * * *

Good evening, I want to thank you for the time and opportunity to discuss something so near and dear to my heart. My name is Sarah Battig, I am a 42 year-old mother of two. During my childhood I was placed in multiple sexual situations that ranged from inappropriate to illegal. The one with the most profound effects on me was being molested by my second step-dad. I was FOUR when it started and ten when it ended. I remember some of those moments like I remember the birth of my children. The clarity and emotion is overwhelming and I am stuck with a life sentence while he runs free. There were so many systems in place that I, as a child tried to utilize, yet was failed time after time.

1. I told my friends parents.

- My friends were no longer allowed to play with me.

2. I told my Mom and she told some family.

- My mom decided to stay with him and one of his family even vowed to keep me safe from him while my mom was at work. That same family member continuously left me alone with him and the abuse continued.

3. Someone who knew about the situation (SO MANY people knew) called DCFS on him.

- DCFS investigated and found cause and gave my mom the option to press charges. She was married to his step-brother and chose not to press charges.

4. A few years later, as a Freshman in high school, even though I was not his step-daughter, I was still dealing with the devastating effects of what I had been through (as I am still dealing with to this very day) I decided to tell my freshman English Teacher in a classroom journal assignment.

- Nothing was reported to anyone by this teacher. It wasn't reported to the school Social Worker, Guidance Counselor, Local Authorities, or DCFS. Years later through the power of Facebook, I found my abuser and that same high school English Teacher in photos together.

5. 14 years after going to my teacher I worked up the courage to go to the police.

- I was told I was past my statute of limitation. Through some recent help from the Law Library at the Madison County Court House last summer, I found out that back in 2007 I was not past my statute of limitations, but now I am.

This was just the worst of many sexually inappropriate situations I had to face as a child. This one had the most far-reaching long term effects. Effects like self-harm, depression, anxiety, low self-esteem, and always feeling like an outsider (different from everyone else). There are countless ways this type of abuse can weave its way into the fabric of your being and completely distort the person you truly *could have been*. Please tell me what a child is supposed to do when literally everyone else in their life fails them? I am thankful every day for KTS. A group of private citizens investing their time and their own money to take a stand against something when they have absolutely nothing to gain from it.

What does KTS Predator Hunters mean to me? It means that when every single system in place fails the next littler girl, she might still have a chance at happiness, a chance at a level of peace and normalcy that most people take for granted. KTS means that predators now need to be afraid that their lies, manipulation, and absolutely disgusting behavior will no longer be swept under the rug. My ex step-dad went on to molest/rape numerous other children we are all stuck with a life sentence while he roams the streets of Bethalto. Please tell me Mr. Prenzler and the Madison County Board, what are you willing to do to keep from failing this next generation of children? Thank you again for your time and consideration this evening. Sarah Battig, Suvivor, Parent, Concerned Citizen, and Taxpayer

Hello, my name is Whitney, I am the Office Manager and HR Assistant of KTS Predator

Hunters, LLC and the Secretary of KTS: Stop Sexual Assault. We, as a team, work very hard between our full time jobs every day to gather evidence to stop these predators in our communities. We are committed to helping bring down child predators in any community that is willing to work with us and even those who are not depending on the circumstances. We do everything from forwarding on evidence we obtain during our chats and letting the proper authorities handle it from there, real time coordination with local authorities to organize an on the spot arrest or exposing them on camera for the areas that do not choose to work with us or do not respond in a timely manner with further guidance. Other states are actively willing to accept our tips and evidence and to prosecute as necessary. We are willing to work with the local police departments or county and state officials to assist them with getting these predators off the streets. With our non-profit we are launching, we intend on the ability to take tips individuals send about potential predators and forward them on to the proper authority as well as provide support and resources to victims of sexual assault with encouragement and guidance to seek the help and counseling they may need after such abuse.

* * * * * * * * * *

My name is Kyle Swanson and I am the owner of KTS Predator Hunters, LLC and President of our up and coming non-profit KTS: Stop Sexual Assault. I wanted to come before you to speak on who we are and what we do. KTS Predator Hunters, LLC sets up decoy accounts on Facebook and dating apps. We use pictures of women who are of age but look under 18 and have signed release forms for the use of their pictures. We do not make first contact with anyone. We set the accounts up and let people add us and message us first. We immediately tell them our age within the first 5 messages. We act completely innocent and do not talk in sexual nature. As soon as the other individual talks in sexual nature to our decoy, we alert authorities with our evidence in hopes of charges brought forth. We have successfully worked with Scott Air Force Base, Pike County and Fayette with 3 convictions in their county. Aside from Illinois, we have worked successfully with Texas, Alabama, Pennsylvania, Wayne County, Missouri and currently have ongoing investigations in both Tennessee, Wyoming, and currently one in Greene County and Jersey County in Illinois and an upcoming court date in White County. KTS has a team of adult decoys that run our accounts. We all have full-time jobs outside of our team. We do not profit from what we do and the convictions we bring forward. We have reached out to States Attorney Gibbons and had a meeting when we first started KTS to only be denied of acceptance of our evidence. We have also sent an e-mail in September of 2019 in hopes that Mr. Gibbons would have had a change of heart since we had started to bring down convictions in the state of Illinois. Again, we were denied. We have called many police departments in Madison County before we did video busts to let them know there was going to be an exposure to only be told there was nothing they could do. We are willing to do whatever it takes to prosecute these sick individuals that pose a threat to our children and community. KTS will not stop exposing these individuals. We will continue to grow and spread the awareness. Thank you.

WHEREAS, the Park & Recreation Grant Commission and the Grants' Committee recommend that the loan be approved;

NOW, THEREFORE, BE IT RESOLVED by the County Board of the County of Madison, Illinois that it hereby authorizes a maximum Park & Recreation Loan of \$45,000 to Village of Worden contingent upon: (1) the Village complying with all applicable federal, state and local regulations; (2) the Village demonstrating that it has adequate funding to complete its park project; (3) Madison County, the Village and any other funding sources negotiating mutually satisfactory security agreements for the park loan; and (4) the Village agreeing not to initiate its proposed park project until it has received a "Notice to Proceed" from Madison County;

BE IT FURTHER RESOLVED that this loan be made for a four year term at three percent interest to assist in funding Village of Worden's park project.

On the question:

Mr. Chapman: This is for non-bargaining unit employees. I wish to commend Chairman Harriss and the entire committee on their excellent research on this issue. The resolution is in response to an anticipated shortfall of 2021 revenues caused by the Covid-19 epidemic.*inaudible* nor the impact on the Madison County budget. It appears we face a critical shortfall due to fewer sales tax receipts and fees. A reduction in the COLA, which some may view as arrays will allow us to remain within budget and help us to ensure receipt of equal expenses. In addition, we hope it will allow all those currently employed by the county to keep their job. This seems a small price to pay to keep our many fine workers in place to provide high quality services to our county residents, some of which were fired, furloughed, and who remain unemployed. This resolution will save approximately \$1 million. I will vote yes.

Mr. King: I have some questions, I'm having a hard time with this. We say it's because of Covid and correct me if I'm wrong, but a lot of this Covid we're getting reimbursed on many levels. I know we just got \$4

million tonight for the Health Department that Toni Corona did concerning the Covid monies. Why are we just finding out right now and please give me an updated figure, I've heard 6 million, I've heard 3.4 million. Why are we so broke? And do we not have any reserves? Don't get me wrong, I've worked in government for quite a few years now and under Republican administrations and Democratic administrations, but it seems like there's always something there for a rainy day in case because you always plan for the worst and hope for the best. Now, this almost seems like one of those times it fits the head. So I'm a little confused about that. I'm also, for the rest of you, I'm on the Tax Cycle Committee and each month we ask everybody to give a report and, you know, the last couple months with the tax cap, we lowered the cap, we were told, well, that's ok because our EAVs are 3-5% throughout county, we're doing good, it's solid, even though we know there's a projected shortfall on sales tax because everybody is going to have a projected fall in sales tax. We know that already. Everything's a projection right now. We don't have solid numbers on that. It seems like we're trying to do things and not knowing exactly what the numbers are going to be. Then of course, we got as you know, we got an election coming up. Can't we negotiate and look at this a little harder for the next two months? I mean, I think we have time, don't we? We have to do this tonight? This has been brought up and if you could answer some of those questions, I'd feel a little better. Thank you.

Mr. Prenzler: Would anyone like to answer any of those questions or speak on those topics?

Mr. Moore: Just one thought to answer one of Mr. King's concerns. As he recognizes, we're going to have a loss of taxes so that's going to be an impact, but I like the Covid money he talked about, that's strictly for contact tracing so that money and other monies coming in at this point, could not be used to offset tax losses. I think we're still going to have to absorb that loss for taxes if that helps at all.

Mr. Parkinson: We can blame this on whatever we want, you can tell whatever story you want, but I told you two years ago that by the end of this year, you were going to be broke. It was back when Lisa Ciampoli, myself and Eric Decker did the budget for you because your guy couldn't do it. And I told you at the end of this year you're going to be broke. And here we are, we're broke. You kept spending money, you kept hiring your friends, and all these people in office are getting exorbitant amounts of money, and we kept telling you to stop it. Now here we are, and we're broke. And now you're going to put it on the backs of the workers for Madison County to do these things day in and day out to keep this county going. You can blame it on Covid all you want, but you're responsible, you and your administration.

Mr. Moore: Mr. Chairman, point of order.

Mr. Prenzler: Yes.

Mr. Moore: I thought we were trying to answer Mr. King's questions at this point, trying to answer his concerns.

Mr. Prenzler: That's true, any other comments or questions?

Mr. Madison: That was demagoguery during an election year by Mr. Parkinson. Now, we've run a tight ship, that's a good thing, not a bad thing. I believe Mr. Parkinson voted for all the budgets, I could be wrong, but that's the way I believe it went down. People out there, the taxpayers, who provide our budget, we do this for them, not for us. They're hurting right now. Many, many of them are hurting and we know that, we see it every day. We hear from friends and family every day. We see it on the news and it's up to us to tighten our belt. We've already given a break on property tax payments and so we know that this is going to be coming down the road. It's up to us to adjust and act accordingly. Thank you.

Ms. Harriss: We can call this whatever we want, but what we're looking at is a revenue shortfall that we believe is going to last into the next year. I've heard numbers between 3.1 million to 3.4 million based on

our current numbers of shortfall of revenue. Department Heads met for finding out a voluntary cost savings, ways that they could defer spending and other ways to save money. I believe that about 1.2 million was saved that way. So, to answer your question, Mr. King, this wasn't just the first mode of looking to save money. There was a meeting with Department Heads where thankfully many of them were able to come together to come up with some savings, but clearly, we know that we are going to need to potentially look for some other avenues there because Covid is not going away and therefore our sales taxes is going to be down. I think something that is important to remember is that this is a COLA. I know that we've been talking about that as a raise. To be clear, a raise would be our step plan which will not be affected by this. COLA, remember, is cost of living expense and that was something, I think, this board hashed out pretty strongly a few years ago on really saying the difference between a raise and a cost of living. I think it's notable too, to know that if we look at federal COLA guidelines, just to see how we are in line with them in 2019, the Federal COLA guidelines for 2.8 in 2020, they were 1.6 and expected for 2021 it's expected to be 0.3. If that helps you see maybe the federal perspective and to remember that this is cost of living, not a raise and this does not affect anyone's step plan activity.

Ms. Ming-Mendoza: My office, the County Clerk's Office, gave money back too so it wasn't just Department Heads. I don't know about what the other electeds did but the County Clerk's Office stepped up and gave money back to cover the losses also.

Mr. Prenzler: Yes, mid year, yes. Any other board members?

Mr. McRae: I was just going to say that I would like to hear from the Auditor's Office as well on projected revenues. It is a fact that sales tax revenues, and I'd love to hear an updated number because, as Ms. Harriss mentioned, it is kind of a moving target. And I appreciate, you know, I mean, there's a couple things I'm really proud of. I'm really proud of the fact that during the whole Covid pandemic, we didn't panic, you know, and we never laid off a single person or furloughed anybody and we did our best to allow county workers to work from home. I think without laying off anyone or furloughing anyone. I'm also proud of the fact that we've kept the property tax levy flat for now for hopefully four years in a row. And it's easy to raise, that is the easy thing to do, is to raise property taxes. The hard thing to do is to sit down and try to find out ways to make small sacrifices among the larger group of people and I think this is one step in doing that and I appreciate Ms. Mendoza, and others who did so voluntarily to find some ways to save some money. That's not me. Anyway, I think I would like to hear what the Auditor has to say about projected revenues, but this is probably one small thing that we need to do, just to make sure that we're as ahead of the game as possible.

Mr. Faccin: We have some projected revenues, I'm going to call on Jennifer for an active number on what the shortfall would be, but it's important that this will not affect this year's budget. And as you all know, I've been out, I'm planning on coming back in September, God willing, and I've got some other comments on areas of concern that I won't bring to everyone's attention tonight. But there are some things looming on the horizon that I will in September piggyback Mr. Parkinson's comments on some things because we're heading to a very expensive process, but I'll hold off on that. If we can Mr. Chairman, the two things I want to note and Tom has brought attention to it is that this does not affect this year's budget, but moving forward, it will. I'm going to call on Jennifer now to give some projected shortfalls or revenue, so Jennifer, if you would with everyone's permission.

Ms. Zoelzer: I've revised projections based on what we've actually received through June 30th, I'm still finalizing July numbers and again, this is based on, you know, there's a delay in the state remitting sales tax to us so the actual taxes we've received through July are only through the month of March. So it's just hitting the tip of the Covid iceberg there. But based on revising projections, we're looking at the revenue falling about 3 million under what we had projected. And then along with what our budgets are the original approved budget added to the reappropriation requests that were approved, that would get us to a \$3.7

million deficit for the general fund, only for 2020. So I know some of that 3.7 is being offset by the voluntary budget cuts that Department Heads and Elected Officials had discussed with the County Board Office earlier in the year. These shortfalls, even with all of the federal and state money we have, we're not allowed to use those to offset the revenue that have been lost. We can use them to offset some of our expenditures that we've incurred, which will hopefully reduce that 3.7 somewhat, but we are looking at being approximately \$3 million under what we projected for revenues based on where we're at.

Mr. Parkinson: So, back to what I was saying, this was projected long before Covid hit. I'd like to, I mean, clearly, I'm not one that wants to go into deficit so I'm not saying that I'm not in favor of cuts. I'm just saying that this is not just because of Covid. This is because overspending, over expenditures over the last three years and there was a proposal made to you, Mr. Prenzler, to cut some of your benefits and salary out. I wonder if you're going to do that to help taxpayers as well.

LETTER OF UNDERSTANDING AIRPORT ROAD/LARS HOFFMAN CROSSING MADISON COUNTY

The intent of this improvement is to construction a roadway from the end of Lars Hoffman Crossing westerly to approximately 600 feet west of Davis Lane. Pierce Lane is to be extended northerly to intersect said roadway with a roundabout configuration. The alignment will be in accordance with Exhibit "A".

In order to advance this improvement which is desired and will be of benefit to the residents of Madison County, as well as the Village of Godfrey and the traveling public, it is necessary that MADISON COUNTY and the VILLAGE OF GODFREY agree to the responsibilities of each party for the improvement. This Letter of Understanding and the acceptance thereof by the County and the Village of Godfrey shall constitute such agreement. A Jurisdictional Transfer Document will be processed upon completion of the construction. These responsibilities are as follows:

- 1. MADISON COUNTY agrees to make the surveys, obtain all necessary rights-of ways, relocate necessary utilities, prepare plans and specifications, receive bids and award the contract, furnish engineering inspection during construction and cause the improvement to be built in accordance with the plans, specifications and contract and will pay all costs thereof.
- 2. The estimated cost of the improvements is \$5,725,000 to be funded by MADISON COUNTY.
- 3. The typical section from Lars Hoffman Crossing to the roundabout shall be 2 12' lanes of PCC Pavement with 6' PCC Shoulders and B-6.24 PCC Curb & Gutter and storm sewer with a 5' PCC Sidewalk.

- 4. The typical section from the Roundabout to Pierce Lane shall be 2 13' lanes of PCC Pavement with B-6.24 PCC Curb & Gutter and storm sewer with a 5' PCC Sidewalk.
- 5. The typical section from the Roundabout to Airport Road shall be 2 12' lanes of PCC Pavement with 8' HMA Shoulders and open ditches.
- 6. Upon completion of construction, the improvements to Pierce Lane, the Roundabout and the sidewalk along Lars Hoffman Crossing shall be the maintenance responsibility of the VILLAGE OF GODFREY. The improvements to Airport Road from the Roundabout to the west shall be the maintenance responsibility of MADISON COUNTY. Lars Hoffman Crossing from Godfrey Road to the Roundabout shall become the maintenance responsibility of MADISON COUNTY. The maintenance of Airport Road from Godfrey Road to Pierce Lane shall become the responsibility of the VILLAGE OF GODFREY. Airport Road from Pierce Lane to Davis Lane shall be vacated.
- 7. The VILLAGE OF GODFREY is under no obligation to make any improvements to Airport Road from Godfrey Road to Pierce Lane. The Village may, however, engage in preliminary engineering work for potential improvements to Airport Road from Godfrey Road to Pierce Lane provided that sufficient notice is given to Madison County if said engineering is to begin prior to the jurisdictional transfer.
- 8. It is mutually agreed that the covenants contained herein shall be null and void in the event the contract covering the construction work contemplated herein is not awarded within three years subsequent to execution of the agreement.

NEW BUSINESS

Mr. Madison: Regarding the public comment that we received prior to the meeting regarding KTS Predator Hunters, LLC; a friend of mine a few weeks ago, reached out to me and asked me what was going on with Madison County in this case. He wanted to know what the heck was going on in Madison County, I had no idea what he's talking about and I haven't seen anything in this group or anything and so I looked them up. I started seeing a lot of things on social media, good stuff and there were a lot of people in sports since then I've seen a lot of social media comments regarding Madison County and I'm not sure what the law says, I'm not an attorney. I did speak to the Sheriff of Pike County and he told me how he's worked with these folks and basically that when they brought him a lead of someone that they had found trying to prey on a child on social media, he just used the evidence that they provided and started his own investigation. I wonder if with the comments that I hear, I know I'm only hearing one side of the story, I haven't spoken with the Sheriff or the State's Attorney. I've just, you know, I would like to see the Sheriff's Office and the State's Attorney's Office work together and try to use some of this evidence to maybe catch somebody that might be easy to catch and deserves to be caught. We don't need anybody going through what the lady that commented, what a horrible thing that she's had to endure in her life and she's not the only one and no one should have to do that. I would really like to see us a little harder to maybe work with KTS and other groups like that can provide leads. We don't want to do anything, obviously outside the law, but I think we can take leads and work with a group like this that might be trying to actually do some good so that I just wanted to say something. I know the Madison County proper County Board doesn't have any control over this with the Sheriff's Department and the State's Attorney's Office, but I think somebody needs to say something because I've seen so much comment on it and I think we ought to look into it. That's all I want to say about it, thank you.

Mr. Lakin: In response to Mr. Madison's comments there, we did try to reach out to KTS, but there is a meeting tomorrow meeting with them. And I know there was some discussion that has been spewed out there and passed along that the Madison County Sheriff's Office does not pursue these types of cases. Since 2015, the Sheriff's Office, just the Sheriff's Office alone, has presented 155 cases to the Madison County State's Attorney's Office. That does not include any cases that we work with the federal authorities, any other cases that we worked with any other agency, any assistance to anybody on these type cases. We do plan to meet with these folks, but there are a set of constitutional guidelines that we have to follow to make sure that these cases are presented properly. And I certainly wouldn't want anyone to think that the Madison County Sheriff is not trying to work with and try to protect and safeguard some of our most vulnerable victims.

Mr. Madison: Yes, I'm aware and I appreciate your comments. That's why I said, I've only heard one side of the story, so I just wanted it out there. I'm glad that you guys are meeting with them, I hope it can turn into something productive, thanks for your comment.

Mr. Petrillo: In these comments that were made previously, I agree with Sheriff Lakin and we've done a great many things. We're not going to be perfect, but I did hear DCFS mentioned, I did not hear Child Advocacy Center mentioned which has been a quite a force in trying to bring these types of issues of young

children to the forefront and we know that the process that they go through is extremely thorough, and very well done. I think when these people actually sit and talk, they'll find out that Madison County does a pretty good job.
