#### **Illinois Environmental Protection Agency**

Public Notice Proposed Issuance of a Federally Enforceable State Operating Permit Midwest Metal Coatings, LLC in Granite City

Midwest Metal Coatings, LLC has applied to the Illinois Environmental Protection Agency for a federally enforceable state operating permit (FESOP) regulating air emissions from the facility, which is located at #9 Konzen Court in Granite City. The source is a metal coil coating plant. The Illinois EPA has reviewed the application and made a preliminary determination that the application meets the standards for issuance and has prepared a draft permit for public review and comment.

The Illinois EPA is accepting written comments on the draft permit. Comments must be postmarked by midnight July 24, 2020. If sufficient interest is expressed in the draft permit, a hearing or other informational meeting may be held. Requests for information, comments, and questions should be directed to Veronica Tellez, Office of Community Relations, Illinois Environmental Protection Agency, P.O. Box 19506, Springfield, Illinois, 62794-9506, phone 217/782-7027 (please call ahead to assure that someone will be available to assist you). The draft permit and other documents may also be available at <a href="http://bit.ly/2SiUSql">http://bit.ly/2SiUSql</a>. Copies of the documents may also be obtained upon request to the contact listed above.

The 1990 amendments to the Clean Air Act require potentially major sources of air emissions to obtain federally enforceable operating permits. A FESOP permit allows a source that is potentially major to take operational limits in the permit so that it is a non-major source. The permit will contain federally enforceable limitations that restrict the facility's emissions to non-major levels. The permit will be enforceable by the USEPA, as well as the Illinois EPA.

# RESOLUTION TO PRESENT AN ADVISORY PUBLIC QUESTION VIA A COUNTYWIDE REFERENDUM ON WHETHER RETIRED EMPLOYEES AND OFFICIALS SHOULD BE PERMITTED TO DOUBLE DIP

**WHEREAS,** Pursuant to the Illinois Election Code, 10 ILCS 5/28-1, et seq., and the Counties Code, 55 ILCS 5/5-1005.5, the corporate authorities of a county have the authority to submit a public question to the electors of the county by means of a referendum; and,

**WHEREAS**, Illinois's pension systems are significantly underfunded with total pension debt in excess of \$200 billion dollars; and,

**WHEREAS**, there has been a practice throughout Illinois, including in Madison County, whereby retired employees and officials receiving a pension for prior government service to Madison County are then rehired or elected to a different position within Madison County's government; and,

WHEREAS, this practice of "double dipping" is disrespectful to the taxpayers in that certain individuals are permitted to draw a taxpayer provided pension while also earning a new salary as an

employee in a different position, or as an elected official, in the same unit of government the said individual has purportedly retired from; and,

**WHEREAS**, there are many current employees and office holders serving Madison County who are presently drawing a pension from prior service to Madison County in another position; and,

**WHEREAS**, other individuals who have purportedly retired from service to Madison County have formed a company or corporation for the purpose of becoming an independent contractor engaged to perform the same functions and duties as the individuals performed while an employee of Madison County; and.

**WHEREAS**, the practice of contracting with retired employees to perform the same functions or duties as they did prior to retirement is unfair to the current and potential employees of Madison County and to the collective bargaining unit representing those employees; and,

**WHEREAS**, as a matter of public policy in the government of Madison County, Illinois, individuals should not be permitted to "double dip" in this manner; and,

**WHEREAS**, the voters of Madison County should have the opportunity to express their views on this important issue in the form of an advisory referendum; and,

**WHEREAS,** 55 ILCS 5/5-1005.5 states, "By a vote of the majority of the members of the county board, the board may authorize an advisory question of public policy to be placed on the ballot at the next regularly scheduled election in the county."; and,

**WHEREAS**, the Madison County Board seeks to place an advisory public question before the electorate via a referendum on the November 3, 2020, countywide ballot seeking to ask Madison County voters if retired Madison County employees and officials should be permitted to draw a salary for service in another position or as an independent contractor of Madison County as follows:

"Shall retired Madison County employees and officials drawing a pension be permitted to also draw a salary for service in another position as an employee, official, or independent contractor of Madison County?"

### On the question:

Mr. Moore: This is something that's been talked about for quite a number of years, I say that based on my 3.5 years of experience here and it's sort of an accepted policy, it seems, within the county that officials, whether they're elected or just employees that retire from the county and then take another job within the county. So, they have their pension coming in automatically now, and then they receive a payment in the form of salary from their current position from the county. This is turning into quite a lucrative deal for past employees right now and potential future employees. I think it's something that we should look at given what's going on in the state of Illinois with the budget. This is something I think Madison County, again, has the opportunity to show some leadership within the state of Illinois and see if we can push back on this and continue this trend or at least try to slow it down a little bit. Money is at stake. It may not be money for Madison County, because pensions are paid from throughout Illinois, all taxpayer pay those pensions but if we can do something to try to curb the tide of this present policy, I think it's worthy of discussion. What we're doing though, is going through a three phase process. We talked about that committee and that did pass, we're talking about it now today and we're going to see if it passes, then the opportunity for the taxpayer to take a look at it decide if they think it's something the county should continue or maybe discontinued.

**Mr. Holliday:** I was looking at this whole resolution, and for me, this resolution is going to eliminate people from being able to get jobs that may have some time from other places. It's not double dipping. I think this is toward the fact that we had a sheriff's department guy retire and come back and work for the county; that incident is saving the county money. I think this resolution has no bearing on anything that is good for the county, that it's just something that been whipped up to say that something is being done but there is no legal evidence that this is going to help the county.

**Mr. Chapman:** I looked for the resolution and I didn't see it here in my papers. Would this, more or less, try to preclude people who have served in the military who may be getting a pension or in federal civil service after they retire? Would that be considered double dipping if they were elected to a county board seat or a county constitutional office? According to this document, would that be considered double dipping? It's a question, an honest question.

**Mr. Guy:** Mr. Chapman, excellent question. No, that would not. This is a non-binding question on the ballot. The question reads as follows, "Shall retired Madison County employees and officials drawing a pension be permitted to also draw a salary for service in another position as an employee, official, or independent contractor of Madison County?" This does not pertain to if you're an individual that served our country at the federal level and moved here or retired from the federal government and wanted a job at the sheriff's office, this does not prohibit that. Keep in mind, this is non-binding.

Mr. Hankins: First, I would like to start with my family nor myself, all work or have worked in the private sector. This includes my grandparents, my parents, my in laws, siblings, and even my daughter, none of us have ever worked a full time government agency job that would provide benefits. I've got the question why this resolution labeled D1 for the non-binding referendum, why it's happening and why it's happening now. I've seen employees hired by the current administration on similar pensions, maybe through the state or other ones, multiple times. I see people on this board, they draw consulting salary. I see other people that their families have jobs at the county, both parties. So to pull this one out, I just think it's funny. I think there's a similar situation where we had people leave I.T. and we replaced those people with Ace Tech, I'm told that it would save the county money; that was a no bid contract for professional services, very similar to the situation at the sheriff's office. I am told that is a savings to the county also. So why do we look at this now? I hear it's been going on for years, and there happens to be a thing called an election in November, let's bring this up. I see people call it the Good Old Boys, but with the Good Old Boys, I see them actually put their people in. And so it's kind of funny that we're going to bring this up now. I'm very disappointed that this has come up. I keep coming to these meetings, hoping for the best and I see political, political political. That's what I got, Mr. Chairman. Thank you.

Mr. Madison: Well, I agree with you, Chris completely. It has happened on both sides, it's happened for a long time. The reason it has come up right now is because it just happened in the sheriff's department and they went around the finance committee and did it regardless. I don't care if you're Democrat or Republican, every time that we've done it as a party, it's aggravated me to no end just as much. I disagree with policy, I will say that I have no problem if a veteran comes in and wants to work a government job, I'm ok with that. I give military people a pass on this, not that it's up to me, but that's the way I feel about it. I do feel that when we do this, people look at it, taxpayers look at it as a Good Old Boy situation. And I think anybody that for this or thinks that it is partisan, I think, I'm not even going say that. When I see people do this, it looks to me like they think that their neighbors or taxpayers are their own personal cash cow. That's the way I feel about it. I'm not trying to insult anybody. I know it's not illegal yet, but I think it may be about to be in January. Regardless, it should have been a long time ago. I'm happy that it's going to happen. I'd like to hear what the taxpayers have to say because I'll bet they agree with Chris and I. Thank you.

**Mr. Holliday:** The way that I kind of understood what he said was that like, myself, as a county board member, if I was to run for your position, or auditor or any other county office that would not be allowed? Is that what he's saying also?

**Mr. Guy:** No, your question that would not apply. Again, this is advisory, what's happened is, I know quite a few of my colleagues on the board, I've heard from constituents and comments about this issue of double dipping going on in Madison County. And after collaborating with several we thought, hey, let's draft something, bring it forward to the board and let the voters decide and just let the voters have a say and let their voice be heard on this issue. And, and there's a law that changes in January, but this gives the taxpayers of Madison County to weigh in, and then we can go to our lawmakers and they make some improvements.

Mr. Parkinson: I appreciate the discussion on this. It's widely widely known that I brought up your abuses, this administration's abuses with Steve Adler on this issue over and over again, to the point where we're all tired of hearing me saying it. Your people hired under your administration, your EMA Director, Todd Fulton, a pensions a pension, you can't pick and choose which pensions you think are double dipping and which ones aren't. Mr. Moore, you've got a pension, you're double dipping, you're taking more money out of taxpayers. Taxpayer dollars are taxpayer dollars, we can't pick and choose. If this was a binding resolution, I would almost bet you that would be illegal and the State's Attorney's Office would confirmed that. You're hiring records of people not approved by this board, we talked to needing to put it in front of the board, they pulled it out and they did it themselves. They're allowed to do that. You've been advised that by the state's attorney, that they're allowed to do it the way they did it, that they're within the law, but you're hiring records of people not approved by this board Cynthia Ellis, Cooper, Thompson, it's all of a

hypocrisy. As a matter of fact, your record of hiring in general is terrible. I mean, how many people that you've hired...

Mr. Prenzler: Mr. Parkinson I think you're out of order, you're not speaking on the issue.

Mr. Parkinson: No, I'm not out of order, Kurt.

Mr. Prenzler: You are out of order.

Mr. Parkinson: I'm not out of order, let me finish, Kurt.

**Mr. Prenzler:** I'm very proud of the fact that I've hired people out of the private sector and I think they've made a great difference.

**Mr. Parkinson:** I'll get back on point. So, then you have people on the county board that are double busy, that are taking salaries from the Transit District, I believe it's about \$36,000 a year. Nobody's questioning that. Is anybody going look into that?

**Mr. Madison:** I think that's what we're doing right now.

**Mr. Parkinson:** Well, I mean, if you're going to bring it up, lets talk about all of it. You can't pick and choose what's a pension and what's not. And it's also your...

**Mr. Madison:** I just did bring it up.

**Mr. Parkinson:** Mick, I didn't interrupt you. Mick, I agree with you, I'm not disagreeing that you didn't say that alright? What I'm saying is you can't pick and choose what pensions you're talking about. I do understand this is non-binding, but pensions are pensions and people who are double dipping are double dipping. This is not a person double dipping, the way this was explained to me is this is a corporation that was hired, just like Ace Tech downstairs. We could break it apart and make determinations all we want, but the legality of it is it is legal, if the legislature wants to change it then so be it. I'm not arguing with what the legislature is going to do, but if you're going to look at one thing, we're not going to make a political issue out of one thing, if there's many things that shouldn't be looked at. Thank you.

**Major Connor:** Sheriff Lakin was unable to be a part of today's meeting because of a medical procedure this morning, so he asked me to convey a message to the county board. What he was saying is that as your elected Sheriff in Madison County, Sheriff Lakin strives to find ways to protect the citizens of Madison County and the brave men and women of the Madison County Sheriff's Office. Sheriff Lakin also continues to find ways of saving money for the taxpayers of Madison County and he asks the county board to support him in his effort to saving taxpayers money, thank you, stay safe and God bless everyone.

**Mr. Faccin:** I'm going to piggyback what Mr. Parkinson said but I want to add this too. Now, you know, I questioned the legality of this, are you inviting another lawsuit because I'm coming in with a with a litigation expense report.

**Mr. Prenzler:** Mr. Faccin, I think you're off topic, this is an advisory referendum to get a sense of the people, that's what an advisory referendum is.

**Mr. Faccin:** But Kurt, I think people have to understand what the repercussion of this could be. The repercussion of this could be, if passed...

**Mr. Prenzler:** Mr. Faccin, it's an advisory referendum, we're going to stay on topic here. Any other folks would like to speak? Go ahead.

Mr. Holliday: You're not going to let Rick continue to speak?

Mr. Faccin: Yeah, I'm not through yet.

Mr. Prenzler: Mr. Faccin is out of order, he drifts off the point, he is not acknowledged.

Mr. Faccin: No, I'm not off the point, Kurt.

**Mr. Prenzler:** Mr. Faccin, you're out of order, you're not a county board member and I let you speak today. You go out of order, like you go outside the lines. You are out of order and I'm directing you be muted. Any other county member that would like to speak? Hearing none, roll call.

# RESOLUTION TO PRESENT AN ADVISORY PUBLIC QUESTION VIA A COUNTYWIDE REFERENDUM ON WHETHER MEMBERS OF THE ILLINOIS GENERAL ASSEMBLY SHOULD RECEIVE AUTOMATIC SALARY INCREASES

**WHEREAS,** Pursuant to the Illinois Election Code, 10 ILCS 5/28-1, et seq., and the Counties Code, 55 ILCS 5/5-1005.5, the corporate authorities of a county have the authority to submit a public question to the electors of the county by means of a referendum; and,

**WHEREAS**, in the past few decades the State of Illinois has maintained a reputation of being one of the most fiscally mismanaged states in the nation; and,

**WHEREAS**, Illinois's pension systems are significantly underfunded with total pension debt in excess of \$200 billion dollars; and,

**WHEREAS**, the total debt of the State of Illinois is consistently among the highest of all states in the nation totaling trillions of dollars; and,

**WHEREAS,** Illinois has among the worst credit ratings of all states in the nation, leaving Illinois with a consistent negative fiscal outlook and a near "junk" credit status; and,

**WHEREAS,** Illinois has been unable to pay its vendors or its bills in a timely manner with some vendors waiting nearly two years to receive payments for services rendered to the state; and,

**WHEREAS**, for nearly two decades Illinois government has failed to address or reverse the trend of rising debt, excessive spending, waste, imbalanced budgets, occasionally the lack of any budget at all, credit downgrades, ever increasing pension obligations, and the inability to pay its bills in a timely manner; and,

**WHEREAS**, those members comprising the majority in the Illinois General Assembly have failed to address these issues while receiving automatic salary increases approved in prior years; and,

**WHEREAS**, members of the Illinois General Assembly automatically receive salary increases each year and it will take a vote of the General Assembly to end this practice; and,

**WHEREAS**, members of the Illinois General Assembly could vote to stop the practice of automatic pay increases but failed to do so in the most recent legislative session despite over a million Illinoisans being out of work due to the COVID-19 pandemic; and,

**WHEREAS**, as a matter of public policy in the State of Illinois, the Illinois General Assembly should stop awarding its members automatic salary increases, or any other increase or addition in compensation, until such time as Illinois becomes financially solvent with a sufficiently funded pension system, the timely payment of bills, a balanced budget, manageable debt, and a healthy credit rating; and,

**WHEREAS**, the voters of Madison County should have the opportunity to express their views on this important issue to the Illinois General Assembly in the form of an advisory referendum; and,

**WHEREAS,** 55 ILCS 5/5-1005.5 states, "By a vote of the majority of the members of the county board, the board may authorize an advisory question of public policy to be placed on the ballot at the next regularly scheduled election in the county."; and,

**WHEREAS**, the Madison County Board seeks to place an advisory public question before the electorate via a referendum on the November 3, 2020, countywide ballot seeking to ask Madison County voters if members of the Illinois General Assembly should stop the practice of voting to give themselves automatic salary increases as follows:

"Shall members of the Illinois General Assembly change state law to stop automatic annual salary increases for legislators?"

### **NEW BUSINESS:**

Mr. Moore: I just wanted to bring up something to some members that are not involved in the Safety Committee or the Finance Committee, there's an issues come up there. So they may not be aware of what's going on with the contract recently that the Sheriff's Department signed. I just want to make sure everybody know and also people online out there that may not know what's going on. The Sheriff's Department has done something, again, unprecedented by signing the contract without the oversight of the legislative body of Madison County government. They did this totally on their own and it's something that hasn't been done before. What they've done is they've hired a contractor to come in and perform the budget duties. This is an administrative function that they state is a professional service but it's really not professional service that the admin functions that they've always done; they use professional service because that way they can get around the no bid process and just have one person who was a recent retiree, Captain Decker, now perform those duties, a part time job, getting paid quite well. This is really a slap in the face everybody on this board and Madison County by them doing this again. This is unprecedented and it could really I mean, what happens with other constitutional officers in the future? Are they going to start writing their own contracts?

Mr. Parkinson: Mr. Prenzler this was already discussed earlier, this is not new business.

**Mr. Moore:** This is new business for the County Board, Mr. Parkinson.

**Mr. Parkinson:** It's not new business, you're just babbling on about stuff that we've already talked about and you don't know what you're talking about.

Mr. Prenzler: I'll give you an opportunity to speak, let Mr. Moore finish.

Mr. Moore: Thank you, Mr. Chairman. Again, this is an admin function that the Sheriff's Department has always performed themselves. This was a part time job and now they've hired in a civilian to come in from the outside to perform the duties and I'm concerned that other officers in the future could take this as, as the go, the green flag and go ahead and do it themselves. The board is losing control, and it's only hurting the county as a whole. I find Major Connor's comment earlier, this saves money, and this is going to be very hard pressed to prove to me that this saves money. You save money by promoting from within and moving people up. Now there might be lieutenant out there with an associate's degree in the county that can handle this job. There might be a sergeant that wants to get off the street to take that lieutenants job. There might be other deputies that can move up one notch within and then maybe hire a new deputy off the street. That job is no longer available for that new person. So that's the way you perform this type of function but this is the precedent being set. Right now, just to close with, I have asked the State Attorney's Office to give me a written opinion that they agree that this actually is legal, however they want to word it. I'm having trouble posing questions, but I want to get something in writing, then the idea is go to the AG and get them to look at this and concur or not. So that's where we're at with that.

**Mr. Parkinson:** First of all, he's assuming he knows what the functions that Decker Analytical is going to do, which is a corporation. He's assuming that that's all they're going to do is the budget, which he doesn't know. Secondly, it's a corporation, this is all legal. He has other employees that work for this corporation. Thirdly, to move somebody up to a higher salary creates higher legacy costs that will cost the taxpayers more money so they are correct, it is the cost savings. They've eliminated a job over there to pay for this

within their budget that was granted to them so they haven't circumvented the system. They were given a budget, they're living within the budget. In fact, they reduced their budget by this. So when you guys came into a meeting and started talking about how much money I.T. is saving by eliminating positions from the people that quit, and then outsourcing that, you were all praising it was such a great thing, we saved all this money, we outsource these jobs, and we don't have legacy costs anymore. And now all of a sudden Don, that's not the case. Why is that? It's political, Don, get over it. They're within the rules, you don't like it, I don't know what to tell you, but they're within the rules so stop trying to make up a false narrative.

**Mr. McRae:** Yeah, so I would just concur with Mr. Moore, and I think he does know what he's talking about. We've had several discussions about this in the Finance Committee and this has been thoroughly and I will tell you that we tried to resolve it behind closed doors actually. So if this wouldn't come to the forefront I think it is incumbent upon all of us so that the Finance Committee lets the rest of the board understand what's going on. You have someone who's got a very generous pension who's going to retire with, I believe, around a \$90k pension who is now going to get a \$115k no bid contract.

**Mr. Parkinson:** Those are not accurate numbers.

**Mr. McRae:** Ok, then what is the number, Mr. Parkinson? Enlighten me, is it \$70k? \$75k?

Mr. Parkinson: Instead of throwing something out there that's not true, why don't you get your facts straight first? It's not my job to tell you what it is.

Mr. Prenzler: Mr. Parkinson, I think he asked you a question, what is the number?

**Mr. Parkinson:** It's not my job to tell you, you want to throw out false numbers, find out what the number is.

Mr. McRae: Well here's where I got my number, my number is 75%, roughly 75% of the last salary. Which to my understanding, and that's kind of a moving target too but that's around \$120k. So, 75% of \$120k is \$90k. I just want to tell you guys, the easy thing to do is just to turn the other way and let it happen. And I think a lot of people, as we talked about earlier, people are tired of it. They're tired of the double dipping and you wonder how it happens, it's because our legislature is ineffective. In some states, it's illegal to do this. The federal government makes you to be removed from that position for two years before you can come back. IMRF is going to have a waiting period effective January 1, 2021. They've seen an issue with this. And so the thing is, and the IRS carefully scrutinizes these types of situations because they don't encourage an employee either has to be a contractor or an employee. And we have to make sure that the IRS signs off on this, that the state's attorney says it's illegal and then our auditor says this is illegal. And to my knowledge, some of that is moving forward, and I'm not sure that any of that is really in writing as we speak right now. So we're not sure that it's illegal. And so maybe, you know, it's incumbent, I think, what we're trying to do as a Finance Committee and as a board, just to make sure that this is the proper way to do things. But when you stand around the watercooler and you hear about these people who are getting, you know, two pensions, or pensions plus huge salaries from the same governmental bodies. That's why the Illinois pensions are billions of dollars underwater, because nobody's done anything. I think this is the resolution we put on tonight tells the state legislature, hopefully, in a large downstate county that you guys really ought to be doing something because people are tired of it.

**Major Connor:** Let me first start off by saying, Mr. McRae, maybe you need to quit standing around the water cooler taking your gossip and spreading it in an open meeting with non-factual things. I bit my tongue the other day in the Finance meeting whenever you spouted out the figures that you don't know what you're talking about, it's not \$90k.

Mr. McRae: How much is it, Jeff?

**Major Connor:** I'm in the middle of talking. I started to say his pension is in the low 70s, that's based upon the IMRF calculation. So if you would read the IMRF calculation, you probably could have got a better idea of what the water cooler talk was and made an accurate statement or I know that is hard for you guys to do, maybe call me, send me an email and ask me what it is before you go into an open meeting. As far as all the legalities and everything, we told you more than once, and we showed you the county ordinance allows for this type of contract, the way we did it. The state law allows it, the Attorney General has given an opinion on the appropriations of money and budgets on constitutional offices. The State's Attorney has given an opinion, Jeff Ezra, gave an opinion to Don Moore, my understanding that Mr. Gibbons told Mr. Moore if you want an opinion, reach out to Major Connor and ask what questions you want to answered. I have not received anything from Mr. Moore yet and as far as hiring somebody with a second pension, this is not a second pension situation. It's a contract with a corporation, just like Ace Tech and other companies, just like the grass mowing cutting people. It's a corporation that has entered into a contract with us to do certain items that we've contracted out. So you're spewing all this information that's not factual in a way to elicit a response from people, instead of just listening, I was in the meeting when you said, hey it's a great idea. I said, well, what would it take for you to support it? I just don't like the numbers, that's all you said, I just don't like the numbers. Ray Wesley in the paper saying, I think it's a great idea. Eric Foster, I think it's a great idea, I just have a couple questions. We answered those questions. Now everybody is afraid to say it's a good idea. You know, if you want to talk about water cooler talk, I hear that Mr. Moore keeps saying it's a good idea, I just don't like it. Thank you.

Ms. Dutton: I don't want to argue with anyone, I first want to say congratulations to Heather Jones on her appointment tonight and thank you for serving and committing to that and again, sorry for your loss. Back to this comment, I keep hearing the word legal that this is perfectly legal to do with that contract. Major Connor, you did call me, you reached out to many of us, I'm sure all of us and I think you could tell on the phone call with me that I had some issues with it. I had to think about it. The first thing that came to my mind was an ethical issue, it may be legal, but anyone opposing that resolution on double dipping, do any of you appreciate the ethical problem involved here? When you have someone who is, you know, use their many years in public service and their influence they develop on everyone to immediately negotiate a sweetheart deal with the county again, it does leave a bad taste in my mouth. And I know many taxpayers feel the same way. So that was my issue with it, I mean, I feel like that's prohibited most anywhere else to be able to turn around within the same month or the next month to just get yourself back in doing essentially the same thing, that was my issue with it. Again, I don't want to argue with anybody, I just wanted to have my points heard.

**Ms. Glasper:** Since this issue was also brought to Public Safety, it is my hope that the State's Attorney, IRS and Auditor can answer all questions as to the legality of this contract, as it was explained to us in our Public Safety meeting. It was explained by Major Connor and others, that it was procedural that they could do this. So it is my hope that all these questions can get answered, because, I too, I am not going to argue who's right and who's wrong here. I want the questions to come from the State's Attorney, the questions to be answered if there's questions. Let's get answers to these questions. Let's find out what we can or cannot legally do, and let's proceed from there. That's my comment, Mr. Chairman.

**Mr. Madison:** I've heard a lot of talk about money saving tonight, again, as we did in the Finance Committee the other day. I'd remind anybody that or let somebody know that's listening online, since we've been doing the budget the last three years, I believe that we've increased the Sheriff's Department's budget about \$2.8M approximately. So any talk of money savings is very, very small here, and I'm not really sure that's what's being considered. You know, if it's something they wanted to privatize, they could have done that with an open bid, they might have even saved some more money. To increase the Sheriff's Department's budget this much, while I deeply support law enforcement and the officers out there getting it done every

day, putting their selves at risk, deeply from the bottom of my heart respect those individuals. This is an upper management issue, it looks like a buddy deal, smells like a buddy deal, sounds like a buddy deal and I believe that's what it is and I'm against it, thanks.

**Mr. McRae:** I will stand corrected, I did mention the term \$90k and my calculation was incorrect. It's apparently low 70s and so the pension is only the low 70s, so when I add 70 plus 115, I get 185k and that's with 70k. I never once said, just for the record, that it was a good idea, in fact, it's a terrible idea.

Major Connor: You didn't say it for the record, you said it in a private meeting with myself and the Sheriff.

**Mr. McRae:** That's not true, Jeff, I never said it was a good idea and that is not true. We had other people there and I'm not going to stand for that.

**Mr. Parkinson:** Yeah, real quick. Tom, thank you for actually coming forward and saying you made a mistake with the \$90k figure, I appreciate you doing that. I would like to say that I would come to the Finance Committee and talk about these issues instead of having to get this in depth into it in the last part of our meeting but Mr. Moore doesn't allow me to talk at his meetings, so I can't do that.

**Mr. Moore:** I just want to clarify something to all the board members to what Major Connor said about me receiving information from the State Attorney's Office, Tom Gibbons. I haven't received anything yet, I'm not sure, it could be in my mailbox, it wasn't there when I left late this afternoon to come to this meeting, so I have not received anything. I'm very anxious to receive something and move forward with this, but as of this time, I don't know what Major Connor is talking about. Also, I would add that Mr. Parkinson, you're welcome to speak at the Finance Committee meeting but you need to know proper protocol, and when to speak and when not to speak and follow the rules. That's all there is to it, you can speak all you like I've let you speak many times in the past but when you get out of line, I pull the plug.

Mr. Parkinson: That's your opinion, Don, you make the rules.

**Mr. Guy:** Got a question from Major Connor, I'm sorry to put you on the spot and ask you this and you can answer it at a later time if so, but what's the average salary for one of the sheriff's deputies?

**Major Connor:** We have 167 employees, as far as an average salary, that would take some checking to do, I'm not even going to give you an answer for that. Mr. Moore, just for clarification purposes, Mr. Gibbons told me that he instructed you to reach out to me with specific questions, that's why I said we're waiting to hear from you.

Mr. Moore: I never got that communication, Major Connor.

**Mr. Gray:** I have a quick question for Major Connor, I was just wondering the length of the contract in question.

**Major Connor:** It is 1 year, July 1<sup>st</sup> to June 30<sup>th</sup>.

**Mr. Foster:** Just for clarification purposes, I was at that private meeting with Mr. McRae, Mr. Wesley, the Sheriff, Mr. Connor and myself. I don't recollect Mr. McRae saying that he was in favor of this contract and I don't remember saying I was in favor of this contract. I did state, I was not against contracts like this, but I felt that this is rather incestuous. I'd just like to have that for clarification that I never once stated that I was in favor of it. I did not say I was against it, but I never said I was in favor of it.

\* \* \* \*

Mr. Holliday: I want to speak about systemic, structural and institutional racism, as well as some incidences happening around our country. Most white people in the US are familiar with explicit racism or racism that is conscious choice to actively hate or discriminate someone of another race. Most white people associate explicit racism as the main form of racism in the US, and beliefs to support racism, there has to be a conscious choice like joining the KKK, or using racial slurs at a non-white person. Explicit racism is a broad problem in this country, but it's a very small part of the actual racism that occurs, often unconsciously in this country. The most people in the US negatively affected by racism are affected by systemic or so called institutional or structural racism, systematic racism, implausible oppression, and privilege that affect almost every aspect of our society, so our laws, institutions, schools justice system, media, culture and everyday interactions. This form of racism although often more harmful than explicit racism is less understood and even recognized by the white moderate majority, who often preserve and perpetuate that racism unconsciously through complicity and complacency. The kind of protest and anger that fuels them did not spring up out of nowhere, and they acquire pain from a raw nerve that has always afflicted the United States in one way that was always too often ignored. That nerve had a number of causes, and a number of things activating it and bias violence, policing of courts, but also lingering effects of segregation affecting education, job opportunities and health, a multitude of ways this will give white men greater financial rewards than others, most of all black women, our criminal justice system that is punitive if you're black, but able to find forgiveness, mercy and understanding if your white. The fact that not just one labor for one's life is less valuable than those of other citizens only because of the color of their skin. People marching the streets have had enough of this injustice and they are demanding in America no longer allows itself to be policed as they have been. They are pulling down memorials of traitorous men who would still have them enslaved. They have called it the link to be made a federal crime, they want equal pay, they want political change, they want people to listen carefully, thoughtfully, and be willing to change their heart and behavior. I'm asking the county board to consider banning the use of the chokehold on the carotid hold by law enforcement officers here in Madison County, Illinois. Thank you, Mr. Chairman.

**Mr. Parkinson:** Mr. Holliday, thank you for your words. I do want to remind you that as I have said in the past, chokeholds are now banned and they're against the law for police use in the state of Illinois.

**Mr. Moore:** I'd just like to add something to Mr. Holliday's statement about racism. Obviously, it's a very sensitive hot topic that's going on across the country here today and I concur with some of the things he said and I would add that all racism is bad. Thank you.
