# **Aide Application Guidelines**

Organizations receiving funding from the Madison County Mental Health Board must show evidence of seeking support from all sources available to them. This includes Medicaid (if services are eligible), insurance coverage and other third party payers, as well as other state departments (DMH, SUPR, DDD, DRS). If an agency serves multiple counties, it must seek local funding from the Mental Health Board located in that county.

The Mental Health Board has a responsibility to set expectations for the mental health system that prompt action on the part of contractors receiving public funds through the Board.

Organizations with which the Mental Health Board contracts have an obligation to adhere to the contract requirements and to self-monitor performance. The Mental Health Board has the right and responsibility to withhold payment when contractors have not met the stipulations outlined in the contract.

The Mental Health Board will carefully examine the on-going support of program services determined by DMH, DDD, SUPR and DRS to be their priority or priorities for funding in order to avoid supplanting state funds with local tax dollars.

The Mental Health Board shall determine what is required in a service plan and shall solicit such plans from all contractors funded, unless the funding is time-limited or otherwise restricted when initially approved.

The Mental Health Board reviews applications yearly, will not engage in historical funding, and restricts funding for services to Madison County residents. For further details, call 618-296-4357.

# **System Development Request Guidelines**

System Development dollars are used to assist with mental health, substance use disorder and developmental disabilities educational activities, trainings, and events. System Development funding priorities are based on current needs in the community and are established in the Madison County Mental Health Board One & Three Year Plan; with events for and/or developed by consumers having priority.

## **Process for Requesting Funds**

Requests for funding require approval by the Mental Health Board at regularly scheduled Board meetings. Meetings are held seven times a year, although, financial requests are not heard at the September planning meeting. Please refer to the Board website for the calendar of meetings at <a href="https://www.mcmhb.org">www.mcmhb.org</a>. To ensure timely receipt of funding, applicants should request funding several months in advance of actual need.

### **Required Components of a System Development Request:**

- Request letter sent to Board office on agency letterhead which includes:
  - Narrative of problem being addressed/purpose of funding request
  - 2. Amount of request
  - 3. Name & address of fiscal agent with address & tax identification number
  - Program Budget which includes all anticipated expense and revenue sources and amounts for the event/program

# **History of the Mental Health Board**

The Madison County Mental Health Board, also known as the 708 Board, was established in 1966 when Madison County passed a referendum to establish a local tax base to fund mental health services for its residents. The annual levied tax, known as the Community Mental Health Fund, is not to exceed .15%. The referendum passed under the enabling legislation of the Community Mental Health Act (House Bill 708). It required the creation of a County Mental Health Board to define, plan, fund and monitor facilities and services to persons affected by mental illness, developmental disabilities and substance use disorder to assure the availability of a comprehensive system of community services for residents of Madison County.

The Mental Health Board is currently represented by seven members all of whom are residents of Madison County. The members are to be a diverse group of individuals representing entities such as local health departments, medical societies, local welfare boards, hospital boards, school boards, lay associations concerned with mental health, substance use disorder and developmental disabilities as well as labor, business and civic groups or the general public. Geographic representation is to be

widespread. The Mental Health Board provides oversight to and has been proactive in the development of high quality services for mental health, developmental disabilities and substance use disorder services for Madison County residents.




