Others present: James Arnold, John Herzog and Frank Miles of Madison County Community, Debbie Ferry of Roxana, Bob Coles from South Roxana, Dave Williams of Granite City, Ben Motil of Pontoon Beach, Tammy Davis and Randall Viessman of Nameoki Township, Ben McCall of America's Central Port, John Harvey, Brenda Ervin of Venice Park District

Mr. Goggin opened the meeting. He then asked for approval of the minutes from the December meeting. Ms. Tracy made the motion to approve the minutes with a second from Mr. Rosen. All in favor; minutes approved.

Mr. Arnold gave the financial report. The beginning balance of the year (12/1/2014) was \$2,584,783.98; the total revenue to date is \$1,577.98 from sales tax revenue and investments. The total expenses to date are \$386,756.54. The current balance in the PEP account is \$2,199,605.42. There is \$8,809.54 encumbered (2013 PEP). There is \$337,685.25 encumbered (2014 PEP). There is \$1,350,000.00 encumbered (2015 PEP). The available balance is \$451,555.68.

Mr. Arnold reported on the PEP Revolving Loan Fund that there was as of 12/1/2014 a balance of \$982,246.95. Revenue to date is \$19,226.98 from loan repayments and interest from investments. Expenses from the loans during this period are \$26,667.54. The PEP Loan Fund balance as of 1/30/2015 is \$974,806.39. There are three encumbered loans (Godfrey, Bethalto, Maryville) totaling \$283,561.22. This leaves an available balance of \$691,245.17.

Special Requests were presented to the committee:

Debbie Ferry, Village of Roxana: The Village of Roxana would like surveillance cameras to protect the integrity of their park.

Chief Bob Coles, Village of South Roxana: The Village of South Roxana would like an electronic marquee for their park. They currently have no signage.

Dave Williams, Granite City Park District: The Granite City Park District would like to complete 6500 linear feet of cart/walking path in at the Legacy Golf Course. This is Phase 3, PEP paid for the first two phases.

Ben Motil, Village of Pontoon Beach: The Village of Pontoon Beach would like to purchase and construct a bandstand. They do not have a bandstand yet.

Randall Viessman and Tammy Davis, Nameoki Township: Nameoki Township would like to request a new zero turn mower to mow both of their parks.

The special requests were discussed. Mr. Parente motioned in favor of the special requests and second from Mr. Rosen. All were in favor.

Ben McCall, John Harvey, and Brenda Ervin came to request a PEP Loan in order to prefinance their OSLAD and MEPRD grants. The loan is a balloon loan in the amount of \$400,000.00 that will be repaid via the MEPRD and OSLAD grants. The remaining balance will be repaid with future PEP funds. Ms. Tracy motioned in favor of the PEP Loan with a second motion coming from Mr. Barnhart. All were in favor, motion passed. A resolution was signed and will be brought to the Grants Committee.

There being no further business, a motion to adjourn was made by Ms. Tracy with a second from Mr. Rosen. Meeting adjourned. The next meeting will be on Friday, March 6th, 2015 at 9:00 a.m. at Madison County Administration Building County Board Room, 157 N. Main St., Edwardsville, Illinois 62025.
