RE: ASSUMED NAME FILING

Enclosed is an Assumed Name Certificate form. Complete this form, and have the business owner(s) sign it before a Notary Public. In order to file a business name that is located in the “unincorporated” area of the county, you must complete the Home Occupation Assessment form. If you have any questions about the Home Occupation Assessment form, please contact the Planning & Development office (618) 296-4468. If your business is a Limited Liability Company (LLC), you must file first with the Secretary of State’s Office and have documentation when filing your assumed name.

Illinois State Law requires that a legal notice shall be published in a newspaper of general circulation within the county in which the Certificate is filed. Such notice shall be published once a week for three consecutive weeks. An Assumed Name Publication Fees List for Madison County, which includes the newspapers and their fees for the three publications, is enclosed. Please advise us in which newspaper you wish to publish so that we can take care of the publications for you.

Your personal check or money order for both the filing fee of \$31.00 plus the publication fee should be made payable to Madison County Clerk. Please send your check and Assumed Name Certificate to Madison County Clerk, P. O. Box 218, Edwardsville, IL 62025.

The proposed home occupation will be reviewed by the Planning & Development Department to ensure that the business will be in compliance with the Madison County Zoning Ordinance (§93.083 Home Occupations). Staff will determine if the proposed home occupation is a permitted accessory use or if a Special Use Permit is necessary.

Amendments:

Approval of a home occupation is valid for the use as submitted. Any future changes of ownerships or use of a home occupation or expansion of a home occupation that has previously been approved will require a new application, review, and approval in order to operate.

Authorized Signature:

I hereby certify that my business will continually conform to the standards of the Madison County Zoning Ordinance, to §93.083 Home Occupations, and to any conditions of approval attached to a Special Use Permit. I understand that the home occupation may be revoked at any time pursuant to any violation of the Madison County Code of Ordinances. I also understand that a Zoning Inspector may, with reasonable notice and during regular business hours, inspect my home occupation site to ensure compliance.

By signing this application, I hereby affirm that I have read and understand the Madison County Zoning Ordinance §93.083 Home Occupations and further affirm that the information provided in this application is correct and complete.

ASSUMED NAME FILING

GENERAL INFORMATION: All businesses, by Law, must have its names registered. Sole proprietorships and general partnerships must file with the county clerk's office. By registering your business name under the Assumed Business Name Act, does not prevent anyone from using your business name. The only way to prevent someone from using your business name is to file as a corporation or have a trademark for your name. Check the Fees Chart for filing and publication fees and the letter for specific filing instructions.

WHO MUST FILE: Anyone using a name (other than his/her own personal name, i.e. John Doe or Sally Smith) for his/her business. Note: By adding any word to your own personal name constitutes an assumed name (i.e. John Doe **Company** or Sally Smith **Computer Service**).

CORPORATE FILINGS: All corporations must file their names with the Secretary of State's Office. The Articles of Corporation are filed with the Recorder's Office. If the corporation is doing business as another name (i.e. TLC Lawns, Inc. d/b/a Bug-B-Gone), the corporation (TLC Lawns, Inc.) must file an assumed name certificate (Bug-B-Gone) with the County Clerk's office. At least one corporate officer must sign the assumed name certificate.

BUSINESS LICENSES: Check with the local city or village clerk's office for any licensing requirements.

EMPLOYMENT IDENTIFICATION NUMBER: Check with the Illinois Department of Revenue for specific requirements.

TAX INFORMATION: Check with the Illinois Department of Revenue for specific requirements.

EXCERPT FROM ILLINOIS REVISED STATUTES

405/1. NECESSITY OF CERTIFICATE - FILING CERTIFICATE

S.1. NO PERSON OR PERSONS SHALL CONDUCT OR TRANSACT BUSINESS IN THIS STATE UNDER AN ASSUMED NAME, OR UNDER ANY DESIGNATION, NAME OR STYLE, CORPORATE OR OTHERWISE, OTHER THAN THE REAL NAME OR NAMES OF THE INDIVIDUAL OR INDIVIDUALS CONDUCTING OR TRANSACTING SUCH BUSINESS, UNLESS SUCH PERSON OR PERSONS SHALL FILE IN THE OFFICE OF THE COUNTY CLERK OF THE COUNTY IN WHICH SUCH PERSON OR PERSONS CONDUCT OR TRANSACT OR INTEND TO CONDUCT OR TRANSACT SUCH BUSINESS, A CERTIFICATE SETTING FORTH THE NAME UNDER WHICH THE BUSINESS IS, OR IS TO BE, CONDUCTED OR TRANSACTED, AND THE TRUE OR REAL FULL NAME OR NAMES OF THE PERSONS OWNING, CONDUCTING OR TRANSACTING THE SAME, WITH THE POST OFFICE ADDRESS OR ADDRESSES OF SUCH PERSON OR PERSONS AND EVERY ADDRESS WHERE SUCH BUSINESS IS, OR IS TO BE, CONDUCTED OR TRANSACTED IN THE COUNTY. THE CERTIFICATE SHALL BE EXECUTED AND DULY ACKNOWLEDGED BY THE PERSON OR PERSONS SO CONDUCTING OR INTENDING TO CONDUCT THE BUSINESS.

NOTICE OF THE FILING OF SUCH CERTIFICATE SHALL BE PUBLISHED IN A NEWSPAPER OF GENERAL CIRCULATION PUBLISHED WITHIN THE COUNTY IN WHICH THE CERTIFICATE IS FILED. SUCH NOTICE SHALL BE PUBLISHED ONCE A WEEK FOR 3 CONSECUTIVE WEEKS. THE FIRST PUBLICATION SHALL BE WITHIN 15 DAYS AFTER THE CERTIFICATE IS FILED IN THE OFFICE OF THE COUNTY CLERK. PROOF OF PUBLICATION SHALL BE FILED WITH THE COUNTY CLERK WITHIN 50 DAYS FROM THE DATE OF FILING THE CERTIFICATE. UPON RECEIVING PROOF OF PUBLICATION, THE CLERK SHALL ISSUE A RECEIPT TO THE PERSON FILING SUCH CERTIFICATE BUT NO ADDITIONAL CHARGE SHALL BE ASSESSED BY THE CLERK FOR GIVING SUCH RECEIPT. UNLESS PROOF OF PUBLICATION IS MADE TO THE CLERK, THE CERTIFICATE OF REGISTRATION OF THE ASSUMED NAME IS VOID.

IF ANY PERSON CHANGES HIS NAME OR HIS RESIDENCE ADDRESS OR THE ADDRESS OF ANY PLACE OF BUSINESS IN THE COUNTY WHERE SUCH ASSUMED NAME IS BEING EMPLOYED AFTER FILING A CERTIFICATE, OR IF THE NAME OF A PERSON IS ADDED TO ANY BUSINESS ORGANIZATION FOR WHICH A CERTIFICATE IS ON FILE, SUCH PERSON SHALL FILE AN ADDITIONAL, DULY ACKNOWLEDGED CERTIFICATE IN THE OFFICE OF THE COUNTY CLERK OF THE COUNTY IN WHICH SUCH PERSON TRANSACTS BUSINESS UNDER AN ASSUMED NAME. THE CERTIFICATE SHALL SET OUT THE CHANGE OR ADDITION AS THE CASE MAY BE. SUCH CERTIFICATE SHALL ALSO SET OUT THE POST OFFICE ADDRESS OF THE PERSON. IF ANY BUSINESS ORGANIZATION FOR WHICH SUCH CERTIFICATE HAS BEEN FILED IN ANY COUNTY OF THIS STATE SHALL REMOVE ITS PLACE OF BUSINESS TO ANOTHER COUNTY IN THIS STATE OR SHALL ESTABLISH AN ADDITIONAL LOCATION FOR DOING BUSINESS IN ANOTHER COUNTY OF THIS STATE, A CERTIFICATE SHALL BE FILED IN THE OFFICE OF THE COUNTY CLERK OF SUCH OTHER COUNTY AND NOTICE OF THE FILING OF SUCH CERTIFICATE OF A CHANGE OR ADDITION OF A NAME SHALL BE PUBLISHED AND PROOF OF PUBLICATION MADE PURSUANT TO THE PROVISIONS OF THIS SECTION IN THE SAME MANNER AS IS PROVIDED FOR ORIGINAL CERTIFICATES TO DO BUSINESS UNDER AN ASSUMED NAME.

405/2. CHANGE OR ADDITION OF NAME - CERTIFICATE - TIME FOR FILING

S.2. PERSONS CONDUCTING SUCH BUSINESS OR ANY BUSINESS UNDER AN ASSUMED NAME WHO HAVE PRIOR TO AUGUST 16, 1963 CHANGED THEIR NAMES OR WHOSE NAMES ARE ADDITIONS TO A BUSINESS ORGANIZATION CONDUCTING BUSINESS UNDER AN ASSUMED NAME, FOR WHICH A CERTIFICATE HAS PREVIOUSLY BEEN FILED, SHALL FILE ANOTHER CERTIFICATE SETTING OUT THE CHANGE IN THEIR NAMES OR THAT THEIR NAMES ARE ADDITIONS TO A BUSINESS ALREADY IN OPERATION AND EVERY ADDRESS WHERE SUCH BUSINESS IS CONDUCTED OR TRANSACTED IN THE COUNTY WITHIN 30 DAYS AFTER AUGUST 16, 1963.

405/3. INDEX OF ASSUMED NAMES - FEE - PRESUMPTIVE EVIDENCE

S.3. THE SEVERAL COUNTY CLERKS OF THIS STATE SHALL KEEP AN ALPHABETICAL INDEX OF ALL PERSONS FILING CERTIFICATES PURSUANT TO SECTIONS 1 AND 2, AND FOR THE INDEXING AND FILING OF SUCH CERTIFICATE SHALL RECEIVE A FEE OF *\$5.00. A COPY OF SUCH CERTIFICATE AND RECEIPT FOR PROOF OF PUBLICATION, DULY CERTIFIED TO BY THE COUNTY CLERK IN WHOSE OFFICE THE CERTIFICATE IS FILED, SHALL BE PRESUMPTIVE EVIDENCE IN ALL COURTS OF LAW IN THIS STATE OF THE FACTS THEREIN CONTAINED.

405/3A. CANCELLATION OF CERTIFICATE - FILING OF SUPPLEMENTARY CERTIFICATE - FEE

S.3A. ANY PERSON WHO HAS EXECUTED AND FILED THE CERTIFICATE REQUIRED BY SECTION 1 OR 2 OF THIS ACT AND WHO WISHES TO WITHDRAW HIS NAME FROM THE BUSINESS ORGANIZATION SHALL HAVE THE CERTIFICATE CANCELLED IN WHOLE OR IN PART BY FILING IN THE OFFICE OF THE COUNTY CLERK WHERE THE CERTIFICATE IS FILED, A SUPPLEMENTARY CERTIFICATE UNDER OATH, SHOWING THAT SUCH PERSON OR PERSONS HAVE CEASED DOING BUSINESS UNDER THE ASSUMED NAME, OR THAT THE PERSON OR PERSONS EXECUTING THE SUPPLEMENTARY CERTIFICATE HAVE NO FURTHER CONNECTION WITH OR FINANCIAL INTEREST IN THE BUSINESS CARRIED ON UNDER SUCH ASSUMED NAME; WHEREUPON THE COUNTY CLERK SHALL NOTE OPPOSITE THE TRADE NAME THEREFORE REGISTERED, THE WORD "CANCELLED" AND THE DATE OF CANCELLATION, OR, IN THE CASE OF WITHDRAWAL ONLY OF ONE OR MORE BUT LESS THAN ALL OF THE REGISTRANTS, THE CLERK SHALL NOTE THE WORD "WITHDRAWN" AFTER THE NAME OF EACH PARTY FILING THE SUPPLEMENTARY CERTIFICATE INDICATING THE WITHDRAWAL, TOGETHER WITH THE DATE OF SUCH WITHDRAWAL. WHEN SUCH WITHDRAWAL EFFECTUATES ANY CHANGE IN OR TRANSFER OF THE OWNERSHIP OF 25% OR MORE OF THE TOTAL OWNERSHIP INTEREST IN ANY SUCH BUSINESS ORGANIZATION DOING BUSINESS UNDER AN ASSUMED NAME, THEN NOTICE OF THE FILING OF SUCH CERTIFICATE SHALL BE PUBLISHED.

FOR FILING A CERTIFICATE NOTING THE CANCELLATION OR WITHDRAWAL OF ONE OR MORE NAMES, THE COUNTY CLERK SHALL RECEIVE A FEE OF \$1.50.

WHERE A PERSON FILES A CERTIFICATE PURSUANT TO SECTION 1 OR 2 SETTING OUT A CHANGE OF HIS NAME, OR THAT HIS NAME IS AN ADDITION TO AN ORGANIZATION DOING BUSINESS UNDER AN ASSUMED NAME WHICH HAS PREVIOUSLY BEEN REGISTERED, THE COUNTY CLERK SHALL NOTE ON THE INDEX OF SUCH PERSON'S NAME THE WORD "CHANGED" OR "ADDITION" AS THE CASE MAY BE.

405/4. CORPORATIONS, PARTNERSHIPS, TRUST, CRIMINAL STATUTES NOT EFFECTED

S.4. THIS ACT SHALL IN NO WAY AFFECT OR APPLY TO ANY CORPORATION DULY ORGANIZED UNDER THE LAWS OF THIS STATE, OR ANY CORPORATION ORGANIZED UNDER THE LAWS OF ANY OTHER STATE AND LAWFULLY DOING BUSINESS IN THIS STATE, NOR SHALL THIS ACT BE DEEMED OR CONSTRUED TO PREVENT THE LAWFUL USE OF A PARTNERSHIP NAME OR DESIGNATION, PROVIDED THAT SUCH PARTNERSHIP SHALL INCLUDE THE TRUE, REAL NAME OF SUCH PERSON OR PERSONS TRANSACTING SAID BUSINESS OR PARTNERSHIP NOR SHALL IT BE CONSTRUED AS IN ANY WAY AFFECTING SECTIONS 220 AND 220A OF DIVISION I OF "AN ACT TO REVISE THE LAW IN RELATION TO CRIMINAL JURISPRUDENCE", APPROVED MARCH 27, 1874, AS AMENDED.¹ THIS ACT SHALL IN NO WAY AFFECT OR APPLY TO TESTAMENTARY OR OTHER EXPRESS TRUSTS WHERE THE BUSINESS IS CARRIED ON IN THE NAME OF THE TRUST AND SUCH TRUST IS CREATED BY WILL OR OTHER INSTRUMENT IN WRITING UNDER WHICH TITLE TO THE TRUST PROPERTY IS VESTED IN A DESIGNATED TRUSTEE OR TRUSTEES FOR THE USE AND BENEFIT OF THE CESTUIS QUE TRUSTENT.

405/5. VIOLATIONS - PUNISHMENT

S.5. ANY PERSON OR PERSON CARRYING ON, CONDUCTING OR TRANSACTING BUSINESS AS AFORESAID, WHO SHALL FAIL TO COMPLY WITH THE PROVISIONS OF THIS ACT, SHALL BE GUILTY OF A CLASS C MISDEMEANOR, AND EACH DAY ANY PERSON OR PERSONS CONDUCTS BUSINESS IN VIOLATION OF THIS ACT SHALL BE DEEMED A SEPARATE OFFENSE.

A PERSON SHALL BE EXEMPT FROM PROSECUTION FOR A VIOLATION OF THIS ACT IF HE IS A PEACE OFFICER WHO USES A FALSE OR FICTITIOUS BUSINESS NAME IN THE ENFORCEMENT OF THE CRIMINAL LAWS; PROVIDED SUCH USE IS APPROVED IN WRITING BY ONE OF THE FOLLOWING:

(A) IN ALL COUNTIES, THE RESPECTIVE STATE'S ATTORNEY;

(B) THE DIRECTOR OF STATE POLICE UNDER SECTION 55A OF THE CIVIL ADMINISTRATIVE CODE OF ILLINOIS;¹ OR

(C) IN CITIES OVER 1,000,000, THE SUPERINTENDENT OF POLICE.

405/6. ACTIONS AGAINST PERSONS FAILING TO REGISTER ASSUMED BUSINESS NAME

S.6. IF A PERSON OR PERSONS REQUIRED TO REGISTER HEREUNDER DO NOT DO SO AND SUCH PERSONS, OR ANY OF THEM, ARE UNKNOWN, CIVIL ACTIONS MAY BE BROUGHT AGAINST SUCH PERSONS OR PERSONS, BY FILING SUIT AGAINST THE BUSINESS UNDER ITS ASSUMED NAME, NAMING ALL KNOWN OWNERS, AND DESIGNATING AS "UNKNOWN OWNER OR OWNERS" THE OTHER PERSON OR PERSONS TRANSACTING BUSINESS UNDER SUCH ASSUMED NAME. A JUDGEMENT RENDERED PURSUANT TO THIS SECTION SHALL BE A PERSONAL JUDGEMENT AGAINST ALL NAMED OWNERS AND SHALL, IN ADDITION, BE IMMEDIATELY ENFORCEABLE AGAINST THE PROPERTY OF THE BUSINESS AND CONSTITUTE LIEN UPON REAL ESTATE HELD IN THE NAME OF THE BUSINESS. AT ANY TIME PRIOR TO SATISFACTION OF JUDGEMENT, IF ANY, IF THE IDENTITY OF A PREVIOUSLY UNKNOWN OWNER IS DISCOVERED, SUCH PERSON SHALL BE NAMED AS A PARTY DEFENDANT BY MOTION TO THE COURT IN WHICH SUCH CASE IS PENDING OR IN WHICH THE JUDGEMENT WAS ENTERED, SUPPORTED BY AN AFFIDAVIT SHOWING THAT NOTICE OF SUCH MOTION HAS BEEN GIVEN IN THE MANNER REQUIRED FOR SERVICE OF PROCESS UPON AN INDIVIDUAL DEFENDANT BY CIVIL PRACTICE LAW, AS HERETOFORE OR HEREAFTER AMENDED.¹ WITHIN 10 DAYS AFTER SERVICE OF SUCH NOTICE, THE PREVIOUSLY UNKNOWN OWNER MAY APPEAR AND DEFEND AS IN OTHER CIVIL CASES; HOWEVER, SUCH DEFENSE SHALL NOT AFFECT ANY JUDGEMENT AGAINST ANY OTHER PERSON PREVIOUSLY ENTERED IN THE SUIT. IF THE DEFENDANT DOES NOT FILE AN APPEARANCE WITHIN SUCH 10 DAY PERIOD OR IF AFTER HEARING THE DEFENDANT IS FOUND TO BE LIABLE, THE JUDGEMENT, IF ANY, THERETOFORE ENTERED IN SUCH SUIT SHALL BE AMENDED TO INCLUDE SUCH PERSON AND SHALL AT SUCH TIME BECOME A PERSONAL JUDGEMENT AGAINST SUCH PERSON AS IF HE HAD BEEN INDIVIDUALLY NAMED IN THE ORIGINAL COMPLAINT.
