

NOTEWORTHY INVESTIGATIONS

THE PUBLIC IS REMINDED THAT ALL ARRESTED PERSONS ARE ONLY ACCUSED OF THE CHARGES AGAINST THEM AND ARE PRESUMED INNOCENT UNLESS PROVEN GUILTY IN A COURT OF LAW.

- On January 4th, 2020, at approximately 8:56 p.m., the Madison County Illinois Sheriff's Office responded to a 911 call at the address of 4586 Mooney Creek Road in rural Edwardsville, Illinois. Upon arrival, they discovered the body of a deceased male. The deceased male was identified as Randy L. Gori, 47 years of age, whom resides at that address. A vehicle described as a Black 2020 Rolls Royce SUV Cullinan had been taken from the address. Deputies secured the scene and the Madison County Sheriff's Office activated the Major Case Squad of Greater St. Louis. Investigators worked tirelessly, following over 60 leads and executing 8 search warrants, to develop a strong person of interest. While conducting a ground search, the subject/person of interest was located by investigators, along with the missing vehicle, in a wooded area close to the victim's home. Enough information was developed to detain the subject in relation to offenses associated to the investigation. On January 6th, 2020, the Madison County States Attorney's Office charged Timothy M. Banowetz, age 28, of Wentzville Missouri, with multiple counts of First Degree Murder, multiple counts of Aggravated Unlawful Restraint offenses related to First Degree Murder.
- From mid to late January into early February of 2020, the Madison County Sheriff's Office began investigating multiple vehicle burglaries in the Prairietown, Godfrey, and Granite City areas. Several nearby police departments, who had also begun seeing similar/possibly connected vehicle burglaries in their areas, joined the investigation. The Madison County Sheriff's Office, along with investigators from those agencies, began working together and were able to identify the suspects. The collective effort resulted in the recovery of one stolen vehicle, a firearm, 1.5 pounds of illegal cannabis, and nearly \$5,600. The joint investigation would uncover that these suspects were responsible for approximately 200 vehicle burglaries in the tri-county region. The facts of the case were presented to the Madison County States Attorney's Office and charges, in multiple counts ranging from Burglary and Stolen Vehicle Possession, were brought against Shane Carney (age 28) of Granite City, Sean Breeden (age 18) of Granite City, Timothy D. Sunderland (age 21) of Granite City. One juvenile was involved, that information is not being released. Bond was set at \$100,000.00 each.
- April 18, 2020, at 10:45 a.m., the Madison County Sheriff's Office responded to Wilson Avenue, Granite City, in reference to a structure/residence fire. Long Lake Fire Department was requesting police assistance. Upon arrival, deputies met with fire department personnel who stated that the residence was found to be vacant, however, there was odor of an accelerant located at the scene. While interviewing neighbors in hopes of locating a witness, it was learned that one of the neighboring residence had a security camera. Footage from this camera was observed and a suspect was developed.

Jared W. Sapp, age 28, of Effingham, Illinois, and former roommate of the residence, was charged with Residential Arson. Bail was set at \$85,000.00

- On July 10, 2020, deputies responded to a call on Rena Avenue, in Collinsville, regarding shots fired. Upon arrival, contact was made with the caller/witness, who stated a maroon in color GMC Suburban had been in the area. Several shots were heard as the vehicle navigated a turn leaving the area. The caller stated that someone inside a residence had begun firing shots at the GMC. Additional witnesses at the scene, however, stated that someone in the GMC had fired approximately seven shots as the vehicle left the area. Surveillance videos were used to locate the origin/crime scene. While reviewing the video footage it was determined that two vehicles were involved, a maroon GMC SUV and a black Ford Fusion passenger car. Through interviews and witness statements, several suspects were identified. During the investigation it was learned that these particular individuals had been involved in multiple area shootings. Warrants were obtained for Martin Valenzuela for the charge of Aggravated Discharge of a Firearm (\$500,000.00 bond) and Matias Herrera-Lamas for charges of Attempted Homicide, Aggravated Discharge of a Firearm, and Possession of a Firearm by a Felon (\$500,00.00 bond). On July 15, 2020, the black Ford Fusion involved in the July 10th call for shots fired was located and deputies were able to arrest Martin Valenzuela. While taking Mr. Valenzuela into custody, several items were confiscated as evidence including multiple firearms and clothing matching the description of individuals on scene and observed in the surveillance footage. The morning of Tuesday, July 21, 2020, Madison County Sheriff's Office Detective Division took Matias Herrera-Lamas into custody.
- August 19, 2020 at 12:11p.m., the Madison County Sheriff's Office received a 911 call regarding an armed robbery and kidnapping. While deputies were in route to the call, Highland Police Department advised they had the scene secured and the victim was being transported to the hospital. Shortly after, the suspect vehicle was located by deputies in the area and spike strips were deployed. Three suspects were taken into custody. Detectives eventually learned that the victim had solicited a prostitute and these individuals had responded. The victim was then robbed, kidnapped, and battered. Members of the Madison County Sheriff's Office Investigation Division were ultimately able to charge suspect Alize Mayes, and an un-named juvenile suspect, with Home Invasion, Aggravated Kidnapping, Armed Robbery, Aggravated Vehicular Hijacking, and Aggravated Battery; suspect Zachary Watson was charged with Home Invasion, Aggravated Kidnapping, two (2) counts of Aggravated Vehicular Hijacking, Unlawful Possession of a Weapon by a Felon, Aggravated Fleeing or Attempting to Elude a Police Officer, Aggravated Fleeing or Attempting to Elude a Peace Officer, and Aggravated Battery. Bond was set at \$500,00.00 each.
- Monday August 31, 2020, at approximately 3:37 p.m., the Madison County Sheriff's Office received 911 reports of a pedestrian struck by a vehicle at the intersection of West Delmar and Pine Grove Lane in Godfrey. Upon arrival it was discovered that a juvenile, age 2, had suffered fatal injuries. Information developed at the scene revealed that the driver of the suspect vehicle pulled over briefly after striking the juvenile then left the area. At approximately 6:00p.m., the Madison County Sheriff's Office received

information from the public regarding the identity of the driver and vehicle. A citizen was behind the suspected vehicle and was able to provide its specific location. Deputies then worked to secure the area and the suspect and suspect's vehicle were taken into custody. Paul E. Broadway, age 62, of Alton, Illinois, was taken into custody and charged with Failure to Report an Accident Involving Personal Injury or Death a Class 1 Felony (Punishable from 4-15 years imprisonment). Bond was set at \$100,000.00.

- Friday, November 6, 2020, approximately 6:55pm, the Sheriff's Office responded to a fatal traffic crash in the 6600 block of Godfrey Rd, Godfrey, IL 62035. The crash involved three vehicles. The decedent was leaving the parking lot of Walmart in Godfrey and turning left in accordance with the traffic control device at the intersection. While attempting to turn northbound, she was struck by a vehicle traveling southbound on Godfrey Rd. The vehicle turning left was not the at fault vehicle. The Illinois State Police Accident Reconstruction Unit also assisted in the investigation. The collision was of such high impact that it caused a crash into another vehicle. The individual that was turning left was taken to an area hospital for serious injuries and was later pronounced dead. The other parties suffered minor injuries and were released from the scene and/or hospital. Preliminary investigation into the sobriety of the at fault driver, Jacob M. Sitze, age 29, of East Alton, Illinois, revealed that he was driving on a public roadway under levels of intoxication prohibited by law. Sitze was held on 2 Counts of Aggravated Driving Under the Influence of Alcohol (Class 2 Felony Enhanced 3-14 years) and 1 Count Reckless Homicide (Class 3 Felony). Bond was set at \$200,000.00.
- On November 25th, 2020, at approximately 2:54 a.m. the Madison County Sheriff's Office received a call for shots fired at the BP Gas Station located on the 8400 block of Collinsville Rd., Collinsville, Illinois. Upon arrival, deputies located an individual that had sustained a non-lethal gunshot wound. The Madison County Sheriff's Office, in conjunction with Granite City Police Department, were able to develop a suspect and compile enough evidence for an arrest. There was no clear connection between the offender and the victim. On December 14th, 2020, the Madison County State's Attorney's Office charged Brandon V. Arriaga, age 25, of Granite City, Illinois, with Attempted First Degree Murder (Class X), Aggravated Battery with a Firearm (Class X), and Aggravated Discharge of a Firearm (Class 1). Bond was set at \$250,000.00.

MADISON COUNTY JAIL 2020 INSPECTION REPORT

Criminal Justice Specialist Kathy Melvin inspected the Madison County Jail on October 29, 2020. Entrance and exit interviews were conducted with Captain Tharp and Captain Ridings.

IMPROVEMENTS SINCE LAST INSPECTION

- 1. Wrist bands are now being utilized for identification of detainees.
- 2. Portable radios were purchased for jail staff.
- 3. Video conferencing was established for court proceedings and attorney meetings.
- 4. New tasers were purchased.
- 5. New handguns were purchased.
- 6. A new transport van was purchased.
- 7. A Xenex robot which disinfects by emitting ultraviolet light was purchased for use in the kitchen, holding cells, attorney/client areas, and health care unit.
- 8. Staffing was increased.
- 9. Two additional computer terminals were added in the squad room which allow staff to complete training.
- 10. Major renovations continue which repair/replace electrical wiring and plumbing throughout the jail. LED lighting is being added and painting is ongoing.
