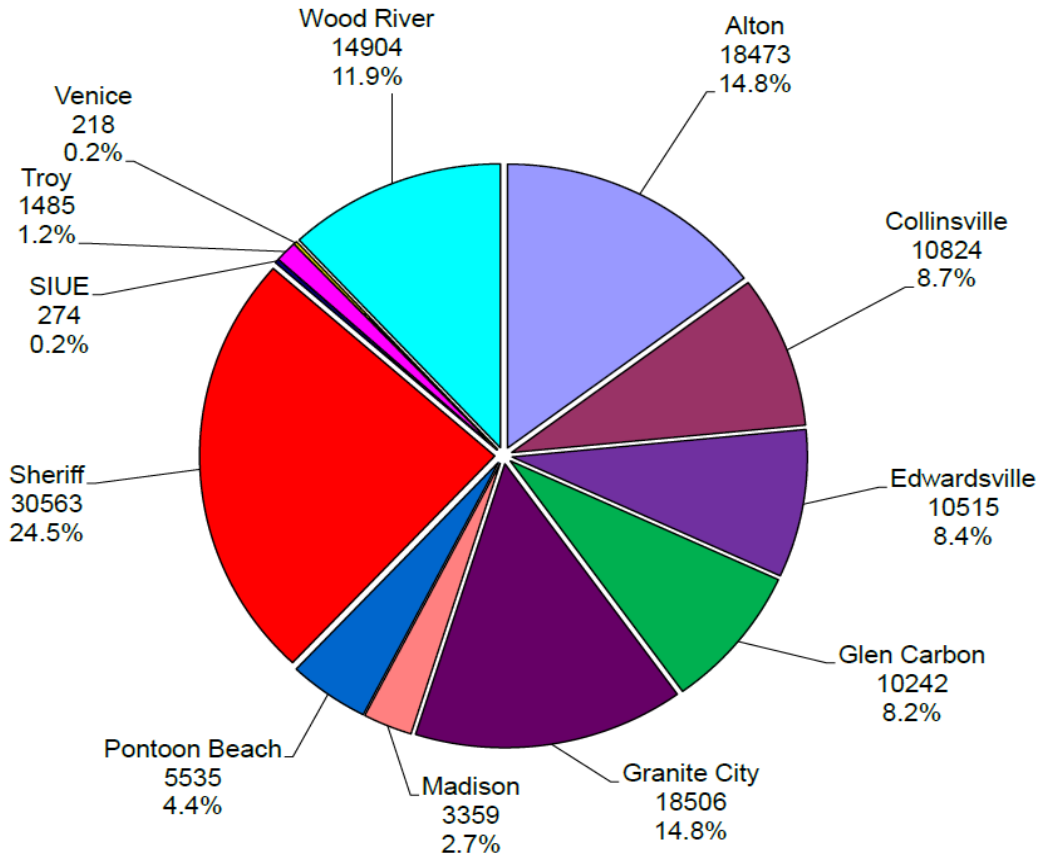

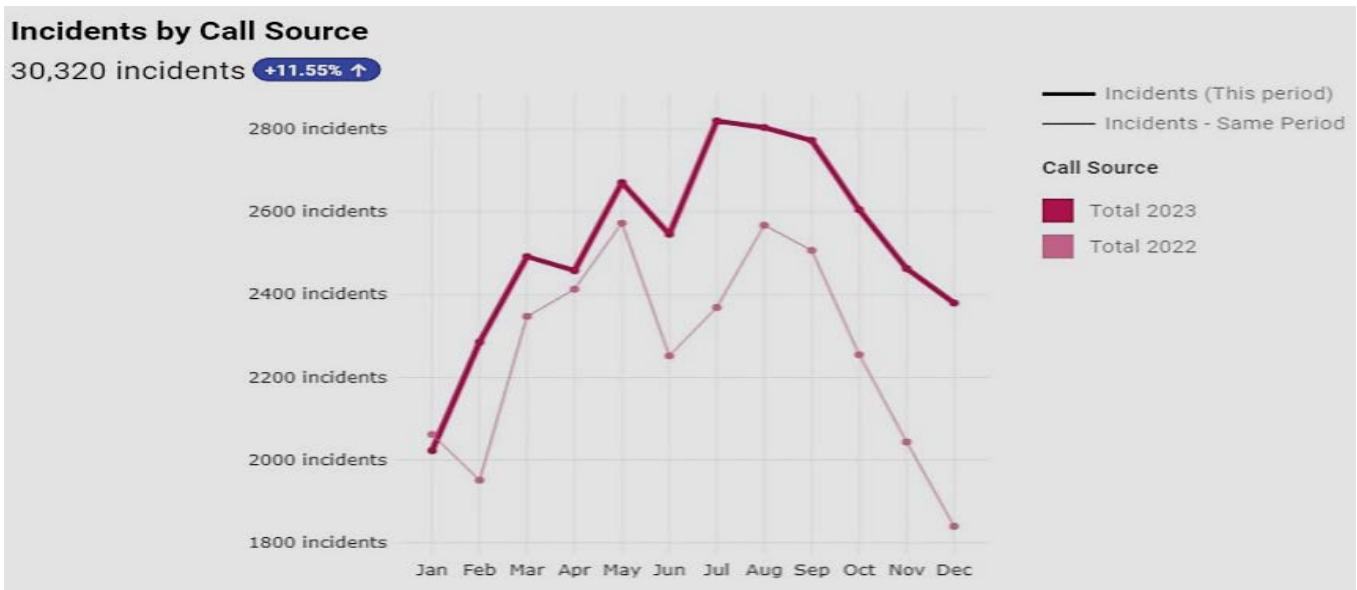

NOTEWORTHY INVESTIGATIONS

THE PUBLIC IS REMINDED THAT ALL ARRESTED PERSONS ARE ONLY ACCUSED OF THE CHARGES AGAINST THEM AND ARE PRESUMED INNOCENT UNLESS PROVEN GUILTY IN A COURT OF LAW.

- **2023-36:** On the afternoon of January 1, 2023, the Madison County Sheriff's Office received a 9-1-1 call of shooting in the 3300 block of Princeton Ave., Collinsville, Illinois. Upon first responders arriving at the scene and investigating the shooting they located a male shot in a nearby vehicle. The male victim, Miguel Villegas De-Santiago, was transported to a St. Louis area hospital, where he succumbed to his injuries.

Investigators with the Madison County Sheriff's Office and the Major Case Squad of Greater St. Louis investigated the homicide. Investigators subsequently identified and arrested 18-year-old Albert Campos and 26-year-old Matias L. Herrera as suspects in the case. The investigation revealed that Herrera drove Campos to the area of the 3300 block of Princeton Ave. Campos exited the vehicle, approached a nearby residence, and discharged a firearm in the direction of a residence and vehicles. Campos then approached a vehicle that was occupied by the victim, Miguel Villegas De-Santiago, firing his firearm several times. Campos then ran to the vehicle being driven by Herrera, which fled the area.

Albert Campos was charged with **two counts of First Degree Murder, two counts of Aggravated Discharge of a Firearm** and **one count of Reckless Discharge of a Firearm**. **Matias Herrera-Lamas** was charged with **two counts of First Degree Murder**.

- **20233-1477:** Just after midnight on January 24, 2023, deputies responded to the 900 block of Williamson Ave., Staunton, Illinois reference an aggravated battery with a firearm. The victim sustained a gunshot wound to his leg and was transported to St Louis University Medical Center for treatment.

Deputies responded to the residence with the tactical vehicle and successfully took two suspects into custody. Upon further investigation, the victim, Christopher Carter advised he was on the property attempting to assist with repossessing a vehicle. Johnny Taylor and his wife, Crystal Taylor confronted Christopher and other subjects. Johnny shot at the victim multiple times and struck Christopher once.

Detectives responded to the scene and conducted a search warrant on the property, at which time a surveillance camera was seized which captured the incident. Multiple interviews were conducted, and the firearm was located and seized at Crystal's mother's property. **Johnny Taylor** was ultimately charged with **Aggravated Battery with a Firearm, Armed Habitual Criminal, Aggravated Discharge of a Firearm, Unlawful Possession of Weapons by a Felon**, and **Unlawful Possession of a Stolen Firearm**. Crystal K. Taylor was charged with **Unlawful Possession of Weapons by a Felon** and **Obstructing Justice**.

- **2023-12418:** On June 6, 2023, the Madison County Sheriff's Office received a report of a Battery which just occurred in the 3100 block of West Chain of Rocks Rd., Granite City, Illinois. Patrol deputies arrived on scene and quickly recognized the situation to be more severe than a simple battery and called out the Detective Division to further the investigation.

Detectives began conducting numerous interviews and discovered that the victim, who was disabled, had been held captive and battered by the suspects. The Investigation found that during the most recent incident the victim had been battered by two occupants within the home and then locked inside of a dog crate for hours after sustaining serious but non-life-threatening injuries. The suspects were identified as Christopher L. Douglas and

Jessy J. Roustio. **Christopher L. Douglas** was charged with **two counts of Aggravated Battery** and **one count of Unlawful Restraint**. **Jessy J. Roustio** was charged with **two counts of Aggravated Battery**.

- **2023-14950**: On July 5, 2023, the Madison County Sheriff's Office received a report of an Armed Robbery in progress at the Carrollton Bank, Alton, Illinois. Suspect description was provided; however, the suspect had fled the scene prior to deputies arriving.

The Detective Division responded and conducted numerous interviews and scoured video surveillance throughout the immediate area of the scene. During this portion of the investigation, detectives were able to identify the suspect in the Armed Robbery as Mylon A. Hughes. Detectives were able to track Hughes via video surveillance, traveling to the Bank, committing the Armed Robbery, fleeing from the bank, changing his clothing, and then ultimately traveling back to the area of his residence after committing the robbery. Hughes was located the following day, July 6, 2023, and taken into custody. **Mylon A. Hughes** has been charged with **one count of Armed Robbery**.

- **2023-21185**: On September 12, 2023, the Madison County Sheriff's Office received a report of shots fired in the area of Surrey Ct. and Preis Ln. in Godfrey, Illinois. During the initial response by patrol deputies, evidence of shots being fired was located and a victim was located in the immediate area of the call. No subjects were struck by gun fire; however, the victim's occupied vehicle was struck by several rounds during the shooting.

Detectives responded to the scene. Through numerous interviews and upon discovering additional evidence, detectives identified Marcus Burns Jr. as a suspect in the case. In the subsequent search for Burns, he was located by detectives hiding under a mattress inside a box spring within an apartment in the area. Marcus L. Burns Jr. was safely taken into custody and subsequently charged with **Aggravated Discharge of a Firearm, Unlawful Possession of Weapons by a Felon** and **Unlawful Possession of a Controlled Substance**.

- **23-28958**: On December 14, 2023, the Madison County Sheriff's Office was notified of an aggravated criminal sex abuse. The incident occurred in rural Highland and the victim was a juvenile female. A forensic interview was conducted as well as numerous interviews with other family members. Detectives seized a hidden camera from the home and eventually conducted a traffic stop of the suspect, where his cellular phone was taken as evidence. A search warrant was obtained on the phone; several images depicting child pornography were located on the device as well as a video of the naked victim when she was under thirteen years of age. The suspect, **Terry M. Gerard** was arrested and ultimately charged with **Production of Child Pornography**, several counts of **Possession of Child Pornography**, and **Attempted Aggravated Criminal Sexual Abuse**.

When a serious crime occurs, the Major Case Squad of Greater St. Louis is activated and the investigators are assigned to assist the local jurisdictions with the investigation and prosecution of the suspects involved in the case. The Major Case Squad of Greater St. Louis is recognized as being one of the top investigative squads in the United States and has a clearance rate of over eighty percent (80%) on the cases they are involved in.

There were ten (10) Major Case Squad of Greater St. Louis homicide activations in Illinois, where the Madison County Sheriff's Office Investigations Division responded to assist in all of those investigations. Madison County Sheriff's Office Command Staff were assigned as Deputy Commanders for one of those activations, which was cleared by the arrests of the suspects involved. The Madison County Sheriff's Office continues to play an integral part of the Major Case Squad of Greater St. Louis in a commitment to holding suspects of major incidents accountable for their actions and protecting our community.

MADISON COUNTY JAIL 2023 COMPLIANCE MONITORING ADDENDUM

Criminal Justice Specialist Kathy Melvin monitored the Madison County Jail on October 30, 2023. Entrance and exit interviews were conducted with Captain Endicott and Captain Ridings.

IMPROVEMENTS SINCE LAST COMPLIANCE MONITORING

1. The offerings on the tablets have been expanded. The EDOVO Platform provides religious, educational, vocational, and rehabilitative curriculums and content to detainees.
2. A full-time mental health professional was hired. Areas of service include mental health screenings and evaluations, classification and placement assistance, and linkage and after care information for detainees being released.
3. The Automated External Defibrillators (AED) and medical crash carts are now located at the entrances to both the male and female housing units which allow expedited access during emergencies.
4. Ten cameras were installed in walkways surrounding the console, male dorms, special housing unit, and male and female safety cells.
5. A second Live Scan machine is now being utilized in the female housing unit.
6. A comfort service dog was obtained to offer emotional support to correctional staff. The handler will receive on-going training.
7. Medication Assisted Recovery (MAR) for detainees who seek treatment for drug addictions is expected to commence in December.
8. A new refrigerator/freezer unit is expected to be installed in November.
9. The facility has received approval for the construction of an intake/booking area, male and female holding cells, a double drive-thru sally port, and a gated parking area for transport vehicles.

NEW APP DEPLOYED BY THE MADISON COUNTY SHERIFF'S OFFICE

In June of 2023, Sheriff Connor deployed the Madison County Sheriff's Office app. The sole purpose behind the creation of this app was to improve communication and information sharing with our citizens.

Once you have downloaded the app, you have access to current public safety news, jail information, road closures, missing persons and more.

Since its implementation, the app has had 8,792 downloads and is averaging 100,000 views per week.



“Rx 4 Safety” update

Sheriff Jeff C. Connor, in partnership with all the Police Chiefs of Madison County, have collected over 14 tons of prescription and over-the-counter medications. These medications have been disposed of at a federally regulated location, approved by the E.P.A. (Environmental Protection Agency).

This is a collective effort, between the community, Madison County Planning and Development, and law enforcement, to protect the environment from the improper disposal of medications/drugs and also to keep our prescription medications from being ingested accidentally, stolen, or misused.

Secured drop off bins are located at the following Police Departments: Alton, Collinsville, East Alton, Edwardsville, Glen Carbon, Granite City, Highland, Madison County Sheriff's Office, Maryville, Roxana, SIU-E, Troy, and Wood River. *These bins were provided by CVS Pharmacy, Republic Waste and the American Water Company.*

These drop off locations are available to the citizens 24 hours a day 7 days a week.

These are the items we **CAN** accept:

Any over the counter medications, vitamins, liquids, narcotics, cough syrup, prescription medicines, hormones, painkillers, antibiotics, ointments, oils, and any unidentified pills.

These are the items we **CANNOT** accept:

Oxygen tanks, asthma inhalers, mercury thermometers, hearing aids, household waste, and sharps or needles.
