COMMUNITY CONNECTIONS



Deputies with the Sheriff's Office enjoyed "Coffee with a Cop" on Wednesday October 4th. The Sheriff's Office would like to thank Itty Bitty Restaurant, Madge's Restaurant, and Mister Donut

During the month of December the Sheriff's Office hosted an employee food drive. We are happy to report just over 1200 pounds of food was distributed to the Collinsville and Highland Food Pantries.



The Madison County Sheriff's Office now has fifty-three (53) AED's in service.

On Friday, March 10, 2017, the Sheriff's Office put an additional 38 Automated External Defibrillator's (AED) into use. These were added to the fifteen (15) already put in place in August 2016.

Currently, all Patrol Division units, Process Division units, School Resource Officers, the Patrol Commander, Training Coordinator, Desk Officer, and Chief Deputy Sheriff, have been issued a Philips HeartStart FRx AED and ALL have been trained in CPR and the use of an AED.



"Rx 4 Safety" update

Sheriff John D. Lakin, in partnership with all the Police Chiefs of Madison County, have collected over 10,000 pounds of prescription and over-the-counter medications. These medications have been disposed of at a federally regulated location, approved by the E.P.A. (Environmental Protection Agency).

This is a collective effort, between the community and law enforcement, to protect the environment from the improper disposal of medications/drugs and also to keep our prescription medications from being ingested accidentally, stolen, or misused.

Secured drop off bins are located at the following Police Departments: Alton, Bethalto, Collinsville, East Alton, Edwardsville, Granite City, Highland, Madison County Sheriff's Office, Roxana, SIU-E, Troy, and Wood River. *These bins were provided by CVS Pharmacy, Republic Waste and the American Water Company.*

These drop off locations are available to the citizens 24 hours a day 7 days a week.

These are the items we CAN accept:

Any over the counter medications, vitamins, liquids, narcotics, cough syrup, prescription medicines, hormones, painkillers, antibiotics, ointments, oils, and any unidentified pills.

These are the items we CANNOT accept:

Oxygen tanks, asthma inhalers, mercury thermometers, hearing aids, household waste, and sharps or needles.



On Jan. 18, the Madison County Sheriff's Office delivered a Winter Warm-Up of its own. During the month of January, the employees, along with the help of family and friends, were able to collect over 250 winter coats.

With the support of the Madison County Board, the Sheriff's Office was able to purchase a drone package. This includes the drone, its cameras, extra parts, extra batteries, the controllers, a hard case and the quick charge battery packs.

The DJI drone features both an optical camera with 30 times optical zoom and as much as 180 times digital zoom, as well as a Forward-Looking Infrared (FLIR) camera.

In 2017 the drone was used to assist in a search for a Suicidal Person, a Missing Person, and to assist the U.S. Marshals in execution of search warrants.



Sheriff Lakin's 1st Annual Shop-with-a-Sheriff took place on Friday December 1st at the Godfrey Wal-Mart.

Alton High-School Resource Officers Dunham and Pohlman were able to raise just over \$4200.00 for this event. Money was raised by "Pie in the face" and from generous outside donors. The money allowed 15 deputies to take 28 Alton High School students shopping with a \$150.00 gift card .

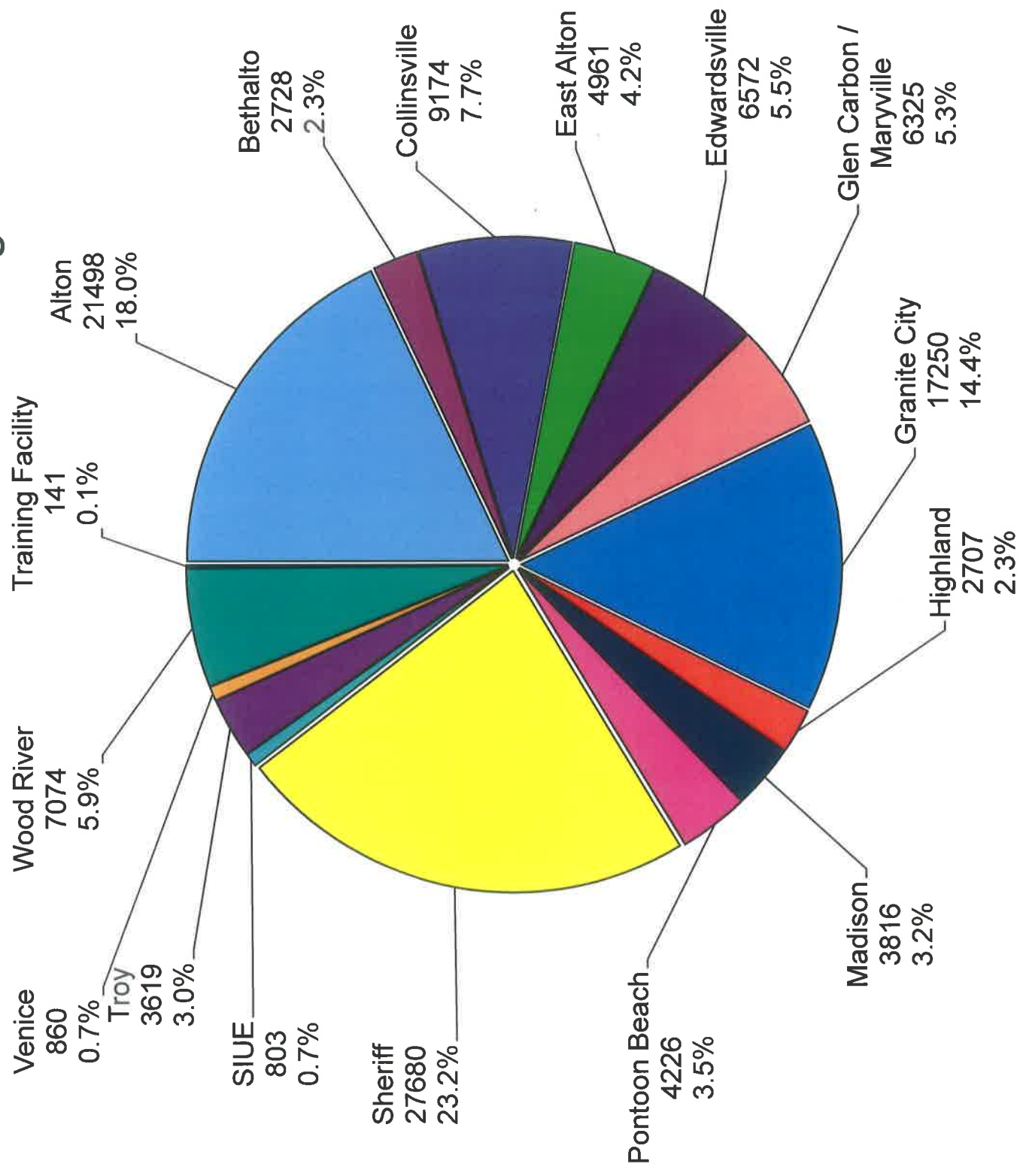

NOTEWORTHY INVESTIGATIONS

- On January 1, 2017, at approximately 6:38 p.m., the occupants of 4019 Garden Lane, Granite City, called 911 to report someone shooting into their home. Sheriff's Deputies responded and located multiple bullet holes in the residence and ten shell casings in the street, in front of the home. The occupants told deputies an unknown person(s), in a passenger car, shot into the home, almost striking a child, who was sitting in the front room. Investigators linked Hailey J. Pretto, Age 21, of Columbia, Illinois, and a second juvenile male from the Granite City area, to the incident. Hailey was charged with one felony count of Aggravated Discharge of a Firearm and is currently out of jail on bond, awaiting trial. The juvenile defendant in this case has also been petitioned through the courts for his involvement in the incident.
- On January 31, 2017, at approximately 5:12 a.m., the Madison County Sheriff's Office and Emergency Medical Services (EMS) responded to 406 N. Main Street, New Douglas, Illinois, in reference to an unresponsive infant. Emergency Medical Personnel arrived on scene within minutes and began providing emergency care. The infant was rushed to Staunton Memorial Hospital, but could not be saved. The infant was identified as Timothy and Amy Elkins' two month old son Matthew Elkins. The investigation revealed that the extreme living conditions and environment that Matthew was living in contributed to his death. The home itself was in deplorable condition. Eight other children living in the home were taken into protective custody. Matthew's parents, Timothy W. Elkins, age 35, and Amy M. Elkins, age 36, were subsequently charged with Involuntary Manslaughter, one felony count of Child Endangerment and nine Misdemeanor Counts of Child Endangerment, with bond being set at \$125,000.00 on each.
- On February 25, 2017, at approximately 11:39 p.m., the Madison County Sheriff's Office responded to the Airliner Bar and Grill, 573 E. Airline Drive, East Alton, Illinois, in reference to a reported robbery. Deputies met with the 54 year old victim who told them that a subject he just met physically attacked and robbed him of \$2000.00 in cash. The victim didn't know the suspect's name, nor did anyone at the business. The suspect fled the scene in a red in color Ford truck. Investigators were subsequently able to identify the suspect as William C. Bartlett Jr, age 33, of Wood River, Illinois. Bartlett was charged with one felony count of Robbery and is awaiting trial.
- On March 16, 2017, at approximately 5:15 a.m., Glen Carbon Police, Fire and EMS responded to a fully engulfed house fire at 15 Dogwood Lane. Firefighters successfully extinguished the fire and located a deceased male inside the home. The decedent was identified as Justin L. Campbell, who was a known occupant of the residence. An autopsy and investigation would later reveal that Campbell died of a gunshot wound to the head.

At approximately 5:31 a.m. the Madison County Sheriff's Office responded to a call of a vehicle having been driven into Silver Lake, off of Illinois Route 143, Highland, Illinois. A paramedic with Highland EMS, who was first to arrive at the scene, entered the lake and located an unresponsive infant child inside the vehicle. The paramedic administered cardiopulmonary resuscitation (CPR), on the roof of the partially submerged vehicle. The infant was revived at the scene, and ultimately transported to a St. Louis area hospital. A deceased white female was subsequently located in the lake, near the location where the submerged vehicle was recovered. The female was identified as Cristy L. Campbell, Age 32, of 15 Dogwood Lane. An autopsy revealed that Cristy died of "probable drowning complicated with hypothermia".

Investigators with the Madison County Sheriff's Office, Madison County Coroner's Office, and Glen Carbon Police Department initiated a collaborative investigation, which ultimately revealed Mr. Campbell died of a gunshot wound at the hands of Cristy L. Campbell.

- On April 15, 2017, at approximately 11:43 p.m. the Madison County Sheriff's Office responded to Doc Holidays Saloon, located at 308 W. MacArthur Drive, Cottage Hills, Illinois, in reference to a report of a subject armed with a knife. Deputies determined the subject had approached a patron while brandishing a knife, and told him to give him his money. The suspect attempted to grab money out of the patron's hands, but was unsuccessful. The suspect then began slashing the knife around, while saying he was going to get his money. The suspect ultimately stabbed a juke box and exited the business. As deputies were arriving, the suspect was fleeing the parking lot in a pickup truck. A deputy was able to get the suspect vehicle stopped. Once stopped, the suspect threw a knife out of the vehicle and was taken into custody. The suspect was identified as Jeremy Crawford, Age 38, of East Alton, Illinois. Crawford was subsequently charged with Attempted Armed Robbery.
- On July 24, 2017, at approximately 7:50 p.m., the Madison County Sheriff's Office, along with emergency medical services responded to a call of an unresponsive child at 136 Troeckler Lane, Granite City, Illinois. The 17 month old child was identified as Billie J. Cottle's biological son. The child was unresponsive and rushed by ambulance to a regional hospital where he was treated for a narcotic overdose. Cottle was wanted for Unlawful Possession of a Controlled Substance at the time of the call, and was arrested. The investigation resulted in the seizure of suspect drug paraphernalia, and revealed the child was under the care and control of Cottle at the time of the event. Toxicological examination revealed the child had Methamphetamine and Fentanyl in his system. The child was treated and ultimately released. Cottle was charged with felony offenses of Aggravated Battery to a Child, Aggravated Battery, Reckless Conduct and a misdemeanor charge of Endangering the Life or Health of a Child, in connection with the incident. She remains in the custody of the Madison County Jail in lieu of \$250,000.00 bond.
- On August 13, 2017, at approximately 8:48 p.m., a Godfrey woman was confronted inside of her garage by two armed suspects. The two black male suspects were armed with handguns and threatened to shoot the victim. The victim complied with the suspects and fortunately wasn't physically harmed. The suspects stole the victim's silver in color 2013 Nissan Altima. The Sheriff's Office responded to the scene and initiated an investigation. Investigators developed evidence in the case and obtained felony charges of Aggravated Vehicle Hijacking, and Offenses Related to Motor Vehicles, against 18 year old Toreyan Moore, of Florissant, Missouri. Three additional juvenile suspects who were involved in the offense have been petitioned through the juvenile courts.
- On September 3, 2017, at approximately 7:30 p.m., the Madison County Sheriff's Office, along with the Glen Carbon, and Maryville City Police Departments responded to 110 Hillcrest Drive, in rural Glen Carbon, Illinois, for a 911 call of shots fired. The responding officers located an unresponsive 43 year old white male victim, who had been shot multiple times, laying on the ground in the back yard. The victim was identified as Steven W. Flack, of Belleville, Illinois. Flack was transported to an area hospital for emergency medical treatment, but subsequently died as a result of being shot. An occupant of the home identified as Steven J. McGauley was arrested in connection with the shooting and subsequently charged with First Degree Murder. McGauley remains in the custody of the Madison County Jail.

MADISON COUNTY JAIL 2017 INSPECTION REPORT

Criminal Justice Specialist Dianne Fritschle inspected the Madison County Jail on December 5, 2017. Entrance and exit interviews were conducted with Captain Eales and Captain Young.

IMPROVEMENTS SINCE LAST INSPECTION

1. More surveillance cameras are slated to be installed throughout the jail.
2. Video kiosks have been installed in housing units which allow for video visitation.
3. Video kiosks will soon allow detainees to order commissary items electronically. Commissary list has also been expanded.
4. A pressure washer has been purchased to disinfect housing areas.
5. The classification system is being revamped to be more comprehensive.
6. A new live scan is slated to be purchased for the female intake area.
7. A computer based law library will be available to detainees in January 2018.
