b. Renewal of Radio System Services Agreement with Motorola Solutions

Gary Johnson, Central Dispatch Manager, was present to explain the following: Central Dispatch is requesting the County Board to authorize a three-year renewal of our Services Agreement with Motorola Solutions. This agreement provides us with a single source for maintenance of our complete radio system, which includes our dispatch consoles, portable/mobile radios, VHF system, radio logger, and our back-up equipment at Marquette PD. The agreement provides us with 24/7 help desk, on-site repairs, advanced replacement, and software upgrades for the system. Motorola sub-contracts with our local service provider, El-Com Systems for on-site repair of our system. This agreement also provides advanced replacement which, this means that we have critical spare parts at Dispatch. If we have an equipment failure and any of the critical spares are used, these parts are replaced at no additional cost to us. Further, when upgrades are made to the State Radio System, both hardware and software, this services agreement covers those at no additional cost to the County. Motorola is the only service provider that can offer us this complete service agreement, any other service provider would have to contract with Motorola, or we would have to have two separate contracts to provide this same level of service.

Board action: Comm. DePetro moved to approve the Services Agreement with Motorola Solutions for (3) three years from March 1st 2021 until February 28, 2024. The annual cost in the first year is \$41,363.49 this is a \$7,000 decrease from 2020 due to equipment changes. Year two of the agreement is \$42,604.39 and year three is \$43,882.52, each year is an increase of 3% with the exception of paying a one-time administrative fee equal to 5% of the subsequent year's annual contract rate. Second by Comm. Adamini. A roll call vote was taken: Ayes: Comm. DePetro, Comm. Derocha, Comm. Adamini, Comm. Nordeen, Comm. Alholm & Chairperson Corkin. Motion adopted (6-0)

c. Reciprocal Law Enforcement Mutual Aid Agreement

Greg Zyburt, Sheriff, was present via zoom to explain the following:

MARQUETTE COUNTY RECIPROCAL LAW ENFORCEMENT MUTUAL AID AGREEMENT April 8, 2021

For the general purpose of reciprocal aid in law enforcement protection, authorized by Public Act 236 of 1967 (MCLA 123.811), the undersigned Marquette County Law Enforcement Agencies and governmental entities ("Parties") hereby agree as follows:

1. <u>DEFINITIONS</u>

- A. "Commanding Officer" means the highest-ranking officer of a police department or the highest-ranking officer of Central Dispatch on duty at the time of the emergency.
- B. "Emergency" shall mean a combination of circumstances requiring assignment of officers from another department or jurisdiction to handle a request for back-up by officers within their jurisdiction or a situation where officers are not available to handle a call within their jurisdiction and so Central Dispatch sends officers from another department or jurisdiction to respond.
- C. "Requesting Department" shall mean a department that requests back up at the scene of an emergency.
- D. "Responding Department" shall mean a department that provides back up or aid pursuant to this agreement.
- E. "Central Dispatch" shall mean Marquette County Central Dispatch currently located at Michigan Department of State Police, Negaunee Post #81, established pursuant to Public Act 236 of 1967, Section 4 (MCLA 1243.814; MSA 5.3323 (4).
- **2. <u>DETERMINATION AND DECLARATION OF EMERGENCY:</u>** The Requesting Department or Central Dispatch shall be responsible for determining and declaring that an emergency exists.
- **3. REQUEST FOR ASSISTANCE:** Upon determining and declaring that an emergency exists, the Requesting or Central Dispatch shall make a request for assistance to the Responding Departments(s).
- 4. RESPONSE TO REQUEST: The Commanding Officer of the Responding Department(s) shall supply available personnel and equipment to provide

back-up or meet the needs of the emergency. The Commanding Officer of the Responding Department(s) may decline the request for aid if personnel or equipment are not available at the time of the request. Under no circumstance shall this Agreement impose any duty or liability on any Party for failure to respond to the request for assistance.

5. DIRECTION AT SCENE OF EMERGENCY:

- a. The Commanding Officer of the Requesting Department shall be the person in charge of operations at the scene of an emergency. All personnel and equipment of Responding Departments shall be under the control and direction of the Commanding Officer of the Requesting Department upon arriving at the scene of the emergency.
- b. In situations where Central Dispatch has declared an emergency and no officers from the jurisdiction where the emergency exists are on scene when officers from the Responding Department arrive, command shall go to the first department to arrive on the scene.
- 6. WITHDRAWL OF PERSONNEL AND EQUIPMENT: The personnel and equipment of a Responding Department may be withdrawn at any time at the discretion of the Commanding Officer of a Responding Department. The Responding Department shall not have any obligation to keep its personnel or equipment in the community of the Requesting Department for any longer than is deemed necessary by the Commanding Officer of the Responding Department. A Responding Department shall not be liable to a Requesting Department for leaving the scene of an emergency in order to answer a call for service in the Responding Department's community.
- 7. <u>LIABILITY:</u> To the extent permitted by law and without waiving governmental immunity, each Party to this Agreement will be responsible for any and all claims, demands, suits, actions, damages, and causes of action related to or arising out of or in any way connected with its own actions and the actions of its personnel in providing mutual aid assistance or when participating in joint training exercises pursuant to the terms and conditions of this Agreement.
- **8. INSURANCE:** Each Party to this Agreement shall obtain and maintain the following types and levels of insurance for the duration of this Agreement.
 - a. General Liability \$1,000,000 combined single limit per occurrence for bodily injury, personal injury, and property damage.
 - b. Public Official Liability & Law Enforcement Liability \$1,000,000 combined single limit.
 - c. Worker's Compensation Coverage statutory levels of workers' compensation coverage for its own employees.
 - d. Automobile Liability Coverage "any auto" with \$500,000 combined single limit per accident for bodily injury and property damage.
- 9. <u>WAIVER OF COMPENSATION:</u> The Requesting and Responding Departments waive all claims for compensation from each other including wages, benefits, and charges for supplies or equipment used or expended while rendering services under this Agreement.
- **10.** <u>TERMINATION:</u> Any Party to this Agreement may terminate its participation in this Agreement by providing thirty (30) days prior written notice to the Marquette County Administrator, 234 West Baraga Avenue, Marquette, MI 49855 and [insert title], Michigan State Police, Negaunee Post #81, [inserted address].
- 11. <u>EFFECTIVE DATE:</u> This Agreement shall become effective April 8, 2021 and remain in full force and effect until April 30, 2031, unless sooner terminated under Section 9.

Board action: Comm. Alholm moved to enter into the Marquette County Reciprocal Law Enforcement Mutual Aid Agreement. Second by Comm. DePetro. A roll call vote was taken: Ayes: Comm. Alholm, Comm. DePetro, Comm. Derocha, Comm. Adamini, Comm. Nordeen & Chairperson Corkin. Motion adopted (6-0)

d. Adler Lease Extension Recommendation

Duane DuRay, Director of Operations at Sawyer, was present to explain the following: staff is recommending that the Marquette County Board of Commissioners approve a five (5) year lease extension between Adler Lumber Inc. and Marquette County for buildings 418, 431, 2537, 2538 and the real estate upon which they are situated, described and depicted as Parcel L-14. Adler Lumber is a dimensional lumber manufacturer and has been operating on-site since 2007 and remains in good standing with Marquette County.

Adler Lumber recently extended their lease for one year due to the uncertainty of COVID and that is set to expire on September 30, 2021. They now are requesting a five-year lease extension for all properties.

Key lease provisions:

Term: The lease extension will commence on October 1, 2021 and expire on September 30, 2026.

Termination Option: In the event either party wishes to terminate this lease agreement, a written notice of the termination to said party shall be

provided not less than thirty (30) days of the lease termination.

Rental Rate: The rental rate shall be:

> Buildings 431, 2536, 2537, 2538 (current rate is \$2.63 sf)

o Equal to \$2.67 sf for years one and two;

o Equal to \$2.71 sf for years three and four;

o Equal to \$2.76 sf for year five.

These rates reflect a 1.5 % escalator in years one, three and five.

➤ Building 418 shall remain at \$2.00 sf for the extent of the agreement.

Over the course of the five-year lease agreement, total revenue shall be \$205,124.56

Tenant Responsibilities: Tenant shall be responsible for utilities, lawn care, snow removal, trash pick-up, janitorial, real estate taxes and any other

costs associated with their day-to-day occupancy of the property.

Security Deposit: There shall be no security deposit, except for what may already be held from the existing lease.

Improvements: The Premises is being leased as-is, where-is.

All of the remaining terms and conditions remain in place with the lease dated October 1, 2020.

<u>Board action:</u> Comm. Nordeen moves to approve the five (5) year lease extension and authorize the County Board Chair to sign the agreement. Second by Comm. Comm. Alholm. A roll call vote was taken: Ayes: Comm. Nordeen, Comm. Alholm, Comm. DePetro, Comm. Derocha, Comm. Adamini & Chairperson Corkin. Motion adopted (6-0)

e. Fencing Bid Recommendation

Duane DuRay, Director of Operations at Sawyer, was present to explain the following: Staff is recommending that the Marquette County Board of Commissioners consider awarding a K.I. Sawyer Water Department fencing construction project. The K.I. Sawyer Water Department manages three water storage tanks with one being a 500,000 gallon ground level water storage tank. The ground storage facility is located on the industrial side of Sawyer near the airport and currently has no fencing or barriers that would restrict the general public from gaining access onto the site. This project has been on the capital improvement project list for a while and with recent water facility incursions across this country, staff feels this is a safety concern and warrants immediate attention.

Staff created a request for proposals (RFP) and advertised it through several media points including the Marquette County and the Sawyer Water Department web site, the builders exchange and direct contact to vendors. The RFP scope of work is to erect a six-foot-high fence with barbwire encompassing the water tank site. Also within the RFP an additional alternate bid item was added to provide extra fencing and a vehicle gate at the elevated water tank on the industrial side of Sawyer; this additional item can be considered with the primary bid if the cost is acceptable.

The bid opening was completed on Friday, April 9, 2021 and a total of two proposals were submitted. A third vendor out of Escanaba declined to bid indicating the elevated cost for material and lead time for the material would render his bid as a non-competitive bid.

The cost for this project will be funded through the K.I. Sawyer Water Department Capital Improvement fund.

Board action: Comm. Alholm moved to award the bid to the Marquette Fencing Company, Inc. bid not to exceed \$23,900 to include the alternate and authorize Chairperson Corkin to sign the agreement. Second by Comm. Derocha. A roll call vote was taken: Ayes: Comm. Alholm, Comm. DePetro, Comm. Derocha, Comm. Adamini, Comm. Nordeen & Chairperson Corkin. Motion adopted (6-0)

f. TriMedia RFQ/Building Development Specifications

Duane DuRay, Director of Operations at Sawyer, was present to explain the following: Staff recommends the Marquette County Board of Commissioners award a professional consulting services agreement to TriMedia Environmental Services of Marquette for the Sawyer Airport Building(s) Demolition project. Staff developed a request for qualification (RFQ), referencing the completion of an environmental assessment and the preparation of demolition specification and bidding documents for 12 identified structures at the Sawyer Airport complex. The buildings selected are deteriorated beyond repair and have become a liability for Marquette County. The completion of this project will result in the removal of some or all of the structures. Removal of any of these properties will greatly enhance the overall appearance of Sawyer, allowing staff to market for new development on the cleared sites.

As mentioned above, the scope of work covers an environmental assessment, the preparation of demolition documents, engineering for one building that will be partially torn down, bidding documentation and proposal evaluations, and a complete review of possible state historic preservation designation through the State Historic Preservation Office (SHPO). Four consulting firms provided qualification and experience documents for review. These firms are Trimedia Consultants (Marquette, MI), UPEA (Houghton, MI), AECOM (Southfield, MI), GEI Consultants (Marquette, MI).

For this project to be eligible under the Cares Act the Federal Aviation Administration (FAA) regulations require the consultant to be selected under a qualification process and the cost to be negotiated following the selection. As per the FAA regulations, Marquette County is required to perform an Independent Fee Estimate (IFE). The IFE is a way to assist in determining the reasonableness or unreasonableness of the bid.

Staff reviewed all of the qualifications and all firms appeared capable of completing the services. After a thorough evaluation TRIMEDIA was selected as the best suited firm for this project. TRIMEDIA provided a detailed scope and cost for the project with a fee of \$45,000.

Staff completed the required IFE process and prepared the appropriate papers for review by the Michigan Department of Transportation / Aeronautics and FAA.

This project is eligible under the Cares Act. Cost will be pre-funded until the monies are reimbursed through our Cares Act grant.

Board action: Comm. Adamini moved to award the contract to TRIMEDIA consulting services with a cost not to exceed the amount of \$45,000 and to authorize Chairperson Corkin to sign the Agreement. Second by Comm. DePetro. A roll call vote was taken: Ayes: Comm. DePetro, Comm. Derocha, Comm. Adamini, Comm. Nordeen Comm. Alholm & Chairperson Corkin. Motion adopted (6-0)

g. Duties of Mine Inspector

Wendy, Civil Counsel, was present to explain duties of Mine Inspectors Duties. Had been asked by board to examine existing Copper and Iron Mine Statute. Examine Mine Inspectors Act 163 of 1911 to determine exactly what the Mine Inspectors duties were as we had a new mine inspector and there were questions regarding what his duties were. Had drafted a memorandum for the Board Mine and subsequently had a meeting with the Mine Inspector to clarify the duties. Had put together a short form for the Mine Inspector to assist him going forward and help him in his role. Inspector physically review an area before making a determination if an area needs to be fenced.
