ITEM III LETTERS OF CORRESPONDENCE

Commissioner Poling read the letter of Commendation from Lt. Berzac.

I would like to make you aware of incident #21ME21254 in which officers arrested two suspects after a pursuit involving a stolen vehicle. On 10/12/21 at 5:59pm, Sgt. Lance Schmidt #294, located a stolen Chevrolet Tahoe at the Luke gas station and attempted a traffic stop at 73rd Ave and Taft St. The Tahoe kept going and fled south on Taney Pl at a high rate of speed, disregarding the stop signs at 75th & 78th Ave. The driver of the Tahoe attempted to take the curve at 79th and Taney Pl, where the vehicle slid sideways and sideswiped the UPS truck that was traveling in the north bound lanes. The Tahoe spun completely around and crashed into mailboxes at 7918/7919 Taney Pl, coming to a stop. At this point, both the driver and passenger fled out to the vehicle into the yard of 7918 Taney Pl. Sgt. Schmidt immediately deployed K9 Goose and gave him the command to apprehend the suspects. K9 Goose apprehended the passenger in the back yard of 7918 Taney Pl. The drive fled past the same backyard and back up officers arrived to search the area. Officers Fultz #389, Bradley #412, and DeCero #410 arrived and placed the suspect into handcuffs. Cpl. Minchuk #279 and Officer Hensley #415 also arrived in the area to assist. Crown Point K9 Officer Wilkins and K9 Jack arrived and began a track with Officer DeCero #410 in an effort to find the suspect driver.

Lt. Rice #112 advised that a witness inside McDonalds at US 30 & Taney Pl said they saw a male white suspect run into the restaurant and then immediately exit again after asking to use a phone. A short time later Det Cpl. Buck #314 was in the area of US 30 and Whitcomb St. close to where the K9 track ended near a car dealership. Det. Buck observed a male fitting the suspect description across the grass median heading to the Speedway gas station at US 30 & Whitcomb St. The male attempted to enter a vehicle that pulled up and Det. Buck and other assisting officers detained the male. The suspect was charged with Level 6 Theft, Level 6 Resisting Law Enforcement and Misdemeanor Resisting. The other suspect was charged with Misdemeanor Resisting Law Enforcement.

Stg. Schmidt's Patrol techniques, perseverance, and communication, along with Cpl. Buck's observations, and diligence led to the arrest of two suspects with extensive criminal histories. I believe that they should be recognized for their efforts and I am recommending that they be awarded a Level II Commendation. In addition, the great teamwork of Lt. Rice, Cpl. Minchuk, Ofc. Fultz, Ofc. DeCero, Ofc Bradley, Ofc. Hensley K9 Goose, and Crown Point Wilkins & K9 Jack assure the public that our officers are always ready, willing, and able to protect and serve.
