ELECTIONS, PUBLIC RELATIONS, & TOWN BEAUTIFICATION-PETTIT- No Report

*ENVIRONMENTAL AFFAIRS- WHITE* –Councilman White informed the council according to the Lake County Dashboard on March 08, 2022 there were 18 cases of COVID-19 and 3 deaths. Councilman White stated Lake County is at a rate of less than 5% where prior to Lake County was at a 29% rate.

PERSONNEL POLICY & EMPLOYEE BENEFITS - HARDAWAY - No Report

**PUBLIC SAFETY- MINCHUK-** Councilman Minchuk informed the council the Public Safety committee did not meet for the month of March. The Public Safety committee will resume meetings in April.

# ECONOMIC DEVELOPMENT-PETTIT - No Report

**PARKS & RECREATION- UZELAC-** Councilwoman Uzelac informed the council all parks within the town are up to par thanks to the help of Parks Director Price. Councilwoman Uzelac stated the anticipation of spring and encouraged all residents to allow their children to use local parks nearest them.

ABANDONED -BLIGHTED PROPERTIES-HARDAWAY – Vice President Hardaway informed the council The Town of Merrillville has 56 tax sale properties out of 9,200 in Lake County. The 56 tax sale properties are on 59th and Washington St. Students of Indiana University Northwest along with Vice President Hardaway are monitoring the tax sale properties.

**DEAN& BARBARA WHITE COMMUNITY CENTER-MINCHUK & PETTIT** – Councilman Pettit informed the council he would like to call a meeting with Public Works & Engineering Director King, Councilman Minchuk, and Parks Director Price to discuss bid documents and concerns for the Horizon Bank Bridge.

Parks Director Price informed the council that the month of March celebrates the one year anniversary of the Dean & Barbara White Community Center. Director Price invites the council to attend a "Sip and Paint" held at the community center March 25, 2022, more information for the "Sip and Paint" will be sent to the council via email. Director Price reported a successful MMA match held at the community center. Director Price informed the council of the anticipation of a clinic as well as an All-Star Game where the Harlem Legends will face the Town of Merrillville All-Stars June 25-26, 2022. Director Price announced various spring break activities held at the Dean & Barbara White Community Center the week of March 28, 2022.

Special Projects (F & B Tax, Diversity) – HARDAWAY – Vice President Hardaway informed the council the Special Projects Committee is working on the 4th of July Parade. The committee anticipates a series of fireworks for the 4th of July will be displayed July 3, 2022. Vice President Hardaway informed the council a revised contract from Miller Fireworks was sent to the council via email. Vice President Hardaway informed the council that the 4th of July parade will begin at 11:00 A.M. The parade will start at the north end of Merrillville and will continue south of Merrillville. Applications to be a part of the parade can be found in the office of the Town Manager. Vice President Hardaway informed the council a Juneteenth celebration will be held at the Dean & Barbara White Center June 18, 2022 from 12:00 P.M.-5:00 P.M. There will be live music, a bounce house for children, and various vendors whom will be able to display their

products. Lastly Vice President Hardaway informed the council Principal Bonin of Merrillville Intermediate School approached him about a potential Municipal Day. During the May 10, 2022 town council meeting various students of Merrillville Intermediate School will be allowed to sit in for each council member. Vice President Hardaway will meet with Principal Bottom March 9, 2022 at 9:00am to discuss further details.

LAKE COUNTY SOLID WASTE MANAGEMENT-WHITE- Councilman White informed the council the Lake County Solid Waste Management committee will meet March 17, 2022.
