REPORT OF OFFICERS on recent events and announcements to the Public:

Attorney Steckbauer offered his interpretation of Muni Code 1.05(10)(a). He stated in practice, City staff was allowing two chickens for household regardless of zoning. Steckbauer stated he felt this was an improper reading of the ordinance. Steckbauer's interpretation is that chickens are allowed in any *agricultural* district only. A discussion regarding chickens will take place in Planning Commission.

City Administrator Chad Hoerth stated he attended groundbreaking for an expansion at Titan Industries. Hoerth highlighted the Comp Plan survey to collect public information.

General Manager of New London Utilities Jason Bessette said Electric crews responded to a transformer pushed off the pad at Northpoint Drive. Crews found one of Pearl St. bridge lights broken off and in the river. He said a breaker operated at the North Well Mini Sub on 6/26/22. The operation was a 3,000-amp fault, and Kwik Trip North was impacted minimally. Bessette said water crews discovered a pumping increase on our system on 6/23/22. After investigating they discovered a large leak. Crews found the cause on Hwy S on 16" main. Utilities estimates 6,000,000 water lost due to the leak over 5 days. PFAS testing of the city wells complete except Well 2, and they are awaiting DNR results. Cory Woller began on July 18. Bessette recognized Josh Fassbender for 1 year of service.

Police Chief Schlueter invited residents to National Night Out on August 2 from 4:30-6:30pm.

Director of Public Works Robert Garske stated the 300 block of North Water was closed for a contractor repair on collapsed sanitary lateral for a business. He stated Avon, Lyons and Lima streets repair project moving along and curb and Gutter to start soon. Garske said on Thursday, July 21 they will be closing Spur Rd at Shawano St/Hwy 45 for culvert replacement. Will be closed 1 day.

Director of Parks & Recreation Ginger Arndt invited residents to National Night Out on August 2. **She said they will be o**ffering babysitting course in August and a trip to Timber Rattler stadium. Residents can call to register for either. Arndt stated the Aquatic Water Carnival will be held on 7/20 and there is a \$2 entry fee with concessions available. She said the Aquatic & Fitness Center is looking for a day shift life guard during school year during the hours of 5:30AM-1:30PM. Interested parties should call Jim Thorpe at the Aquatic & Fitness Center
