  - Discussed Workers Comp Benefit for the Fire Department

  - Chief Roloff reported that he got an estimate for a new truck from Marion Body Works. \$396,000
  - Chief Roloff reported that they are having some electrical problems with 954. Ebbens is going to be taking a look at it.

- Report of the Police Department by Chief Schlueter
- Motion to approve bills for March in the amount of \$30,066.80 : Cooley, 2<sup>nd</sup> Schmude ; Carried.
  - Budget as of March 31<sup>st</sup>, 2014 was reviewed. Currently 23.61%.
  - Crime and activity report reviewed.
    - Incident count for March 2014 was 541.
    - Due to changes in the P1 system, Chief Schlueter reported that the monthly counts might be suspended for a while.
  - Current staffing and training update.
    - Chief Schlueter gave an update to the PFC on Officer Johnson.
    - Chief Schlueter gave an update on Mulroy's background. Mulroy will be starting around the 1<sup>st</sup> of May.
