- Report of the Fire Department by Chief mark Wilfuer
 - Motion to approve the bills as presented for November in the amount of:
\$4,488.30 : Grumann 2nd Lee ; Carried 5-0
 - Budget as of November 30th reviewed. Currently 79.98%
 - Discuss Fire Department Equipment/Technology
 - Chief Wilfuer reported that starting in January they will be doing training on the new software for recording fire calls
 - Fire runs and service calls reviewed
 - Discuss extending the coverage for Maple Creek: Chief Wilfuer presented a map to the PFC showing where Maple Creek would be interested in being covered by the New London Fire Department. At this time the PFC and Chief Wilfuer did not feel that it is in the best interest of NLFD to extend the coverage. The PFC felt that it may hurt Bear Creek Fire Department whom NLFD relies on for mutual aid. The PFC also felt that this is a bigger issue than just NLFD taking on Maple Creek and that if this discussion continued in the future that it should include other townships that we currently have agreements with and fire departments that we use for mutual aid.
