➤ Report of the Police Department by Chief Schlueter

- Motion to approve bills for May in the amount of \$68,158.29 and \$4,201.14: Schmude 2nd Lee; Carried. 4-0
- Chief Schlueter reported that 50% of the \$4201.14 will be reimbursed for the bullet proof vest through a federal grant.
- Budget as of July 31st was reviewed. Currently 56.28%.
Chief Schlueter reported that the budget appears to be on track for the year.
For the Month of July the PD received state grants for overtime spent on OWI enforcement and drug investigations in the amount of \$511.86 and \$549.04
- Move to closed session per WI SS 19.85(1)c to consider promotion, compensation or evaluation of any employee under the commission's jurisdiction. Motion by Cooley, 2nd Lee to move to closed session.

- Chief Schlueter spoke to the PFC about the 2020 budget and capital budget. Chief Schlueter reported that there will be an extra increase this year due to adding 2 additional health insurance policies, increase in cost of health insurance, and an increase in police retirement. The PFC looked over the presented budget. Chief Schlueter will bring it back to the PFC in September for final approval.
- Crime and activity report reviewed.
 - Incident count for July was 502 calls for service
- Current staffing and training update.

Chief Schlueter, Captain Gregory and Sgt. Sarazin attended the WI Chief's Conference in Green Bay the 1st week of August.
Last week at Lincoln school we had a county wide training for law enforcement on active shooters.
In the beginning of September the PD will have firearms qualification and fitness testing.
- Update on current activities/investigations
Chief Schlueter reported that John Brush has been filing some motions. They were in court today again and will have closing statements in the near future.
- Discuss/Approve the SRO MOU
Chief Schlueter has been working with CVMIC, Attorney Luaders and the School District to get an MOU signed for the School Resource Officers. After the School Board struck a paragraph on "Indemnification, Chief Schlueter contacted CVMIC and Attorney Luaders. Based on the recommendation of Attorney Luaders, the paragraph was struck. The PFC voted 4-0 to sign the MOU and keep positive working relations with the School District.
- Update on current projects
