

2019 NORTHFIELD TOWNSHIP SECOND AGREEMENT

THIS AGREEMENT, made and entered into this ____ day of _____, 2019, by and between the Township Board of Northfield Township, Washtenaw County, parties of the first part and the Board of Washtenaw County Road Commissioners, parties of the second part.

WHEREAS, the parties of the first part desire that certain improvements be made upon the local roads in the Township of Northfield, and

WHEREAS, proper authority is provided to the parties of the agreement under the provisions in Act 51 of Public Acts of 1951 as amended,

IT IS NOW THEREFORE AGREED, the parties of the second part will accomplish the improvements as specified herein, all in accordance with the standards of the parties of the second part.

- 1. Six Mile Road, Dixboro Road to Autumn Drive:**
Work to include heavy brushing, forestry operations, roadside berm removal, ditching, culvert replacements, reshaping the existing surface, the placement of 6" (C.I.P.) of 23a limestone (approximately 1,800 tons) with associated dust control and project restoration.
Estimated project cost **\$ 83,900.00**
- 2. Six Mile Road, between 780 Six Mile Road and 450 feet easterly:**
Work to include canopy trimming, reshaping the existing surface, the placement of 6" (C.I.P.) of 23a limestone (approximately 300 tons) with associated dust control and project restoration.
Estimated project cost **\$ 11,600.00**
- 3. Six Mile Road, between Whitmore Lake Golf Links maintenance garage driveway and 2,100 feet easterly:**
Work to include reshaping the existing surface, the placement of 6" (C.I.P.) of 23a limestone (approximately 1,350 tons) with associated dust control and project restoration.
Estimated project cost **\$ 26,000.00**
- 4. Township-Wide Limestone:**
Work to include the application of 1,000 tons of 23a limestone with associated dust control and project restoration on various local roads within the township. Locations to be determined by mutual agreement between the Township Manager and the District Foreman. Estimated compacted-in-place cost of \$19.30 per ton for 23a limestone includes all labor, equipment and material costs.
Estimated project cost **\$ 19,300.00**
