R-40 Zoning District.

R-40 Zoning District.

3. #P20-26 Site Plan Application of Meat King of North Haven LLC, Applicant, North Haven Holdings, LP, Owner, relative to 100 Universal Drive North, (Map 16, Lot 2). Plan Entitled: Ferraro's Market, Target Plaza - 100 Universal Dr. N., North Haven, CT 06473. Prepared by: Edificio Architecture & Design. Dated: September 8, 2020. Scale: 1"=8'. Attorney Timothy Lee with Fasano, Ippolito, Lee & Florentine, LLC, presented the application to permit the addition of an approximately 10'x 20' cooler, a loading dock lift, cooling compressors, a box compactor and other minor site modifications necessary for a change in tenancy of this approximately 6,400 square feet retail space from Payless Shoes to Ferraro's Market.

Plan Entitled: Land Development Plans for Site Plan Approval for Proposed Retail Redevelopment. Prepared by: BL Companies. Dated: September 8, 2020. Scale: 1"=20'. IL-30 Zoning District.

Attorney Dennis Ceneviva with the Ceneviva Law Firm presented the application to permit the construction of a new, approximately 7,000 square feet, single story retail structure to contain O'Reilly Auto Parts. He explained that the existing building that was previously "Boston Market" Restaurant, will be demolished. Attorney Ceneviva stated that the Zoning Board of Appeals approved a side yard setback variance of 10' on 30 July 2020.

Mr. Matthew Bruton with BL Companies, presented the site plan and explained the parking and the storm water management system. He then described the lighting and landscaping plans.
